ACHIEVING MDGs In CHILD, MATERNAL MORTALITY CUT

PPP, digitisation of health sector stressed

Experts stressed the need for public private partnership, digitisation of health sector and ensuring services at the existing health facilities to achieve Millennium Development Goals 4 and 5 that tells of reducing child and maternal mortality in the country.

They also reviewed the key developments in the MDGs in Bangladesh, ways forward and the barriers.

BRAC and Partnership for Maternal, Newborn and Child Health (PMNCH) jointly organised the meeting titled 'Mothers and Babies Speak: Moving Forward with Lessons on Maternal, Neonatal and Child Health' at the BRAC Center in the city.

Bangladesh is supposed to reduce the child mortality rate to 50 per thousand live births by 2015, which were 151 in 1990 to achieve the MDG 4. At the same time the maternal mortality rate (MMR) should be reduced to 143 per 100000 live births, which was 574 in 1990, and achieve 50 percent skilled birth attendants to achieve the MDG5.

"We need to ensure that home deliveries are conducted by skilled birth attendants (SBAs) but the progress in increasing the SBA is very slow that needs to be addressed."

Highlighting the success in reducing maternal mortality rate in Chowgachha upazila of Jessore through public private partnership where the MMR has reached to 42 per one lakh live births, Director General of the Directorate General of Health Services Prof Shah Monir Hossain said, "We had to find out the barriers why even after a decade of the success this model could not be scaled up."

He also talked on community participation by empowering the community and stressed the need for perinatal care programme to reduce the neonatal mor-

"E-health can be a tremendous tool to

Julian Schweitzer, chairperson of PMNCH, adding, "Maternal health is involved with nutrition, income generation, female and community education, so we should ensure these mechanisms."

Health Minister AFM Ruhal Haque as the chief guest highlighted the government's e-health programme that aims at reaching the people more easily and effectively.

"We've connected 482 upazila health complexes with internet. We're also trying to use geographic information system (GIS) to track the pregnant mothers. Pregnant mothers also can call to a particular telephone number for getting experts' suggestions in any case of their physical problems," he said.

Presiding over the session, Founder and Chairperson of BRAC Fazle Hasan Abed highlighted different programmes run by the non-government organisation to reduce maternal and child mortality.

State Minister for Women and Children Affairs Shirin Sharmin Chowdhury, Dr Kaosar Afsana, associate director of BRAC Health Programme, Anir Chowdhury from Prime Minister's Office and Dr Flavia Bustreo also spoke.

Execute laws to curb noise pollution

Environmentalists urge traffic police

Traffic policemen can play an important role in executing laws to curb noise pollution by punishing horn-happy motorists on the streets, said environmentalists at a sit-in programme yesterday, a press release said.

They said involvement of traffic police can make it easier to implement the existing laws, which has proved to be ineffective in controlling noise pollution due to weak enforcement.

Nirapad Development Foundation and WBB Trust jointly staged the sit-in in front of Fine Art Faculty on the Dhaka University campus marking the 15th International Noise Awareness Day 2010.

Speaking as the chief guest, Bapa President Abu Naser Khan said indiscriminate honking is the key reason of noise Hasan, director of Green Mind, also spoke. pollution.

Honking, hooting and others, including brick-grinding machines which are generously used in the residential areas, are

major sources of suffering to people, he added.

Prof Indiscriminate honking must be fined by traffic police and regular mobile courts need to be conducted to get hold of hydraulic horns, he added.

Nirapad Development Foundation Chairman Syed Rana said noise pollution is a dangerous form of pollution but its impacts are not fully realised immediately.

This is a major reason for weak implementation of the laws, he said, adding that mass awareness needs to be created in this connection.

FRIGATE PURCHASE CASE

Judgement on Hasina's petition May 18

The High Court (HC) yesterday fixed May 18 for delivering judgement on a petition by Prime Minister Sheikh Hasina for quashing the proceedings against her in the frigate purchase corruption case filed during the regime of BNP-Jamaat alliance government.

After final hearing on the petition, an HC bench of Justice Md Shamsul Huda and Justice Abu Bakar Siddiquee set the date for verdict.

This court in separate verdicts quashed proceedings of eight corruption cases against the prime minister in March and April.

The now defunct Bureau of Anti-Corruption (Bac) filed the case with Tejgaon Police Station on August 7 in 2002 against Hasina and five others on charge of damaging around Tk 747 crore of the state exchequer in purchasing a frigate

A Dhaka court yesterday sentenced two people to death for killing Awami League (AL) leader Farid Uddin Sarker in the city's Shyampur area in August, 2008.

Judge Mohammad Rezaul Islam of the Speedy Trial Tribunal-4 handed down the sentence in absence of the convicts Mohammad Jasim and Kamal Hossain. The court also acquitted Rajib Hossain, Tofazzal Hossain,

brought against them were not proved. The punishment of the fugitive convicts will be effective from the day of their arrest or surrender, the court said.

Earlier, the prosecution and the defence had completed their arguments and the court recorded statements of 28 prosecution witnesses during trial of the case.

According to the prosecution, a gang of miscreants led by Jasim and Kamal entered the "Toma Hotel Sweet Fast Food & Mini Chinese Restaurant" at Rayerbagh at Shyampur in the city about 8:40am on August 23, 2008 and shot AL leader Farid Uddin Sarker, leaving him seriously injured. Farid who was owner of the hotel, was having his breakfast.

The victim was rushed to Dhaka Medical College and Hospital (DMCH) for treatment where the on-duty doctors declared him dead.

Following the incident, victim's wife Suraiya Khanam filed a murder case against Jasim and Kamal and four others with Shyampur Police Station.
