PROTESTS CONTINUE IN SYLHET

Bring Osmani's killers to book, demand newsmen

Sylhet regional correspondent of the Saptahik-2000, Fateh Osmani was critically armed gang while returning home from workplace on April 18 midnight.

He was rushed to Sylhet MAG Osmani Medical College and Hospital and sent to the capital on the following day. He succumbed to his injuries on April 28 at Apollo Hospital in Dhaka.

Flood damages boro in huge areas of greater Sylhet

Farmers in two Kishoreganj upazilas using unripe crops as fodder

Flash flood has damaged boro crops on around two lakh hectares of land in greater Sylhet region and Kishoreganj district.

About three lakh farmers have been directly affected in Sylhet region as early flooding caused by heavy downpour and rolling of water from the hills across the border in India destroyed paddy on 1.52 lakh hectares of land, said our staff correspondent quoting officials of the Department of Agriculture Extension (DAE).

Water Development Board (WDB) authorities' failure to protect the embankments due to alleged corruption also added to the situation, sources

Agriculture officials said the loss would stand at Tk 1,318 crore while local sources claimed that about 10 lakh tonnes of paddy worth Tk 1700 crore has been lost by the calamity.

Meantime, Sunamganj WDB executive engineer Abdul Hekim has been put under suspension for negligence in saving embankments.

A high level team from the WDB will investigate the irregularities, sources said.

Boro was cultivated on 4.27 lakh hectares of land in Sylhet, Sunamganj, Moulvibazar and Habiganj districts this year but floods badly affected crops on 1.52 lakh hectares, causing loss of 7.75 lakh tonnes of crops worth Tk 1,318 crore, DAE sources said.

The affected farmers somehow managed to harvest a portion of their unripe paddy from the inundated croplands.

In worst affected Sunamganj district, boro crops on 1,03,045 hectares of

land out of a total 1,93,000 hectares has been lost, agriculture officials said. The production loss has been hectares. primarily estimated at 5.27

In Sylhet district, the crop loss has been estimated at 2.08 lakh tonnes of paddy worth Tk 354 crore as 40,700 hectares of boro lands out of the total

crore.

In Moulvibazar, 37,000 tonnes of boro (worth Tk 63.34

land has been damaged while the total boro filed in the district this year is 49,150

In Habiganj, 1.09 lakh lakh tonnes worth Tk 896 hectares were used for boro paddy this year. Of that, 580 hectares had been damaged causing production loss of 2967 tonnes of paddy worth Tk 5.04 crore. A Correspondent reports

With deterioration of flood situation in the haor areas of the district due to onrush of hill water, farmers are getting their unripe paddy cut in exchange of lion's share of the crop to the labourers.

Any visitor in the area will now see hundreds of women and children harvesting unripe paddy to feed their

Frustrated paddy farmers are now worried about paying their debt that they took to meet up the cultivation cost, said farmers Ibrahim of Wara and Haji Abul Kashem of Joishiddi in Itna upazila.

Day labourers are demanding Tk 500-600 a day for harvesting paddy and boat owners take Tk 1000 to 1500 a day to carry 100 to 200 hundred maunds of paddy.

Public representatives and agriculture officials said twothirds of Itna upazila and half of Mithamoin upazila has already gone under water while several embankments have collapsed.

A few hundred people barricaded Rangpur-Bogra highway Sunday night for about an hour demanding arrest and punishment to the culprits who attacked a union Awami League leader. Police said Abdur Rashid, secretary of Taluk-Kanupur union Awami League was returning home from Gobindagnaj town on Saturday night. As he reached Katakhali, a gang of armed criminals attacked him. An FIR was lodged but police did not take steps to arrest the culprits. Demanding their immediate arrest locals barricaded the highway at Balua bazaar. Hundreds of vehicles remained stranded for over an hour on both sides of the road.

Croc kills fisherman

The incident occurred as Sohel was catching fry in the river along with his father and other fishermen. Later, his body was found floating in the river.

Schoolboy electrocuted

A schoolboy of Birganj upazila died yesterday as he came in contact with a live electric wire. The incident occurred when he climbed a roadside tree to catch bird on way to school. The deceased was identified as Belal Hossain, 14, son of Bahez Ali of village Jagdal under Birganj municipality and a class eight student of Kabi Nazrul High School. Witnesses said Belal climbed a roadside eucalyptus tree in front of Abdul Patwari Auto Rice Mill of Birganj-Panchagarh highway for birds. But accidentally he touched the 440 volt live wire which passed through the tree.

2 Bangla Bhai aides held in Naogaon

DEATH OF LIZA DAS IN SYLHET

Husband, his sister held on murder charge

Kotwali police on Sunday night arrested businessman Nilkanta Das and his sister in connection with the murder of

his wife Liza Das. Earlier, father Babon Dhar filed a case with the Kotwali police station accusing Liza's husband and other members

of his family. Dhar hails from Kasba upazila in Brahmanbaria but he stays in Sylhet along with

family.

Police quoted Nilkanta as saying that Liza entered bathroom at about 4:30 pm Sunday but she did not come out even after a long time. There she killed herself. Mentally sick Liza herself had cut her throat using a sharp knife in a bid to commit suicide when she was 7 months' pregnant, Nilkanta claimed.

At about 5:30 pm Nilkanta took his wife to the MAG Osmani Medical College and Hospital where the physicians found her dead. Police and hospital sources

said, the body bore marks of injuries on the throat. Liza was the second wife of Nilkanta, whose first wife also

committed 'suicide' three and a halfyear ago, family sources said. Officer-in-charge (OC) of Kotwali PS Mohammad Ali

said they sent suspects Nilkanta and his sister Shankari Das to the judicial magistrate court yesterday.

"We are waiting for the autopsy report," he added.
