War on Maoists needs fighting poverty first

Says Sonia Gandhi

India's ruling Congress party chief Sonia Gandhi has spoken out in a mounting debate over a deadly Maoist revolt, saying poverty was at the root of the insurgency.

"While we must address acts of terror decisively and forcefully, we have to address the root causes" of the revolt, wrote the widow of assassinated former prime minister Rajiv Gandhi in an open party letter.

The Maoists' growing strength highlights the need for development efforts to reach the "most backward districts," Sonia said in the latest issue of the Congress party journal "Congress Sandesh," which appeared at the week-

Sonia is the president of the Congress and regarded as the power behind the government. Analysts see her intervention as a sign the leadership is uneasy with the government's

our development initiatives to reach the grassroots," said Sonia, who has aggressively championed the left-leaning party's pro-poor programmes.

Maoist influence is greatest in impoverished, remote areas, fuelling the arguments that growing social disparities thrown up by India's blistering economic growth has been a major factor behind the rebels' expansion. Late last year, the Congress-

led coalition government launched a large-scale offensive involving six states worst-hit by Maoist violence.

But the rebels' superior knowledge of local terrain has thwarted efforts to take to take them on in large numbers.

In April, the insurgents massacred 75 policemen in a jungle ambush in central India, the deadliest attack by the Maoists in a single day. The rebels insist they are fighting for the rights of the poor in India's hinterland.

Nepal govt rules out emergency after May 28

As the deadlock over the promulgation of a new constitution continued in Nepal, the government yesterday ruled out the imposition of emergency even after the expiry of the term of the current Constituent Assembly on May 28.

There will be no emergency rule in the country even after the Constituent Assembly's term expires on May 28, said Shanker Pokharel, the Information and Communication Minister and government spokesman.

Even if the political parties fail to reach an understanding to extend the tenure of the 601member Constituent Assembly, the government will not be dissolved and the status quo will be maintained, he said.

He said the government will do everything to avert a constitutional crisis and there is no need to worry about what happens after May 28.

'Terror attack' kills policeman in Hyderabad

One policeman was killed and three others were injured in a suspected terror attack in the southern Indian city of Hyderabad on Friday evening.

Witnesses said two people, riding a motorcycle, opened fire on a police picket at Shahali Banda in the Old City area of Hyderabad, the capital of Andhra Pradesh state.

Police suspect involvement of a terror operative Vikar Ahmed in the incident. The policemen were deployed as part of enhanced security arrangements ahead of the third anniversary of the blast at the

Mecca Masjid on May 18. The assailants fled after the attack.

Constable Ramesh, of the Andhra Pradesh Special Police (APSP), died while being taken to Osmania Hospital while three other policemen were being treated for their injuries.

Last year, on the second anniversary of the blast, a policeman was killed and another injured in a similar attack when assailants opened fire on police at Falaknuma area of the old city.

A resident of Old Malakpet area in the city, Vikar was also associated with a city-based rightwing group Darsgah Jihad-o-Sahadath (DJS).

28 killed in Madhya Pradesh as bus hits voltage wire

At least 28 people, mostly women and children, were killed when a bus carrying marriage ceremony guests hit a high-tension electricity wire in the central Indian state of Madhya Pradesh on Friday.

The accident took place near Surajpur village in Mandla district, around 450 km from the state capital Bhopal.

District police superintendent KK Sharma said a steel wardrobe had been kept on the roof of the bus, which came into contact with high-voltage electricity line, leaving the vehicle completely charred.

He said the people on board the bus were returning after attending a marriage ceremony.

At least 30 militants dead in Afghan, Nato raids

Afghan and coalition forces conducted sweeps across Afghanistan that left at least 30 militants dead, while insurgents in the east killed five security guards in an ambush on a vehicle convoy, officials said yesterday.

Before dawn on Friday, international and Afghan forces carried out an operation in the Sangin district of Helmand province and 10 insurgents were killed, said Daud Ahmadi, a spokesman for the regional governor.

Mullah Mohammed Hassan, a "prominent" Taliban commander who was involved in many insurgent attacks in northern Helmand province, was captured in the Sangin village of Pirqadam Kariz during the raid, Ahmadi said.

No security forces or troops were injured in the operation, he said. Nato did not provide immediate comment.

In southern Zabul province, a bridge on a highway linking the province with neighboring Kandahar, was blown up with explosives,

according to Mohammad Jan Rasoolyar, spokesman for provincial governor of Zabul. Traffic was being diverted around the explosion site in Shahrasafa district. No one was injured.

Violence in southern Afghanistan has been on an upswing in recent weeks, following a broad operation in the town of Marjah in Helmand province and as Nato and Afghan forces ramp up security efforts in neighbouring Kandahar.

Eastern Afghanistan, along the Pakistani border, and parts of northern Afghanistan have also faced numerous attacks in recent weeks.

Also Friday, insurgents led an ambush of a vehicle convoy between the Gelan and Muqur districts of eastern Ghazni province, killing five private security guards working as escorts, the Interior Ministry said in a statement.

Three oil tankers in the convoy burned during the fighting, the ministry said.

For its part, the Defense Ministry said Afghan National Army troops and national police tracked the insurgents who led the ambush and killed six in an ensuing gunbattle.

Former vice-president of India passes away

India's former vice president and senior Bharatiya Janata Party leader Bhairon Singh Shekhawat died yesterday of cardiac arrest, two days after he was admitted to a hospital with lung and chest infection.

87-year-old Shekhawat breathed his last at 11:10am at the Swai Man Singh Hospital in Jaipur, the capital of his home state Rajasthan. He leaves behind his wife Suraj Kanwar and daughter Ratan Kanwar and three grandchildren.

The Congress government in Rajasthan declared a three-day state mourning for Shekhawat who had wide acceptability to parties outside BJP also. A former policeman, he joined politics in 1952 and was the

chief minister of BJP government in Rajasthan thrice from 1977 to 1980, 1990 to 1992, and 1993 to 1998.

Shekhawat shifted to the national scene when he was elected vice president of India in 2002 when BJP was in power in India. He had defeated Congress candidate Sushil Kumar Shinde, now India's power minister, by a margin of 149 votes out of the 750 votes polled.

Born on October 23, 1923, Shekhawat was the 11th vicepresident of India and had served in that position from August 2002. He was elected for a five-year term following he death of Krishan Kant and resigned on July 21, 2007 after losing the presidential election to incumbent President Pratibha Patil.

Iranian cleric wants creation of 'Greater Iran'

A radical cleric called yesterday for the creation of a "Greater Iran" that would rule over the entire Middle East and Central Asia, in an event that he said would herald the coming of Islam's expected messiah.

Ayatollah Mohammad Bagher Kharrazi said the creation of what he calls an Islamic United States is a central aim of the political party he leads called Hezbollah, or Party of God, and that he hoped to make it a reality if they win the next

presidential election. Kharrazi's comments reveal the thinking of a growing number of hard-liners in Iran, many of whom have become more radical during the postelection political crisis and the international standoff over the country's nuclear program. Kharrazi, however, is not highly influential in Iran's clerical hierarchy and his views do not represent those of the current

government. Kharrazi's comments were published yesterday in his newspaper, Hezbollah.

He said he envisioned a Greater Iran that would stretch from Afghanistan to Israel, bringing about the destruction of the Jewish state.
