# River dredging

Bangladesh is criss-crossed by rivers. The total waterways measure 24,000 km. Two of world's large rivers the Ganges-Padma and the Brahmaputra-Jamuna flows through this country. These rivers carry 2.4 billion tonnes of silt annually. The navigable route has been reduced by 2000km in the last 25 years due to siltation. At present the navigable route stands at 3800km only. So the government of Bangladesh decided to dredge rivers to increase navigability of the river at a cost of Tk. 11,472 crore in two phases. In the first phase, 23 rivers will be dredged at a cost of Tk 4201 crore in 3 years and in second phase 53 rivers will be dredged at a cost of Tk. 7271 crore. The project work will be completed in 8 years starting from now. The government expects

89 % assistance from donors. But work will begin now with our own resources.

Dredging involves big investment besides technicalities. Annual maintenance is as important as dredging the channels to make investment useful. So one should consider future provisions for annual maintenance of the channel, Bangladesh Water Development Board with the assistance of Netherlands recently dredged Gorai River, the mouth of which has been silted up. An evaluation will be useful. BIWTA dredge the Daultdia Baghabari route. But in winter ferry service and vessels carrying fuel and other commodities frequently get stuck. These call for additional measures to reduce/stop siltation.

#### Sugar prices

The business page of a local English daily on May 10 had two reports published side by side on the above subject matter. The one by your staff reporter mourned the lack of profitability of sugar manufacturers. They state that the price fixed is too low and that they are losing Tk.20 per kg. which comes to a loss of Tk.20,000 per ton.

The other report from a news agency sates that the government is going to import 25,000 tons of sugar before Ramadan at US\$514.95 per ton. It was not clear, if this price was on FOB or C&F basis. In Bangladesh taka, based at @1\$=Tk.70, it comes to Tk.36,038 (rounded off) per ton, or a maximum of Tk.36.10 per kg. If the above price is on FOB basis, then assuming 15% duty, the landed cost at godown should not exceed Tk.42 per kg, covering duty and internal transport costs.

Given these facts, the government can set an ex-mill price of Tk.39 per kg. Surely, this should eliminate the question of financial loss for the sugar manufacturers. They should however, maintain the same quality as of imported sugar. The usual complaint is poor colour of local sugar, which normally is considered to reflect the poor quality!

Such consideration, for a price review, deserves the government's serious attention in the interest of saving foreign exchange and at the same time assisting the local producers to get a minimum return on investment.

May be government should review the matter, and if found to be justified, increase the exmill price of sugar.

After all, the industry, from farm to the factory, supports many farmers, and other low paid employees, in this rather labour intensive process of

production. Further, sugar is not an essential food item, and increase in its price will not affect the common man's cost of food. The few urban and other better off, can afford to tolerate a few taka increase in sugar price, and this may reduce the consumption of rich food items, and improve our health-- an additional benefit!

Hence it is widely suggested by the physicians to take a lower dose of aspirin with necessary precautions.

#### Mobile plants for desalination

The news published in your daily on April 26, 2010 stating that Japan would provide five water purification mobile desalination plants is no doubt a welcome development. People living in the coastal belts have been suffering from drinking water crisis due to salinity and after any natural disaster this problem is compounded. Only the sufferers can realize it. As I was Upazila Nirbahi Officer of Shyamnagar Upazila under Satkhira district about three years ago, I saw the untold sufferings, especially after two major disasters i.e. 'Sidor' and 'Aila'. After Aila the water bodies of this upazila were submerged by saline water except a few ponds located around the headquarters. People had been screaming for drinking water. Instantaneously we set up a plant for filtering water in our upazila headquarters and supplied it to different corners. The district administration also supplied water transported by lorries. Satkhira Jubo Academy supplied water in the whole of upazila setting up plants in the headquarters. Oxfam, GB Ganoshastya, Assistance Eau Et Environment, a French NGO, established plants for supplying water.

People need drinking water not only for drinking but other purposes also like cooking. But we are able to supply only drinking water. People are compelled to use polluted water for other household
