Crackdown on stalkers

Rajshahi police arrested 10 alleged stalkers from different city points on Tuesday and released nine of them hours later as they sought apology. Zahangir Hossain Matubbor, deputy commissioner of Rajshahi Metropolitan Police told this correspondent that all but one, named Shibul, were released. Shibul was taking photos of girls by his mobile in front of PN Girls' High School, he said. His two mobile phones were seized, he said adding that RMP is conducting anti-stalking campaign following a home ministry directive. RMP's assistant commissioner Mahfuzur Rahman said, detective branch of police caught 10 youths red-handed while conducting raids in different city areas including Malopara Coaching Centre crossing, Sadar Hospital road and PN School areas.

One beaten to death

UNB, Comilla

A suspected thief was beaten to death by a mob at Dakkhin Rampur village in Sadar Dakkhin upazila of the district on Monday night. The identity of the deceased could not be known immediately. Police and locals said a gang of four thieves entered the house of Hafez Abdur Rob at dead of night. As Rob and his wife caught one of the thieves the other thieves stabbed them with sharp weapon leaving Rob injured. Hearing his scream, local people rushed in and beat up the thief who was caught by the couple earlier leaving him dead on the spot. The other thieves managed to flee the scene.

40 houses, 14 shops gutted in 3 districts

Fire gutted at least 40 houses shops and 14 shops in three districts on Tuesday and Monday.

In Bandarban, a devastating fire gutted 40 houses in Jamchhari area of Sadar upazila early Tuesday.

Fire service sources said the fire originated from the kitchen of a house late at night and soon engulfed the adjacent houses, reports UNB.

On information, fire fighting unit from Sadar headquarters rushed to the spot and extinguished the blaze after an hour of hectic efforts with the help of local people.

Fire service sources primarily estimated the losses caused from the fire at about Tk 50 lakh.

Bir Bahadur MP, Chairman spot at 4:15am. of CHT Development Board, Kashailya, Sadar upazila Chairman and DC Mizanur Rahman visited the spot and assured all possible help to the fire victims.

In Gopalganj, a devastating fire that broke out at Rajpat bazaar in Kashiani upazila burnt down eight shops early Monday.

Police and locals said the fire originating from an electric short circuit at a shop at about 3:00am engulfed seven other adjacent shops.

Local people extinguished the blaze after two hours of frantic efforts with the help of police. Police said five people sustained burn injuries while putting out the blaze.

Affected shop owners claimed that commodities worth over Tk 3 lakh were gutted by the fire.

Six shops were gutted at Matlab (south) upazila in Chandpur on Tuesday damaging goods worth around Tk 15 lakh, according to a correspondent.

Fire service official Farid Ahmed quoting locals said the six shops were burnt down before they could reach the

The shops caught fire at around 3:00am.

Ahmed said they, however, managed to save 7-8 other shops worth Tk 15-20 lakh as they were able douse the fire with the help of locals.

The fire might have been originated from an electric short-circuit in a small rice mill, he said.
