Crackdown on stalkers

Rajshahi police arrested 10 alleged stalkers from different city points on Tuesday and released nine of them hours later as they sought apology. Zahangir Hossain Matubbor, deputy commissioner of Rajshahi Metropolitan Police told this correspondent that all but one, named Shibul, were released. Shibul was taking photos of girls by his mobile in front of PN Girls' High School, he said. His two mobile phones were seized, he said adding that RMP is conducting anti-stalking campaign following a home ministry directive. RMP's assistant commissioner Mahfuzur Rahman said, detective branch of police caught 10 youths red-handed while conducting raids in different city areas including Malapara Coaching Centre crossing, Sadar Hospital road and PN School areas.

One beaten to death

UNB, Comilla

A suspected thief was beaten to death by a mob at Dakkhin Rampur village in Sadar Dakkhin upazila of the district on Monday night. The identity of the deceased could not be known immediately. Police and locals said a gang of four thieves entered the house of Hafez Abdur Rob at dead of night. As Rob and his wife caught one of the thieves the other thieves stabbed them with sharp weapon leaving Rob injured. Hearing his scream, local people rushed in and beat up the thief who was caught by the couple earlier leaving him dead on the spot. The other thieves managed to flee the scene.

Murder in Narail

UNB, Narail

A man was murdered by criminals at Purulia village in Kalia upazila on Saturday. The victim was identified as Tota Mia, 48 of the village. Witnesses said, unidentified assailants chopped Tota while he was returning home from a local market at about 8:00 pm, leaving him critically injured. Later he died on the way to hospital.

40 houses, 14 shops gutted in 3 districts

Fire gutted at least 40 houses and 14 shops in three districts on Tuesday and Monday.

In Bandarban, a devastating fire gutted 40 houses in Jamchhari area of Sadar upazila early Tuesday.

Fire service sources said the fire originated from the kitchen of a house late at night and soon engulfed the adjacent houses, reports UNB.

On information, fire fighting unit from Sadar headquarters rushed to the spot and extinguished the blaze after an hour of hectic efforts with the help of local people.

Fire service sources primarily estimated the losses caused from the fire at about Tk 50 lakh.

Bir Bahadur MP, Chairman of CHT Development Board, Kashailya, Sadar upazila Chairman and DC Mizanur Rahman visited the spot and assured all possible help to the fire victims.

In Gopalganj, a devastating fire that broke out at Rajpat bazaar in Kashiani upazila burnt down eight shops early Monday.

Police and locals said the fire originating from an electric short circuit at a shop at about 3:00am engulfed seven other adjacent shops.

Local people extinguished the blaze after two hours of frantic efforts with the help of police. Police said five people sustained burn injuries while putting out the blaze.

Affected shop owners claimed that commodities worth over Tk 3 lakh were gutted by the fire.

Six shops were gutted at Matlab (south) upazila in Chandpur on Tuesday damaging goods worth around Tk 15 lakh, according to a correspondent.

Fire service official Farid Ahmed quoting locals said the six shops were burnt down before they could reach the spot at 4:15am.

The shops caught fire at around 3:00am.

Ahmed said they, however, managed to save 7-8 other shops worth Tk 15-20 lakh as they were able to focus the fire with the help of locals.

The fire might have been originated from an electric short-circuit in a small rice mill, he said.

Man sentenced to death for killing wife

A Panchagarh court yesterday sentenced one person to life term imprisonment for killing his wife.

The court also fined him Tk 10,000, in default, to suffer six more months in jail.

District and Sessions Judge and Judge of the Woman and Children Repression Prevention Special Tribunal Court of Panchagarh Abdus Salek delivered the verdict in a crowded courtroom.

Convicted Shahidur Rahman, 20, is son of late Shahabuddin of Bakshipara

village under Sadar upazila in the district.

According to prosecution, Shahidur locked in an altercation with his wife Pervin Akhter, 18, on September 8, 2009.

At one stage, Shahidur strangled her wife after a good beating. Victim's father Rafiqul Islam of Chaklahat village under Sadar upazila filed a murder case on the same day with Panchagarh police station accusing several people.

After investigation Sub-Inspector (SI) of Panchagarh police station and also Investigation Officer (IO) of the case Din Mohammad submitted charge sheet on October 31 last year.

After examining 15 witnesses and evidence of the case the judge handed down the verdict.

Interns call off strike at Faridpur medical

Interns at Faridpur Medical College and Hospital (FMCH) yesterday withdrew their strike following an assurance given by the hospital authorities to meet their demands.

Dr Guru Das Sikder, superintendent of FMCH, said the interns joined their duties at the hospital at 2:30 pm.

The assurance came from a meeting that held in the office of Superintendent Guru Das Sikder at 10:00am. Dr Khobirul Islam, secretary of Bangladesh Medical Association (BMA) Faridpur unit, ASM Jahangir Chowdhury Titu, vice-principal of Faridpur Medical college, and AL leader Mohtesham Babar were present in the meeting.

Dr Ridoy Ranjan, president of Intern Doctors Association (IDA) Faridpur unit, said they withdrew the strike as authorities assured them of meeting their seven-point demands that include tightening of security at FMCH and punishment to the person who assaulted a female intern at the hospital on Sunday night.

Outlaws held after gunfight

Two underground operatives of Purbo Banglar Communist Party (PBCP-Janajudhho) were arrested after gunfight with police in Chatmohar upazila of the district yesterday.

The incident took place at Kuabashi-Chakmarom village of the upazila at around 3:00pm. The arrestees are Md Moksed Ali, 35, son of Md Mofiz Uddin of Chakmoram-

Kuabashi village, and Md Johir Udin, 32, son of Billal Hossain of Jatbari under Ataikula upazila.

The outlaws received bullet injuries during the gunfight and were admitted to Pabna General Hospital. Police recovered firearms and ammunition from the spot.

Officer-in-charge of Chatmohar Police Station Md Shahid Alam said

police raided the house of Jharu Mondol where PBCP cadres were holding a

secret meeting. Sensing the presence of the policemen, the outlaws opened fire, prompting the law enforcers to retaliate.

Moksed and Jahir Uddin received bullet injuries during the gunfight that continued for half an hour and later arrested by the law enforcers while the rest managed to flee, he said.

Police said both were wanted in several cases filed with Chatmohar Police Station.
