## Only 2,178 applications submitted in 48 days

Most petitioners are Bangalee settlers

The CHT Land Dispute Resolution Commission, formed to resolve land disputes in Rangamati, Bandarban and Khagrachhari hill districts, has received only 2,178 applications in 48 working days till Tuesday.

Most of the petitioners, who submitted applications to settle land disputes, are Bangalee settlers, said sources of the commission office.

The commission issued public notice seeking applications within 60 workings days from March 13 to resolve land disputes in the three districts of Chittagong Hill Tracts (CHT).

When contacted, Acting Chairman of Khagrachhari Hill District Council Kujendra Lal Tripura, also a member of the CHT Affairs Land Commission, said the ethnic people are totally ignoring the

invitation.

"The commission will have to make people, particularly the ethnic groups, aware about the notice. Otherwise, the CHT land disputes will remain unresolved," the chairman said, adding that the commission must fulfill the quorum for its meeting to make its decision

The commission has so far received applications from Dighinala, Bagaichhari, Langudu, Manikchhari, Laxmichhari, Kaptai, Mohalchhari, Matiranga, Lama, Ali Kadom, Naniyarchar, Ramgarh, Panchhari, Rajasthali, Khagrachhari Sadar and Bandarban Sadar upazilas, sources

No application has been submitted from nine other upazilas of the three hill districts.

Shanti Bikash Tripura, an indigenous the number of applications is poor and man from Azodda village in Matiranga upazila of Khagrachhari, went to the

commission office on Tuesday to submit application, alleging that one Mohammad Mizanur Rahman occupied his three acres of land in 1981.

"Most of the ethnic people in my area do not know about the process of application or last date of submission" he said.

Joynal Abedin of Shalbagan in Khagrachhari Sadar upazila said he went to the commission office to settle a land dispute after hearing about the public notice from his neighbours.

Contacted over cell phone, Land Dispute Resolution Commission Secretary Md Abdul Hamid admitted that the number of applications submitted to the commission was very poor.

He, however, said, "The number will increase as the commission has already decided to give additional 60 working days to the petitioners to submit their applications on competition of the first phase of submission."

## Chuknagar 'genocide day' observed

Thirty-ninth Chuknagar 'genocide day' was observed here yesterday.

On this day in 1971, a few thousand men, memorative women and children mostly belonging to minority community were slain by the Pakistan occupation forces. The forces sprayed bullets on them from light machine guns and semi-automatic rifles killing them on the spot within hours.

The victims of the massacre hailed from Khulna, Bagerhat, Satkhira, Jessore and Gopalganj districts. They had assembled at Chuknagar under Dumuria upazila of Khulna district to flee to India through any available border route.

The Principal of Chuknagar College and President of Ganohatya '71 Smriti Rakkha Parishad ABM Shafiqul Islam yesterday told the chief prosecutor of the International War Crimes Tribunal (IWCT) that he had witnessed the massacre committed by Pakistan occupation forces on May 20 in 1971.

"That must be the biggest genocide in world history as Pakistan forces killed thousands in a few minutes on that day".

"Only 1500 people died in the Mai Lai massacre in Vietnam. But during Chuknagar massacre over 10,000 people were killed in the twinkling of an eye", he said.

To observe the day, Ganohatya '71 Smirity Rakkha Parishad organized a com-

meeting yesterday at Chuknagar College ground with principal ABM Shafiqul Islam in the chair.

State minister for Labour and Employment Begum Mannujan Sufian was present at the function as chief guest. Lawmaker Noor Afroze Ali, Dumuria upazila chairman Sheikh Abdul Hadi and UNO Sakhawat Hossain addressed the meeting as special guests.

The state minister said in her speech that government is determined to try war criminals at any cost.

Speakers at the meeting urged the government to declare May 20 as National Mourning Day to show respect to the victims of Chuknagar massacre.

Meanwhile, the members of war crime tribunal visited three major spots of massacre in Khulna yesterday.

The chief prosecutor of the IWCT, Golam Arif Tipu, said his team had recorded statement of 24 eye-witnesses to massacre at Chuknagar and other places in the district.



### Malaria kills 167 in Khagrachhari in last 4 years

#### Roundtable told

Malaria killed at least 167 people and attacked 55984 in eight upazilas of Khagrachhari hill district in the last four years.

It was revealed at a roundtable discussion jointly organised by civil surgeon's office, Khagrachhari press club and non-government 2007. organisation Brac.

Held at the conference hall of Khagrachhari Hill District Council (KHDC) it was chaired by civil surgeon Dr Udoy Shankor Chakma while acting KHDC chairman Kujendra Lal Tripura attended as chief guest.

Speakers said the actual figure of malarial death or attack might be two to three times higher as the figure has been compiled from various sources.

They said, number of death and infection has declined in the recent years as Global Fund for AIDS, Tuberculosis and Malaria (GFATM) in collaboration with the Health Department started awareness campaign from early 2007 in Khagrachhari.

The international organi-

sation is carrying out the programme through various activities to control malaria in the hill district.

Citing example they said only one person was killed and 2738 were affected in the last four months of the current year while 12 killed and 15811 affected in 2009, 55 killed and 19673 affected in 2008 and 99 killed and 17762 affected in

Several organisations are working to control malaria in the hill district in collaboration with government including 14 NGOs led by Brac.

They have distributed 1,94,448 long lasting mosquitoes net (LLMN) besides blood tests, supplying medicines and arranging awareness campaign, the speakers said.

Among others, Deputy Commissioner Anis-Ul-Haque Bhuiyan, Chief Executive Officer Tarun Kanti Gosh, KHDC member Bir Kishore Chakma, Khagrachhari press club president Zizen Barua, its secretary Azim ul Haq, Brac district manager Rupok Chakma and Brac Sadar upazila manager Fazlul Haque addressed the roundtable.
