

# Two vehicles plunge into gorges in Kashmir, 23 dead

At least 23 people were killed yesterday and 60 injured when a bus and an army vehicle plunged into gorges in two separate accidents in Indian-administered Kashmir, police said.

The driver of the passenger bus failed to negotiate a sharp curve, a police spokesman said, and the bus fell into a 350-metre (1,150-foot) deep gorge in the southern district of Reasi.

"Seventeen passengers were killed and 55 others injured," the spokesman said, adding

the bus was overcrowded.

Two Indian Air Force helicopters were used to evacuate the dead and the injured from the mountainous area.

In the neighbouring Rajouri district, five army soldiers were killed and six others injured when their vehicle skidded off a mountain road and rolled into a gorge, an army spokesman said.

Bad roads, overcrowding and poor vehicle maintenance make road accidents common in the Himalayan region.

## People pay tribute to slain leaders in Kashmir

Thousands of people turned out yesterday to pay tribute to two slain separatist leaders in Indian Kashmir, as a one-day strike called to mark the occasion closed shops and businesses.

The strike was called by the moderate faction of the Himalayan region's main separatist alliance, the All Parties Hurriyat Conference, to remember Molvi Mohammed Farooq and Abdul Gani Lone.

Farooq, who was also the chief cleric in the region's main mosque, was murdered by unidentified gunmen at his residence in Srinagar, Kashmir's summer capital, on May 21, 1990.

## BNP grassroots

Empowered by the council, Khaleda later formed the party's national executive and standing committees though the party constitution empowers only the council to elect office bearers and members to both the committees.

Tamur Rahman, general secretary of Thakurgaon district BNP where council was held in December last year, said they had submitted the draft committee to party's Senior Joint Secretary General Mirza Fakhrul Islam Alamgir.

Fakhrul is also the president of both Thakurgaon district BNP and Jatiyatabadi Krishok Dal, a front organisation of the main opposition.

About the formation of Noakhali district committee, BNP's Joint Secretary General Mohammad Shajahan, who comes from Noakhali, said the council was held about three months back but the formation of full committee has not been completed.

A number of presidents and general secretaries of districts, however, told The Daily Star they had not been able to form full committees,

as they did not get the amended party constitution.

Syed Iftekhar Ali, general secretary of Sathkira district unit of BNP, said the full-fledged committee of the district had not been formed yet, as there was a lot of confusion about the new provisions of the party constitution.

"But we will submit a draft committee soon and hope the central leadership will approve it."

Madaripur district unit president Abu Bakar Siddique told The Daily Star that they had received the copy of party constitution last week and that is why they could not announce the full committee.

Meanwhile, the BNP has made no move to convene the national executive committee since it was formed afresh following the party's national council. It met last in September 2005.

Before the party charter was amended in the last council, the national executive committee was supposed to meet at least once in every three months. But the latest amendment relaxed the time limit and says the biennial meeting would suffice.

The CID investigators recently showed two other JMB men arrested. They are Salehin alias Sajeeb and Rahib Hasan alias Hafez Mohammad who were also arrested in other cases.

Of the five accused in the first probe, Abdur Rahman and Sunny were executed, Minhaz is in jail, and Shamim and Shahid are on the run.

CID Inspector Mustafizur Rahman who is the investigation officer of the case said "We grilled Salehin for four days and sought a five-day remand for Rakib Hasan before the court".

Latifa said the charge-sheeted accused might have been involved in the attack, but there were powerful persons including former lawmakers who abetted them in the heinous mission.

In 2004, the then lawmakers threatened to kill Humayun Azad, and even in parliament they declared him 'Murtad', she said.

"None of the masterminds is still arrested," Latifa added.

Asked about CID's move to arrest them, Mustafiz said CID was carrying out investiga-

tion, and once it gets enough evidence, it would take steps immediately in this regard.

Replying to a query, he said CID could not yet trace the fugitive JMB men who were accused in the first charge sheet.

Mustafiz also said, during the interrogation, JMB activist Salehin admitted to his involvement and informed CID about Rakib's involvement.

He said Rakib would be taken on remand soon.

On February 27, 2004, a gang attacked Azad with machetes in front of Bangla Academy leaving him critically injured. After his recovery, Azad went to Germany where he died on August 11, 2004.

In a confessional statement on June 3, 2007, JMB member Minhaz admitted to his direct involvement in the assault saying that a plan for the attack was finalised at Abdur Rahman's residence and Sunny was given the responsibility to execute it.

After the novel, Pak Sar Zamin Saad Baad, written by Azad was published, Rahman ordered his men to kill the writer, the confessional statement reads.
