PSTU DISCIPLINARY BODY SHOWS LENIENCY

BCL men now have to pay fine only 300 posts of officials,

Disciplinary committee of Patuakhali Science and Technology University (PSTU) has cancelled its earlier decision to expel 20 students, also activists of Bangladesh Chhatra League (BCL), who were punished for involvement in anti-disciplinary activities on the campus.

However, the students, except one, will have to pay different amounts of fine, said a press release signed by PSTU Deputy Registrar Naser Saleh on Saturday evening.

"We pardoned them considering their future. Besides, their guardians and local elites requested for it," PSTU Vice Chancellor Prof Dr

ShakhawatHussainsaid. The PSTU disciplinary committee took the decision in its 9th meeting presided over by the vice chancellor, also chairman of the committee, on Friday.

Earlier on May 13, PSTU authorities expelled 20 students for different periods and fined them at the same time for their involvement in anti-disciplinary activities on the campus.

Seven other students were fined for the same allegations.

Monjur Rahman Joni (4th semester), Madhob Chandra Shil (7th semester), all of Agriculture faculty, Mazharul Islam Shakil (7th semester) of Computer Science and Engineering (CSE) faculty and Khalid Mahmud Khan (7th semester) of Business Administration and Management (BAM) faculty will have to pay Tk 5,000 as fine as per earlier decision, said the press release.

Besides, they will have to pay additional fine of Tk 2,000 for failing to reply to show cause notice issued by the PSTU authority.

semester) and Arifur Rahman Peyel (3rd semester) will have to pay fine of Tk 5,000 each.

All the above six students, belonging to agriculture faculty, were earlier expelled for two semesters.

Eight students --

5,000 that was ordered earlier. They have been fined more Tk 2,000 each as they failed to reply of showcause notice in time.

Fine has been reduced from Tk 5,000 to 3,000 for Tanjilur Niaz Morshed Shaon (6th Rahman Khan, (7th semester), Rakibul Islam Roni (7th semester), Ramesh Canrda Das (6th semester), Abu Sayeed Md

Hasan (4th semester), all of Haque. The committee on agriculture faculty, and Sanjib Sarker Pintu (6th semester) of BAM faculty.

Sohag Mir (4th semester) of BBA was pardoned from both expulsion and fine.

The 14 students were expelled for one semester.

Fine has been reduced from Tk 5,000 to 3,000 for Saiful Islam Roni (3rd semester), Akbar Ali (4th semester), Jayed Bin Ali Sujon (4th semester), Shuvo Saha (4th semester) of BAM faculty and Shaikh Sabbir Ahmed (4th semester) of agriculture faculty.

Bishajit Das Hero (6th semester) of BAM faculty has been pardoned.

earlier fined Tk 5,000 each. On May 13, all the punished students submitted prayer, seeking pardon to the vice chan-

The vice chancellor formed a seven-member committee headed by PSTU students' affairs advisor Dr Rabiul

cellor through the registrar.

May 24 received statement from all expelled students who made written promise to the committee not to engage in anti-disciplinary activities on the campus.

Consequently, the committee recommended to the vice chancellor to pardon them.

The students were involved in the clash between Jewel group and Shakil group of Bangladesh Chhatra League (BCL) on PSTU campus on February 9 when 25 people were injured and at least 20 rooms of Sher-e-Bangla Hall and M Keramot Ali Hall were ransacked.

Early on February 8, BCL activists attacked Shibir men and ransacked at least eight rooms at Sher-e-Bangla Hall and M Keramot Ali Hall, apparently in reaction to Shibir's attack on BCL men at Rajshahi University.

Additional police have been deployed on the PSTU campus to avoid any unwanted incident.

Posts of cooperative officer, fisheries officer, primary education officer, women affairs officer, accounts officer and 40 third and forth class employees in Patuakhali Sadar upazila are

In Mirzaganj upazila, the posts of upazila engineer, assistant commissioner (Land), fisheries officer, primary education officer, public health officer and 50 third and forth class employees are vacant.

In Baufal, posts of the UNO, upazila engineer, election officer, BRDB (Bangladesh Rural Development Board) officer, family planning officer, fisheries officer, land registration officer, women affairs officer and 40

3rd and 4th class employees are lying vacant

Forty posts including Ansar-VDP officer and assistant commissioner (Land) in Galachipa upazila, 90 posts including upazila engineer, assistant commissioner (Land), fisheries officer, primary education officer, public health officer, Ansar-VDP officer, women affairs officer in Dashmina upazila, 41 posts including the UNO, assistant commissioner (Land), secondary education officer, fisheries officer and social welfare officer in Dumki upazila are

In Kalapara, over 25 posts in different sectors are vacant.

Two UNOs of nearby upazilas are performing additional duty as acting UNOs for Dumki and Baufal upazilas.

When contacted, Patuakhali Deputy Commissioner Md Reaz Ahmed said, "We have already sent several letters to the authorities concerned asking for necessary steps to fill all the vacant posts."

Outsider engaged to scrutinise documents!

The education ministry yesterday formed a committee to investigate enrolment of 56 fake headmasters for a government-run training programme at Secondary Teachers Training Institute in Rajshahi, five days after disclosure of the incident.

The one-member committee chief Prof Taslima Begum, director (Training) of the Directorate of Secondary and Higher Education (DSHE), has already started her investiga-

"The investigation so far reveals that Abdul Hannan, one of the alleged persons, usually serves as a peon at the institute although he is not an employee there. But he was engaged in scrutinising the papers of the training participants. The officials concerned need to answer why and how he was given the charge," said Prof Taslima, who was seen taking written statements of the officials and employees and examining pieces of evidence at the institute yesterday noon.

Hannan earlier worked in a project that ended in 1999.

"Two other employees Jahangir Hossain and Shafik Ahmed were also not supposed to be engaged in the scrutiny. Even if they were given the task, the officials concerned failed in their duty to properly supervise and

guide so that the scrutiny is done properly," the probe team chief said.

Following an anonymous telephone call on May 26, the institute authorities found that a staggering 56 of 84 participants in the May 22-27 teaching quality improvement (TQI) training programme were fake.

Students, small traders, non-teaching service-holders, even nearly illiterate people were enrolled for the six-day training programme meant for headmasters.

The 56 people were listed as 'headmasters' of nonexistent schools apparently to embezzle a portion of the money allocated for the training under a project funded by Asian Development Bank and Canadian Development

Agency (Cida). Institute Director Dr Swapan Kumar Dutta supervised the training while Additional Director Dr Shelina Afroze and assistant directors M Shamsuzzoha and Sirajum Munira coordinated the programme.

Earlier a three-member probe committee headed by Rajshahi New Government College teacher Shamsul Kalam Azad was formed to probe the irregularity in the training programme but the investigation faced difficulties after a certain stage as the institute director is senior to the probe body chief in government service rank.
