Constitution Day Denmark

MESSAGE

T is a privilege and honour for me to address the people of Bangladesh on the occasion of the Constitution Day of Denmark. On the 5th of June 1849 King Frederik VII of Denmark approved a democratic constitution with a two-chamber parliament and political parties. All subsequent changes of our constitution have entered into force on the 5th of June.

As Denmark's Ambassador to Bangladesh since September 2006, I am pleased to use the celebration of our Constitution Day as an opportunity to assess the relations between our two countries. During my stay in Bangladesh I have observed how our long and strong history of develop-

ment cooperation has developed into a mature partnership with now also strong ties in the area of business and trade and not least our political relations, where a number of ministers have been visiting our two countries in recent years.

First of all on behalf of the Government of Denmark I would like to thank Bangladesh for playing a proactive and constructive role before, during and after the climate conference COP15 held in December 2009 in Copenhagen. Bangladesh continues to play a commendable and constructive role in tackling the global and national challenges of climate change. COP15 was also an opportunity for the Honourable Prime Minister and several ministers to visit Denmark. The Danish Climate Minister also visited Bangladesh.

Just recently in the middle of April the Danish Minister for Development Cooperation, Mr. Søren Pind, visited Bangladesh, where he met with the Government of Bangladesh and representatives from civil society and private sector and visited a number of private companies in Dhaka and Chittagong. A visit was also made by the Minister to the Chittagong Hill Tracts where he saw development activities related to water supply and agricultural production. The Minister was satisfied with the programmes and committed Denmark to further cooperation with Bangladesh.

Denmark provides substantial devel-

opment assistance to Bangladesh, especially within the areas of human rights, democratisation and good governance, agriculture and water supply/sanitation and private sector development. We are also supporting a successful private sector instrument in Bangladesh called the B2B (businessto-business) Programme. The B2B Programme seeks to match and support long-term commercially viable business collaborations between companies in Bangladesh and in Denmark. The Programme has so far supported around 70 projects in sectors such as IT, shipbuilding sector, food processing and sustainable energy. I am very pleased to say that the Programme contributes to creating jobs and links Bangladeshi private companies with the international markets.

The most striking development for me is however the level of interest from Danish companies to do business in Bangladesh. In the past six month 31 Danish companies have come to Bangladesh. It started with 21 companies looking at the shipbuilding and fishery sectors. Of these companies five have already started doing commercial business in Bangladesh and four are about to start joint ventures for local production of trawls, hydraulics for ships, sonar equipment and other electrical equipment for ships. Another four companies are expected to start in Bangladesh very soon bringing the success rate to more Many of you will know that than 50 % in only six month. Last month 10 Danish companies came to

Bangladesh to focus on the energy sector as well as introduction of cleaner technology and it looks like eight of them will start doing business in Bangladesh.

It is good news for Bangladesh that foreign companies are interested in investing in the country. In order to ensure growth and reduce poverty it is also important to continue strengthening the framework conditions necessary for attracting foreign direct investments.

On behalf of the Government of Denmark I would like to commend the Government of Bangladesh for its initiatives to improve Public Financial Management, the recent establishment of the National Human Rights Commission and the strengthening of important guardian institutions, such as the Election Commission and the Anti-Corruption Commission, and other key institutions. Working towards a more functional parliament will also strengthen inclusive parliamentary practices being a cornerstone of any democracy.

In all programmes supported by Denmark special attention is given to the alignment of Danish development assistance with the national policies, systems and procedures. We therefore continuously explore opportunities for strengthening donor harmonisation and alignment with Government in order to ensure maximum efficiency and impact of the combined development assistance. One important milestone in strengthening donor harmoni-

sation is the Joint Cooperation Strategy by the Government of Bangladesh and 18 Development Partners, in support of the implementation of Government's Poverty Reduction Strategy. Here I would like to commend the Government of Bangladesh for its continued efforts to improve aid effectiveness and for hosting the successful Bangladesh Development Forum in February this year, which further strengthened the close dialogue between the Government of Bangladesh and the Development

Partners.

In closing, I would like to reassure Denmark's continued commitment to the longstanding and strong partnership with Bangladesh that has been ongoing ever since the Independence. I am hopeful that the warm relations between Denmark and Bangladesh will continue and become even stronger in the coming years.

According to the Danish Embassy the Energy and Clean Tech delegation was an enormous success. "Of the 10 companies, I'm sure we will see at least 8 being active in Bangladesh within the coming months. We have already seen the first MoUs being signed and some of the Danish and Bangladeshi companies are still discussing, their next step. We see both companies within large scale biogas, solar and wind power, but also within water cleaning coming up with project ideas and local partners to move on with.", says Morten Siem Lynge, B2B-coordinator
