8 Shibir cadres caught from RU exam hall

BCL men beat them up before handing over to police

Police arrested eight Shibir cadres at Rajshahi University (RU) yesterday in connection with February 9 violence on the campus.

Karim, Baizid, Hassanuzzaman, Shamim, Abul Kalam, Habibullah and Isahaq are third year students of Islamic Studies

department.

Sources said, at around 12:30pm, several hundred activists of Bangladesh Chhatra League (BCL) led by its secretary Mazedul Islam Opu blocked the three gates Arrestees Faruq, Abdul of Shahidullah Arts Building on hearing the news that a number of Shibir cadres were appearing in third year final examination of Islamic Studies.

On information, the university proctorial body along with law enforcers also rushed to the spot and took position at the gates to arrest the Shibir cadres.

At around 1:30pm, the BCL leaders and activists entered the building and caught the Shibir cadres from the examination hall. They then severally beat them up with iron rods and

Of them, Shibir cadre

Faruq received serious head injury on the spot. Police arrested the Shibir

men from the main gate after the BCL activists dragged the Shibir cadres out of the building.

BCL leaders alleged that the eight Shibir cadres took part in February 9 campus violence. Among them, Faruque led the first attack at Bangabandhu Hall that left BCL worker Kowsar and Asad injured on February 8 night.

RU proctor Prof Chowdhury Zakaria said the Shibir men were arrested for their alleged involvement with February 9 campus violence that killed BCL worker Faruk Hossain and injured a number of others

Abul Khair, officer-incharge (OC) of Motihar police station told this correspondent that the eight are accused in the cases filed in connection with the violence.

"We will take necessary steps after primary interrogation", he said.

According to the police, over 215 Shibir leaders and activists have been arrested till date in connection with 14 cases filed after the February 9 violence.

18 illegal structures demolished

Eighteen illegal structures on the bank of Laldighi, an ancient water body located in the heart of Jessore town, were demolished yesterday.

Jessore Pourasava (municipality) authorities with the help of district administration, police and Rab conducted the drive from 9:00am to 2:00pm.

Earlier, the municipality authorities had decided to fill up Laldighi for constructing a market there, ignoring the residents' demand for saving the important water body.

organisations including Workers Party, NAP, Gono Forum, Sammilita Sangskritik Jote and Sangbadpatra Parishad formed human chains on a few occasions protesting the move to fill up the water body.

Moksimul Bari Apu, a councillor of Jessore Pourasava said, "We have cancelled our earlier plan to construct a market there, showing respect to the demand of the townspeople.'

Nazir Ahmed, executive engineer of the municipality, said illegal structures were built, encroaching upon the water body. Notice was earlier served on the owners of these structures to vacate the Several political, social and cultural land by June 7, but they failed to comply

with the order, he added.

Restaurant owner Abdul Hannan said, "We have been running our business on this land for long by taking lease from the pourasava authorities. But the pourasava has demolished our shop, breaching the agreement."

Khandaker Firoz Iliyas, secretary of Jessore Pourasava, said the authorities will not lease any land around Laldighi in the future.

In 1864, authorities under the then British government arranged digging several water bodies including Laldighi in Jessore town to meet people's need for

One killed, 32 hurt as storms lash Gaibandha, Joypurhat

Storms killed one person and injured at least 32 others in Gaibandha and Joypurhat yesterday and the day before.

An old woman was killed and 17 others were injured in Gaibandha as a nor'wester lashed two upazilas early yesterday, according to our Correspondent.

The storm hit Gobindaganj and Sunderganj damaging over 200 dwelling huts and uprooting scores of trees, locals said.

Victim Fatey Bewya, 70, was wife of late Lasker Ali of village Noontola under Gobindaganj upazila. A thunderbolt struck her as she came out of her house amid heavy rain. Two others Moyna Begum, 35, and Abu Sayeed, 12, received burn

Four shops in Mohimaganj Bazar under the upazila were destroyed when a big banyan tree fell on the roofs.

The badly affected areas are Kamarpara, Noontola, Ulipur Shakhahati, Mohimanaj Bazar under Gobindaganj upazila and Dahabandh, Ramjibon, Chapporhati, Sarbanada and Santiram under Sunderganj upazila.

At least 30 schoolhouses, mosque and temples also collapsed during the nor'wester.

Meanwhile, road communication between Dahabandh union and Sunderganj upazila snapped as a portion of the road washed away due

to incessant rainfall in the last two days. Locals said movement of vehicular traffic remained cut off. Surging water even washed away the pavement of the road.

In Joypurhat, a severe storm lashed five upazilas of the district on Sunday afternoon leaving at least 15 people injured and damaging scores of houses, reports UNB.

Of the injured, Aleya, 30, Jesmin, 18, and Kalpana, 32, of village Harail in Sadar upazila were injured as thunderbolt struck them during the

Locals said the violent storm swept over the district at about 5:15pm damaging scores of dwelling houses and uprooting a large number of trees. It also twisted a few electric poles plunging the areas into darkness.

Critically injured eight people including Aleya, Jesmin and Kalpana were rushed to Joypurhat Modern Hospital while others were released after first aid.

Outlaw held, sent to jail in Mongla


