## Three housewives murdered over dowry, land dispute

Three housewives were murdered over dowry, land dispute in Satkhira, Sunamganj and Patuakhali districts on Monday and the day before.

A woman was beaten to death allegedly by her husband at village Madanpur in Kalaroa upazila for dowry on Sunday night, reports our Satkhira correspondent.

The victim was identified as Marzina Khatun, 24, wife of Shahidul Islam of the village.

Quoting locals police said, Shahidul Islam, son of Joynuddin Dalal of the village took Marzina as his second wife about five years ago. Shahidul received a dowry of Tk. 40,000 at the time of marriage. Recently he demanded more money for the victim's parent to buy a motorbike. As Marzina could not pay the

amount, he used to torture her off and on, police sources said.

On the fateful day, Shahidul beat her mercilessly as she refused to go to her parent's house to bring the money.

At one stage Marzina died and the killer husband fled the scene. Police recovered the body with marks of injuries and sent it to Satkhira morgue for post-mortem.

In Sunamganj, a housewife was strangled to death allegedly by her husband at Amtoil village in Tahirpur upazila early Monday, reports UNB.

The victim was identified as Rubia Khatun, 29, daughter of Eakub Ali, of the village.

Police said M Latib, strangled his pregnant wife to death and left the body on the bank of Maram river.

Locals found the body, caught Latib

and informed police in the morning. Police arrested Latib and a case was filed.

Our correspondent in Patuakhali reports: A housewife was murdered in her sleep on Sunday night allegedly over a land dispute at Paschim Auliapur village.

The victim was identified as Joynab Begum, 50, wife of Khalilur Rahman of the village.

Khalil is now in jail as he was convicted for 32 years in a murder case.

Police said, Joynab and her mother-in-law Jamili Bibi, 90, who is blind and dumb, were sleeping in her house. In the dead of night assailants chopped her to death by sharp weapons and fled away.

Rashida, daughter of the victim came on the spot on hearing the news of murder and informed police.

She also filed a case with Patuakhali police station.

## SUNAMGANJ BOAT TRAGEDY

# Death toll rises to 15 as search operation called off

With recovery of two more bodies yesterday, the death toll from Tuesday's boat capsizing in Shoilchakra haor under Dharmapasha upazila of Sunamganj district rose to 15.

The bodies found yesterday are of Rony Akhtar, 14, and Nahida Begum. Both were students of Badshaganj Girls High School.

Search for another missing student named Zaria, 15, daughter of Abdul Quddus of Balijuri village, was going on as of filing of this report at 6:00pm.

Fire Service divers, who reached Dharmapasha at 9:30 pm on Tuesday, declared their job ended before going back to the capital yesterday morning.

Contacted, Dharmapasha Upazila Nirbahi Officer (UNO) Md Babul Miah said all the 15 bodies were buried at a graveyard at Balijuri village after Janaja yesterday afternoon. He said the district administration had given Tk 3,000 for burial of each of the deceased.

The small engine boat with over 50 passengers aboard sank in the haor at around 9:30am due to overloading and strong current in the haor.

All the passengers were

from Balijuri heading towards Shelborosh of the upazila, said Upazila Chairman Awal Talukder. He immediately sanctioned Tk 2,000 for burial of each of the deceased.

About 30 students of Badshaganj Girls' High School and Badshaganj Pilot High School were on the boat on their way to

school, said Shamsuddin Ahmed, principal of Badshaganj Degree College. The boys managed to swim ashore, he said.

Thirteen bodies were recovered on Tuesday. The victims were identified as Hashi, 14, Nurpur, 13, Nobija Khatun, 35, wife of Fazal Haque and her five-month-old child Babu,

Tajul Islam, 1, son of Nurul Islam, Akilama, 1, daughter of Deen Islam, her brother-Rahul, 4, Swapna, 12, daughter of Abdur Rab Miah, Poshaker ma, 55, Rokeya Begum, 35, Jharna Begum, 14, Monimala, 15, former UP member Hajera Begum, 55, Rony Akhtar, 14 and Nahida Begum, 15.





## Five get life in Bogra for killing BCL leader

### 7 jailed in Faridpur murder case

A Bogra court yesterday sentenced five people to life term imprisonment for killing a leader of Bangladesh Chhatra League (BCL), reports our staff correspondent.

The court also fined the convicts Tk 20,000 each, in default, to serve two years more in jail.

Judge Nitai Chandra Saha of Judge court-3 handed down the verdict against Sumon, 24, Jitu, 24, Adam, 24, Anarul, 26, and Gittu Masum for killing Robiul Islam, a BCL leader.

The court also acquitted nine other accused in the case.

According to the case statement, the convicts shot and hacked Robiul to death on September 28, 2006 in front of his house.

Victim's brother Abdul Motin later filed a murder case on September 30, 2006.

In Faridpur, a court yesterday awarded life sentence to five people and different jail terms to two others for killing a man in Sadar upazila in 2006, reports our correspondent.

The lifers are Anwar Zahid, 32, former district correspondent of daily Inqilab, Jahangir, 22, Shaheed, 25, Kalachan, 32, and Majed 24. The court also fined them Tk 50,000 each, in default they are suffer six months more in jail.

Two other convicts are Bazlu, 28, and Rabeya, 50. Bazlu was sentenced to seven years imprisonment while

Rabeya to three years. The court fined Bazlu Tk 10,000 and Rabeya Tk 5,000, in default Bazlu is to suffer three more months and Rabeya one more month in jail.

Police submitted a charge sheet in the case on March 9, 2008 against Anwar Zahid Zahangir, Shaheed, Majed, Kalachan, Nazrul, Zihad, Bazlu, Rabeya. Of them, Nazrul, Zihad were acquitted as murder charge brought against them could not be proved.

Additional District and Sessions Judge Abul Kashem Mohammad Mostafa Kamal pronounced the verdict.

According to the prosecution, Kamal Hossain, 28, of Laxmipur village under Sadar upazila, went missing on December 25, 2006. After seven days, his decomposed body was found in double-bridge area of Keshobnagar. Being informed police went to the spot and recovered the body.

Victim's uncle Md Elias Hossain filed a murder case with Sadar Police Station on January 2, 2008, against Bazlu, his elder brother Kalachan, mother Rabeya Begum, Jahangir, Majed, Shaheed and four to five unnamed people.

Police later arrested six accused and on their confessional statements, they (police) arrested Anwar Zahid on January 17, 2008.


