A young man died from electrocution and three others sustained injuries in Ajmiriganj upazila headquarters on Thursday.

The deceased is Nizamul Mia, 20, and the injured are Rokon Mia, 30, Sumon Mia, 12, and Abidul Mia, 7, of the upazila. Locals said Nizamul died

on the spot and three others sustained injuries when they came in contact with a live electric wire at noon.

The injured were given first aid at a local clinic. Another report from

Bagerhat adds: A woman was electrocuted at Moghia village in Kachua upazila Thursday morning.

The deceased was identified as Bashanti Rani, 35, wife of Amal Dakua of the village.

Local sources said Bashanti died instantly when she came in contact with a live electric wire at her house during a marriage ceremony.

Tougher agitation threatened

Students of different departments under Social Science Faculty at Rajshahi University (RU) yesterday laid a siege to the administrative building demanding cancellation of evening master's courses under the faculty. Over 500 students of eight

departments under the faculty blocked the building's main gate for an hour from 11:00am to 12:00pm. Earlier, the students

formed a human chain in front of the university central library followed by a protest procession that paraded the campus.

At a rally in front of the administrative building, the

students said the evening were not met within 24 hours. Prof Mizan Uddin, dean of masters courses will add to session jam worsening the situation alarmingly. They

Social Science Faculty said that he will look into the matter and take steps after talks with the university authorities. RU Vice Chancellor Prof

Abdus Sobhan was not available for his comment.

The students have been staging protest for the last 10 days as the university authorities decided to launch evening masters courses at eight departments under Social Science Faculty.

#### JU official's house looted in Savar

3 robbers held in Natore

Robbers looted valuables worth Tk 20 lakh from the house of former Assistant Controller Jahangirnagar University (JU) at Islamnagar here early Friday.

Police and locals said, a gang of robbers numbering 15/20 swooped on the house of Bachchu Mia at about 4:00 am. They took the members of the house hostage at gunpoint and looted cash, 50 tolas of gold ornaments, mobile phone sets and other valuables.

The gang also beat up Shamsunnahar, wife of Bachchu Mia, severely as she tried to resist them.

A case was filed in this connection.

In Natore, police in a drive seized a private car and arrested three robbers along with a firearm from near Kachikata toll plaza on Bonpara-Hatikumrul highway in Gurudaspur upazila on Friday night.

The arrestees were identified as Bazlu and Mamun of Singra upazila and Shuvo of Chatmohor upazila in Pabna district.

Police said, a team of DB police challenged the private car while it was moving suspiciously in the area at dead of night.

Later, after a hot chase they seized the car and arrested the three robbers along with a shutter gun loaded with three bullets while three others managed to flee from the car.

Police said the arrestees are the members of an inter-district robber gang. A case was filed in this connection.

# Massive plan to cultivate palm oil in Gaibandha

A massive plan has been taken up to plant 10 lakh palm oil saplings in all the seven upazilas in the district to meet the demand of the edible oil and address 'monga' and maintain ecological balance.

Sources said the saplings would be planted on the yards and surroundings of the houses and the homesteads, roadsides and abandoned and open spaces within three years. Palli Unnayan Sangstha

(PUS), a local organisation, is implementing the plantation programme in co-operation with three associate organisations -- Sheba of Sadullapur, Sonar Bangla of Plashbari and Apon of Sadar upazila -- with the financial support of Happy Bangladesh under its the growers plant saplings and Kartik.

Development Project, the sources said.

Of the total, around 2.90 lakh saplings would be planted in Sadullapur upazila, 1.50 lakh in Sundarganj and Gobindaganj upazila each, 1.20 lakh saplings in Sadar and Shagata upazila each, 1.00 lakh in Palashbari upazila and 70 thousand in Fulchhari upazila during the period.

Plantation programme is going on in full swing and over 5,200 saplings have already been planted in the upazilas till June 10, locals said.

The growers will get oil from the trees within three and four years, sources said. As many as 180 staff including nine upazila coordinators and 162 supervisors have been recruited to help

Bangladesh Palm Oil and nurture those properly and to make the programme a grand success, said an official of PUS.

M. Anisur Rahman Joarder, Chief Executive of PUS told the news agency that if any person can plant at least two saplings, the demand of edible oil in his or her family will be fulfilled

On the contrary, if 100 saplings are planted on an acre of land, the grower will be able to earn 4-5 lakh taka from palm oil annually, he said.

#### Youth murdered

A young man has been murdered at Haldha village in Naldi union of Lohagara upazila. His body was found in a marshy land near the village yesterday morning. He was called out of his home Friday morning by some locals but he did not return home. Police believe Jahangir was murdered by his accomplices.



#### Arms, phensidyl seized

The members of Rapid Action Battalion (Rab) recovered foreign-made arms, ammunition and phensidyl here early yesterday. Acting on a tip off, a team of Rab-12 led by its commander Major Mahfuzul Haque ordered a Dhaka-bound truck from the North to stop at the Bangabandhu Bridge east end at around 2:00am but the truck tried to flee, Rab sources said. As the law enforcers chased it, the driver and passengers left the truck in Ibrahimabad area, two kilometer away from the bridge and fled the scene. The Rab members later recovered a USA-made 7.65mm pistol, its seven bullets with a magazine from under the driver's seat and 1220 bottles of phensidyl from the truck.
