30 hurt as JP, AL men clash in Rangpur

Attack and counter-attack by Jatiya Party and Awami League activists at Badarganj upazila headquarters yesterday left over 30 people injured.

The trouble began when JP activists, wielding sticks, reached in front of the house of Badarganj Upazila Parishad Chairman and local Awami League leader Bishawnath Sarker Bitu at around 1:30pm to protest against 'insult' to JP lawmaker Anisul Islam Mondol by a union parishad chairman in a Test Relief committee's meeting on Saturday. Bitu chaired the meeting.

As Awami League activists swooped on the JP men, they retaliated and at one stage stormed into the chairman's house and damaged furniture and portraits of some national leaders.

At least 30 people from both sides were injured during the attack and counter-attack. The JP men also damaged three motorbikes at a workshop adjacent to the house of the upazila chairman.

Later, AL activist brought out a procession at the upazila headquarters protesting attack on upazila chairman's house and pelted brickbats at the house of a relative of lawmaker Anisul Islam Mondal. They also set fire to a billboard beside the house.

Anisul Islam Mondol, JP lawmaker from Rangpur-2 constituency (Badarganj and Taraganj upazilas), alleged that Bitu's men attacked a JP procession, leaving at least 12 processionists injured.

The lawmaker said he lodged a case

with Badarganj Police Station yesterday against Bitu's accomplices who threatened him with death following Saturday's incident at the auditorium of Badarganj upazila complex.

"As I lodged the case against them, they became violent and attacked the JP men in front of Bitu's residence," the lawmaker said.

Badarganj Upazila Parishad Chairman Bitu alleged that Mondol's men attacked the AL activists and ransacked his house as upazila Test Relief Committee refused to give him rice under the programme at a meeting on Saturday.

The lawmaker refuted the allegation, saying that Upazila Parishad Chairman Bitu is trying to tarnish his image, bringing false allegation against him.

Students punished by KU say they were wronged

Stage protest, give deadline to change decision

A section of students of Khulna University (KU) yesterday demanded cancellation of the authorities' decision to take punitive action against 34 students.

Giving a 72-hour ultimatum, they warned of tougher agitation if the authorities did not meet their demand by the deadline.

The university reopened yesterday after remaining shut for over two months.

The authorities on June 8 decided to permanently expel four students and take punitive measures against 30 others for their involvement in an untoward incident on the campus on April 5.

Yesterday, some 100 students including the punished 34 formed a human chain on the campus to press home their demand.

During the three-hour programme that began at about 10:00am, the agitating students urged the general students of the university to join them. But their move fell flat, according to

The four students, who were expelled

from the university, yesterday denied their involvement with the incident. They said the university authorities

took an one-sided action against them. KU Vice-Chancellor Prof Md Saifuddin Shah, however, told this correspondent that they took action against the 34 stu-

dents giving them a chance to appeal against the decision. The four students permanently expelled from the university are Abir Hossain Talukder of Urban Planning, Golam Faruque of Social Science, Saiful

Islam Bappi of Business Administration

and Zakaria Jaber of Architecture depart-

Besides, seven students have been expelled for two years and fined Tk. 15,000 each, in default, to face expulsion for more one year, 13 students for one year and fined Tk 15,000 each while 10 others fined Tk 15,000 each as their involvement was proved beyond doubt by the probe committee.

Earlier, the Vice Chancellor formed a seven-member committee on April 6 to probe the untoward incident of April 5.

On April 5, a few students of the university locked in an alteration with flexiload shop owner Shahnewaz over non-payment of dues.

At a stage it turned into a fierce clash between two groups forcing the authorities to shut the university indefinitely.

Kethega Tangchangya, 40, son of Chola Tangchangya of village Tiger Para of Farua union died on Saturday night, locals said.

Diarrhoea spread to almost entire area of the four villages of Farua, the remotest union in the district in the last couple of days, according to sources.

The most affected villages are Tiger

Para, Tyindong Para, Bilchhari and visit our areas. Last year, they came to our Sanjong Para. At least 500 people live villages with some medicine. But nobody there in about 100 houses without nominal healthcare facility.

"When I asked a field worker for medicine, he told me that he has no medicine allotted for my area," added Jakob.

District Civil Surgeon Mohammed Abdullah yesterday said that a threemember team along with necessary medicine has been sent to the area.

"I hope the situation in the diarrhoea "People of health department rarely affected areas will improve soon," he said.

Man gets life for killing his wife

A court here on Thursday sentenced a man to life term imprisonment for killing his wife in 2008.


