

RU to shelve plan for evening courses

In the face of student agitation, the Rajshahi University authorities yesterday postponed their decision to introduce evening master's courses in all departments under social science faculty.

The authorities took the decision at an emergency meeting after the RU students of different departments called for an indefinite strike from today (Wednesday) to press home their demand for withdrawing the decision to intro-

duce evening master's course in different departments under social science, law and business studies faculties.

The students gave the strike call at a press conference in the office of Rajshahi University Journalists' Association at around 1:45 p.m. Immediately after the strike call, Vice-Chancellor (VC) Prof Abdus Sobhan sat with the deans of nine faculties of the university in his office and took the decision.

The authorities, however, did not take any deci-

sion about two other faculties—law and business studies—where they decided to introduce evening master's course.

At around 8:30pm yesterday, the RU students withdrew their proposed indefinite strike from today, urging the authorities not to introduce evening master's course in two other faculties.

The students of social science faculty had been agitating since June 2 to press their demand for withdrawing the RU authorities' decision to introduce

evening master's course in all eight departments under the faculty.

On Monday, the students of law and business studies faculties and other departments of the university joined the agitation and locked two academic buildings for four hours from 8:00am.

They also brought out a procession on the campus, held a rally in front of the administrative building and staged a sit-in for two hours on the premises of Rabindra Arts Building.

Ex-PCJSS leader shot dead

A former member of a reformist group of Parbattya Chattogram Jana Sanghati Samity (PCJSS) was shot dead allegedly by the armed cadres of PCJSS at his house at Moddhyam Pakuzzachhari under Baghaichhara upazila of the district Monday night.

The deceased was identified as Suvas Chandra Chakma, 37, son of Samo Dhan Chakma.

Sources said a group of 12 to 15 armed men attacked his house in the small hours of Monday and asked him to open the door.

As Suvas did not respond to their call, the gang broke open the door and fired several shots at him leaving him dead.

Officer-in-Charge of Baghaichhara police station Naseem Uddin confirmed the incident.

Police recovered the body and sent it to Khagrachari Sadar Hospital for autopsy.

Sajid Chakma, assistant publicity secretary of central committee of PCJSS denied the allegation.

He said, "we don't believe in politics of killing. It might be an internal conflict."

Strike at stone quarries

Sylhet District Truck Owners' Association and three other organisations have called a day-long strike at all stone quarries in Jaintapur and Gowainghat upazilas today demanding immediate removal of illegal toll collection points from Sylhet-Tamabil highway.

The leaders of the four organisations gave the call at a press conference at Sylhet Press Club yesterday afternoon. They read out a written statement at the conference, alleging that some organised groups have set up four illegal toll collection points on the highway in the name of union parishad tax and upazila parishad tax.

They even forcibly realise Tk 700 to Tk 1200 from each stone-laden truck, the press conference was told.

They further alleged that they had submitted a memorandum to the deputy commissioner last week demanding removal of the illegal toll collection points from the highway, but to no effect.

President of Sylhet Zila Truck Malik Samity Saleh Ahmed Khasar, Jafflong Stone Crushing Mill Malik Samity President Haji Aziruddin, Jaintapur Truck Malik Samity President Md Sirajul Alam, Jaintapur Pathor Sramik Trade union leader Abdus Shukur were present at the press conference.

Over 50,000 labourers work in the quarries at Jafflong, Sripur and Bichhakandi. Some organised groups allegedly backed by the ruling party leaders are involved in illegal toll collection on Sylhet-Tamabil highway, which is used for transporting stones from the quarries to Sylhet and other places of the country.



Flash flood in Barisal, tidal water enters Patuakhali

Flash flood caused by heavy downpour hit at least 50 villages in Barisal while tidal water flooded five villages in Patuakhali in the last two days.

The flash flood in Barisal followed continuous downpour and onrush of water from upstream, reports UNB.

The district relief and rehabilitation office said, at least 50 villages and shoals of five upazilas of the district went under water.

A large number of people in the affected areas of Mehendiganj, Hizla, Muladi, Wazirpur and Agoiljhara have taken shelter on high land and in educational institutions, upazila administra-

tion sources said.

In Patuakhali, at least five villages under Aila-hit Mirzaganj upazila were inundated as the flood control embankment on the Payra river collapsed at different points during high tide on Monday and Tuesday.

The tidal water rose above the normal level, reports our correspondent.

It was flowing at 2.60 metre which is 0.60 metre higher than usual level, according to Water Development Board officials.

Mobarak Ali Munshi, UP chairman of Subidkhali UP told this correspondent that several areas of the 7 km-long flood control embankment washed away as high tide hit the coast.

The dam was earlier affected by both cyclones Sidr and Aila, he said.

At least five villages—Mehendiabad, Ranipur, Charkhali, Golkhali and

Hajikhali—were inundated as tidal water entered through the breaches, he added.

Md Shahjahan, upazila agriculture officer of Mirzaganj told this correspondent that Aus paddy on at least 1,000 acres went under tidal water.

"A vast tract of crop field will be affected due to saline water and silt," he said.

Contacted, Siddiqur Rahman, executive engineer of WDB said, "We hope that repair of the embankment will start by next month."

Seventy students of Khulna University (KU), who began fast-unto-death on Monday demanding withdrawal of punishment imposed by the authorities on 34 students of the university in connection with April 5 incident on the campus, continued the programme for the second day yesterday.

Seven of the 70 students fell sick yesterday morning and they were given intra-venous saline by private physicians. They are Imran Ahmed, Mustafizur Rahman, Ismat Jahan, Praggo Dipa Halder, Zakaria Jaber, Mahbub Alam and Arefin Huq.

On April 5, a few students of the university locked in an alteration with flexi-load shop owner Shahnewaz over non-payment of dues. At a stage, it turned into a fierce clash between two groups forcing the authorities to shut the university indefinitely. The university reopened on Sunday after remaining shut for over two months.

Vice-Chancellor Prof

Saifuddin Shah formed a seven-member committee on April 6 to probe the untoward incident. On the basis of the committee's report, the authorities on June 8 permanently expelled four students and take punitive measures against 30 others for their involvement in June 5 incident.

Those permanently expelled from the university are Abir Hossain Talukder of urban planning department, Golam Faruque of social science department, Saiful Islam Bappi of business administration department and Zakaria Jaber of architecture department.

"Our fast-unto-death will continue until the demand is met," they said.

Vice-Chancellor Prof

Saifuddin Shah told this correspondent that nine out of the punished 34 students have appealed to him in writing for reconsidering the punitive action taken against them.

"They have rejected my appeal to call off fast-unto-death programme for greater interest of the university," the VC said.

He hoped that the crisis would be resolved soon with active cooperation of teachers and students.

But the hunger strikers, when asked, said they did not submit any written appeal to the vice-chancellor for mercy. His action against 34 students is quite unjust, they added.

Flood situation in Sylhet unchanged

Flood situation in the district remained unchanged yesterday despite decrease in rainfall in the last 24 hours.

However, all the rivers marked further rise flowing above danger level at many points.

The road link between Zakiganj, Balaganj and Beanibazar upazilas and district headquarters remained snarled as water inundated several

points of Sylhet-Zakiganj, Sylhet-Baroigram and Tajpur-Balaganj roads.

The Surma was flowing 12 cm above danger level in Sylhet, 18 cm above at Sunamganj town and 95 cm above at Kanaighat while the Kushiyara was flowing 98 cm above at Amoloshingh border point and 79 cm above at Sheola at 3:00 pm yesterday, Water Development Board (WDB) officials informed.

Erosion by the Surma and the

Kushiyara took a serious turn in Zakiganj, Beanibazar, Golapganj, Balaganj and Fenchuganj during the last two days.

Floodwaters submerged Zakiganj upazila headquarters for the fourth day yesterday causing much suffering to the people.

Many areas in Zakiganj municipal and Fenchuganj upazila headquarters are still under water.

In Golapganj upazila, all villages in Budhrabazar, Sharifganj and

Badapasha unions have been badly affected.

In Balaganj, floodwater continued to enter villages through at least five breached points of Kushiyara dyke.

Upazila complex and upazila health complex areas are now under 2-3 feet water.

In Dakkhin Surma upazila, floodwater damaged about 2,000 hectares seedbed of Aus paddy, officials said.
