Jessore doctors call off strike

Doctors at Jessore General Hospital withdrew their indefinite strike after a fruitful meeting with local political leaders and administration officials held in the conference room of the deputy commissioner yesterday.

The doctors went on an indefinite strike on June 17 protesting assault on one of their colleagues by the relatives of a patient who died at the hospital on the night of June 16 due to alleged neglect of the doctor. Two separate cases were filed with Sadar Police Station after the incident.

At the meeting yesterday, both sides agreed to withdraw the cases. It was also decided that additional police will be deployed at the hospital to ensure security of the doctors.

Settlers besiege members of int'l CHT body

Bangali settlers yesterday besieged the visiting members of the International Commission for CHT Affairs for an hour at Bagaihat under Bagaichhari upazila of Rangamati district.

The members of the commission were going to see the progress of post-violence rehabilitation works at some affected villages in the upazila.

The settlers blocked the vehicles carrying the commission's members and urged

them to listen to their sufferings caused by the violence on February 19 and 20. The member of the commission came down from their cars and gave a patient hearing to their problems.

After withdrawing the blockade at around 12:00 noon, the team members visited Gangaram Mukh, Ratkaba, Dany Baibachhara, Baye Bhaibachhari and Seminapara villages. They also talked with the affected villagers and enquired about the progress of their rehabilitation at the villages.

On Saturday, the team visited affected Mohajanpara, Shantiniketan and Satbhaiyapara areas under Sadar upazila of Khagrachhari district talked with the locals.

The members of the commission also sat with the leaders of United People's Democratic Front (UPDF) at Surja Shika Club at Mohajanpara in Khagrachhari town. They discussed with the UPDF leaders about February 23 violence that left four people killed and 75 others injured.

2000 workers of another jute mill laid off in Khulna

Over 2000 workers and employees of privately owned Mohsin Jute Mills at Shiromoni industrial belt have been laid off for 45 days with effect from Saturday.

General Manager of the mill Anwarul Mumin said in the layoff notice that higher production cost, severe crisis of raw material and sharp fall in demand of its products in international markets are the reasons for closing the mill till August 2.

The workers and employees have been laid off as per provision in the labour law as the jute mill has turned into a losing concern", Anwar told this correspondent.

Meanwhile, hundreds of workers assembled around the mill from 8:00 am yesterday to protest against the layoff

notice.

CBA president of the mill Sultan Molla, while addressing a protest rally there, blamed the management for creating financial crisis intentionally.

He said that management of the mill took Tk two crore and 70 lakh as loan from Sonali Bank two months ago for purchasing raw jute.

But the mill has been closed in a pre-planned way instead of purchasing raw jute, the CBA leader alleged.

"We shall go for tougher agitation demanding reopening of the mill. Our programmes will include road and rail blockade, call for indefinite strike in all jute mills of Khulna-Jessore industrial belt, fast-unto-death and self-immolation, he said.

The president of Khulna city unit of

Bangladesh Sramik Kalyan Federation Khan Golam Rasul issued a press statement yesterday condemning 'double standard' of the government in resolving the crisis prevailing in the Khulna-Jessore industrial belt.

State owned Khulna Newsprint Mill, Daulatpur Jute Mill, People's Jute Mill, Khulna Textile Mill, private owned AFI Jute Mill and Dada Match Factory have remained closed throwing nearly two lakh workers and employees out of jobs, he said.

The poor jobless workers are getting nothing but lip service from government in the name of reopening these industries, he added.

Four platoons of police were deployed in and around the laid off Mohsin Jute Mill since Saturday night to maintain law and order.

LAND DISPUTE

9 injured in attack, houses torched

Nine people were injured and nine families rendered homeless in a barbaric attack over land dispute at east Faridpur village of Palashbari upazila on Saturday morning.

Several houses were completely destroyed as those were set on fire during the attack.

Of the injured, Rustam Ali, 45, his wife Shantona Begum, 40, Montu Miah, 40, and Halima Begum, 37, wife of Ful Miah, have been admitted to Palashbari hospital, while others were given first aid.

Police have detained one Abdul Jabbar, 35, in connection with the attack. Other attackers have been absconding.

Police and local sources said the attack was a sequel to longstanding dispute over 41 decimal of land between Khaja Miah, Osman Miah and Solemuddin, sons of late Sobed Ali of the villa and Thanda Miah, Rostom Ali, Montu Miah and others of the same village.

A case is pending in court over the disputed piece of land where nine families, including of Thanda Miah and Montu Miah, have been living.

On Saturday, Osman Ali, Khaja Miah and Solemuddin equipped with sticks and sharp weapons suddenly attacked the nine families, vandalised the nine houses and later set fire to the houses. They also looted five tube-wells, paddy, rice and other valuables.

Constable held on extortion charge

A police constable was arrested in Meherpur on charge of extortion on Saturday evening.

The constable, identified as Bulbul Hossain, allegedly demanded Tk 5 lakh from Rupali Khatun, wife of Dubai expatriate Anwar Hossain.

Bulbul also threatened the woman to implicate in false case if she did not meet his demand.

Rupali contacted a high police official in the district

and sought his help. She also filed a general diary (GD) with Meherpur Sadar police as per the advice of the police official, several days ago.

On Saturday morning, when Bulbul asked Rupali to pay the money, Rupali told him to come to her house in the evening.

As Bulbul came to collect the money at about 7:00 pm, she informed Sadar police.

A Sadar police team led by sub-inspector Hasan Imam rushed to Rupali's house and arrested Bulbul from the spot.

Police said they have already

suspended the constable and departmental action will be taken after investigation.

Meanwhile, muggers stabbed a businessman in Chuadanga on Saturday in broad daylight and took away Tk 1.2 lakh from him.

Police said, cosmetic trader Ali Hossain of the town was attacked at Purbasha transport counter at about 7:30 am. He was supposed to leave for Dhaka on business purpose.

The gang stabbed him indiscriminately as he tried to resist them and fled with the bag containing the money.

2 missing in boat capsized

A man and a woman went missing as a boat capsized in the Kaloni River in south Sunamganj upazila yesterday. The victims were identified as Sadik Mia, 35, and Rahima Begum, 37, of Asharchar village. Locals said the boat carrying 10 passengers sank due to strong current while crossing the river in the morning. Other passengers, however, managed to swim ashore.

Body recovered

Police recovered the decomposed body of a young man from a closed jewellery shop at Pashchim Lamapara under Fatulla police station in Sadar upazila on Saturday afternoon. The identity of the deceased body could not be known immediately. Getting bad smell from the shop that remained closed for the last three days local people informed the police. Later, police rushed to the spot and recovered the decomposed body from the shop. Police suspected the victim was killed three days ago by the assailants in the shop. Shop owner Alam Mia and his five employees remained absconding. Police sent the body that bore stab injury marks to Sadar hospital morgue for autopsies.

Woman murdered

A woman was killed allegedly by her nephew at Char Adampur village under Sadar upazila over a family feud in broad day light yesterday. The dead was identified as Mehera Khatun, 40, wife of Jamal Biswas of Char Adampur village of Ambikapur union under Sadar upazila. Ripon Biswas, 11, a witness and the second son of the four children of victim Mehera said, at around 10:00 am Eskander Sheikh, 25, attacked Mehera with lethal weapon while she was cutting grass for the cattle at a field adjacent to her house. Mehera died on the spot as Eskander chopped her indiscriminately.

2 held for rape, murder

Police arrested two people on charge of killing a schoolgirl after rape at Narayanpur village of Devidwar upazila on Saturday. The arrestees were identified as M Bashir Alamgir, 25, and M Abdur Rashid, 27, of the village. Police said on Wednesday morning the two culprits abducted Farzana Akhter, 9, a student of class three and daughter of Siddiqueur Rahman on her way to school. They took her to a nearby bamboo cluster and killed her after rape. Later, after hectic search her body was recovered in the afternoon. The victim's father filed a case with the police.
