Experts tell post-budget discussion

Women's contribution to national economy through their agriculture and household activities must be measured to prepare a gender-sensitive budget, experts at a post-budget discussion said yesterday.

They said as the non-economic household activities are not measured in Gross Domestic Product (GDP), the women are deprived of enjoying their economic freedom.

Bangladesh Mahila Parishad organised the discussion titled 'Gender sensitivity in the proposed budget' at the National Press Club.

Dr Fahmida Khatun, additional director of Centre for Policy Dialogue pre-

sented the keynote paper.

Saarc ministerial meet begins today

In a bid to end violence against children, the third Saarc ministerial level meeting is beginning in Kathmandu today (Wednesday), official sources Ministers and senior gov-

ernment officials of Afghanistan, Bangladesh, Bhutan, India, the Maldives, Nepal, Pakistan and Sri Lanka are taking part in the meeting.

Nepalese Prime Minister of Madhav Kumar Nepal is scheduled to inaugurate the meet to be held at Soltee Crown Plaza in Kathmandu.

The Ministry of Women, Children and Social Welfare of Nepal is hosting the Secretariat of the South Asian Forum for Ending Violence against Children.

The meeting will discuss the issue of integrating South Asian Forum (SAF) with the secretariat or establishing a separate secretariat.

The SAF set up in 2005 as an outcome of the Regional Consultation on the UN Study on Violence against Children held in Islamabad works on trafficking, early marriage, sexual abuse and exploitation and child protection.

It is supported by the South Asian Coordinating Group for Ending Violence against Women and Children, a group of regional UN Agencies and International NGOs.

2 JMB men jailed | BNP readies | for June 27 for blast at court

A Dhaka court yesterday sentenced two leaders of Jama'atul Mujahideen Bangladesh to 32 years' of rigorous imprisonment for the serial bomb blasts on the Mymensingh court premises in August 2005.

Judge Mohammad Rezaul Islam of the Speedy Trail Tribunal-4 handed down the verdict in presence of convicts Kawsar Alam alias Sumon and Amanullah Akhond alias Sanaullah. The court also acquitted

Salauddin alias Salehin and nine others as the charges pressed against them were not proved.

Earlier, the prosecution and the defence completed their closing arguments and the court recorded statements of 23 prosecution witnesses.

According to the prosecution, around 11:10am on August 17, 2005, several bombs were blasted on the Mymensingh court premises that injured four people.

Later, a case under the Explosive Substances Act was filed against the banned Islamist militant outfit JMB leaders and activists with Mymensingh Police Station.

After an investigation police pressed charges against 12 alleged JMB leaders and activists.

17 burn patients return home

At least 17 burn patients of Nimtoli inferno, who were admitted to Dhaka Medical College and Hospital and Combined Military Hospital in the capital, returned home after receiving treatment for more than a week.

Around 46 burn patients were admitted to DMCH on June 3, the night of the fire incident. Of them 14 were referred to CMH on the following day.

Two seriously burnt

patients--Nasrin, 38, and Sohel, 30, were released from CMH yesterday, said ISPR press release. So far, four burn victims have succumbed to their injuries, it also mentioned.

Dr Samanta Lal Sen, project director of Burn and Plastic Surgery Unit of DMCH said at least 15 patients were released after their conditions improved while five died in the hospital.

Currently 12 victims of the Nimtoli blaze are undergoing treatment in DMCH while eight in CMH.

MONEY LAUNDERING No bar to arrest SQ Chowdhury Says lawyer

The Supreme Court (SC) yesterday stayed for six weeks a High Court (HC) order that directed the law enforcers not to harass or arrest BNP leader Salauddin Qader Chowdhury in a money laundering case.

Chamber judge of the Appellate Division Justice SK Sinha passed the order upon a petition filed by the government against the HC order.

The HC on May 16 directed Salauddin Qader to surrender before the Metropolitan Special Tribunal in Dhaka within eight weeks in the money laundering case and also asked the law enforcers not to harass or arrest him in this case during this eightweek period.

The government recently filed a leave-to-appeal petition with the SC, seeking a stay on the HC order. Additional Attorney

General MK Rahman told The Daily Star that there is no bar to arrest Salauddin Qader in the money laundering case following the chamber judge's order.
