India, Pakistan to hold trust-building talks today

IANS, New Delhi

India and Pakistan are set to kick off a string of back-to-back meetings, starting with talks between their foreign secretaries today that are aimed at bridging post-26/11 trust deficit and exploring ways to revive dialogue between them.

Foreign Secretary Nirupama Rao will fly to Islamabad along with Home Secretary GK Pillai Wednesday for talks with their Pakistani counterparts.

Rao will hold wide-ranging talks with Pakistan's Foreign Secretary Salman Bashir that will cover an entire gamut of bilateral issues, including terrorism, Jammu and Kashmir, confidence-building measures and the Indus water dispute.

All issues are on table, including Jammu and Kashmir, official sources said here ahead of the talks.

From India's point of view, terror will top the agenda.

During delegation-level discussions, India will press for the speedy trial of seven 26/11 terror attacks suspects in Pakistan, concrete action against Hafiz Saeed, the suspected mastermind of the Mumbai carnage, and against those groups based in Pakistan nurturing anti-India agenda.

Ten terrorists had held Mumbai hostage for 60 hours from Nov 26, 2008, killing 166 innocent men, women and children. Rao is also expected to take up a recent spike in cross-border

infiltration and ceasefire violations that are marring the spirit of thaw that followed the summit talks between Prime Minister Manmohan Singh and his Pakistani counterpart Yousaf Raza Gilani in Thimphu nearly two months ago.

Manmohan Singh and Gilani had directed their foreign ministers and foreign secretaries to meet and work out modalities of restoring trust between the two countries.

Signalling India's intention to revive dialogue, official sources said here India was going into these talks in 'an exploratory, not an accusatory way.'

Pakistan releases Bin Laden hunter

An American construction worker, who was detained from Pakistan's Chitral region last week while on a solo mission to find and kill al-Qaeda chief Osama bin Laden, has been released.

Gary Brooks Faulkner, 51, who has been dubbed "Rambo" and the "American Ninja," has left for the United States after being released from custody, the Xinhua news agency reported.

However, there has been no official confirmation about the report.

He was nabbed while trying to sneak into Afghanistan's Nuristan province on June 15 and confessed to be on a personal mission to eliminate bin Laden, who has a 25 million dollar bounty on his head.

According to reports, Faulkner, is said to be suffering from diabetes and various kidney ailments.

Faulkner was arrested with night-vision goggles, a pistol, dagger and 40-inch sword that may have been intended for use on bin Laden.

Since 1981, Faulkner has been arrested at least 10 times on charges ranging from traffic offences to theft and domestic violence, according to the Colorado Bureau of Investigation.

GENERAL'S AIDES' GAFFE

Is Obama dropping 'no drama' style with McChrystal?

An infuriated US president is hauling his top general in Afghanistan to the White House, job hanging in the balance, to explain "what in the world he was thinking" when he and his aides mocked their commander-in-chief and his team.

After reading General Stanley McChrystal's complaints in a Rolling Stone magazine article entitled "The Runaway General," Obama departed from his calm, deliberative style. He wasted little time in ordering him to fly halfway around the world to face the music yesterday. Obama spokesman Robert Gibbs, speaking

more bluntly and emphatically than usual at his daily briefing on Tuesday, said "the magnitude and greatness of the mistake here are profound" and repeatedly declined to say McChrystal's job was safe.

"All options are on the table," he told reporters. Gibbs said he gave Obama a copy of the article on Monday night and the president twice left the White House residence and went to the Oval Office to confer with his advisers.

"He was angry," Gibbs said. How so? a reporter asked. "You would know

it if you saw it," Gibbs said tersely. The public talk of presidential pique raises

strong questions whether McChrystal will be able to save his job.

Obama risks looking weak on insubordination if he lets McChrystal stay, especially with some leading lawmakers calling for the general's head.

But Obama also could be accused of undermining his own Afghan war strategy -- already facing steep obstacles -- if at such a pivotal moment he cuts loose the commander he appointed to implement it. Success or failure in Afghanistan will be a major part of Obama's

foreign policy legacy. "The purpose for calling him here is to see what in the world he was thinking," Gibbs said of McChrystal. He pointedly insisted, however, that the US war effort in Afghanistan was "bigger than one person."

The McChrystal controversy is the last thing Obama needs as he struggles with a devastating BP oil spill in the Gulf of Mexico while dealing with high unemployment and a stuttering economy that threaten his fellow Democrats in November's pivotal congressional elections.

It is also another test of the "No-drama Obama" style he cultivated during the presidential campaign and has instilled as his presidential demeanour.

Obama has been widely criticized for not showing enough anger and emotion over the oil spill, the worst ecological disaster in US history. But he won praise for his uncharacteristic comment that he was looking for an "ass to kick."

McChrystal has apologized for the Rolling Stone article, which quotes his aides calling one top Obama official a "clown" and another a

Afghan leaders voice strong support for McChrystal

Afghan officials said yesterday that firing Gen Stanley McChrystal would disrupt progress in the war and could jeopardize a pivotal security operation under way in Taliban strongholds in the south.

At the end of a one-hour video conference Tuesday night with President Barack Obama, Afghan President Hamid Karzai expressed his confidence in the top Nato commander in Afghanistan, Karzai spokesman Waheed Omarsaid.

McChrystal was summoned to Washington to explain disparaging comments published in Rolling Stone magazine that he and his top aides made about Obama's national security team.

While McChrystal, who was meeting with Obama on Wednesday, was harshly scolded by his superiors in the United States, officials in Afghanistan rallied to his support, saying he had increased cooperation between Afghan and international troops, worked to reduce civilian casualties and gained the trust of the Afghan people.

Lanka concerned over **UN** panel formation on war crime

The Sri Lankan government has expressed its concern over UN secretary general's decision to set up a panel to look into alleged human rights abuses.

There have been several allegations that both the army - and Tamil Tigers rebels who they routed last year - committed crimes at the end of the war.

Ban Ki-moon's spokesman said the three-man panel would advise on how to deal with alleged perpetrators. About 7,000 civilians died in the last five months of the war,

the UN says. Rights groups accuse both sides of war crimes - a claim which

has been denied. Sri Lanka's media minister, Keheliya Rambukwella, told a local news website that the government was "concerned" that Ban Ki-moon, as an outsider, had appointed this panel of human rights advisers, given that Sri Lanka recently announced its own

team looking at reconciliation issues. "We will take appropriate action when it comes to the next stage," the minister said.

Ban's three-member panel is headed by a former attorneygeneral of Indonesia, Marzuki Darusman.

He was part of an international team which was appointed to observe proceedings on a previous Sri Lankan commission on atrocities but which resigned saying that commission did not meet basic minimum standards. The other two members are South African human rights lawyer

Yasmin Sooka and Steven Ratner, a US international law expert.

The BBC's Charles Haviland in Colombo says that the UN's new panel is advisory in nature and is not an investigation commission.

Our correspondent says that the domestic Sri Lankan one, appointed a few weeks ago, also has limited and quite vague terms of reference.

The 37-year conflict ended last year with the defeat of the Tamil Tigers in May 2009. The UN estimates 100,000 people were killed.

India army officer killed in Kashmir clash

A senior Indian army officer has been killed in a gun battle with separatist militants in Indian-administered Kashmir. Colonel Neeraj Sood was

"leading his troops" when he was gunned down by militants in Lolab area, the army said. He is the highest ranking

officer to be killed by militants in Kashmir in 2010. Despite a decline in violence in Kashmir in recent

years, there are fears that militants are trying to regroup in the region. Hundreds of thousands of

Indian troops are based in Kashmir to fight a two decadeold insurgency against Indian A spokesman for the Indian army said the operations

against militants, launched by Col Sood before he was killed is still on in the forested areas of Lolab, north of the capital, Srinagar. It is not clear whether the

militants have suffered any casualties in the clashes.

Taliban 'openly raising funds' in Pak Punjab

A Pakistani intelligence report says militants are publicly raising funds in Punjab province, the BBC has learned. The disclosure comes amid

reports of an increased Taliban presence in this politically important province. The report says at least 17 banned militant groups are

operating in the province under different names. They are raising donations through religious gatherings, certificate award ceremonies

and meetings held in the name of social welfare, it says. Punjab is Pakistan's most populous province and is

home to more than half of the country's 160 million people. It is the country's bread-


basket and houses most of its industry. It also supplies the bulk of personnel to Pakistan's mili-

tary, civil service and political class. In recent years, militants

have carried out dozens of attacks against civil and military targets in Punjab.

Officials blame these attacks mostly on the so-

called "Punjabi Taliban" affiliated with anti-Pakistan Taliban groups based in the country's north-western tribal areas.
