A Dhaka Court yesterday adjourned till September 15 the hearing on charge framing against BNP Chairperson Khaleda Zia, her elder son Tarique Rahman and four others in connection with Zia Orphanage Trust graft case.

Judge (In-charge) AKM Nasiruddin Mahmud of the Special Judge Court-3 passed the order following a time petition on behalf of Khaleda and Tarique.

In the petition, their counsels said Khaleda could not appear before the court, as she was busy with the ongoing parliament session while Tarique was abroad for his treatment.

The four other accused are former BNP lawmaker Kazi Saleemul Haq Kamal, Sharfuddin Ahmed, former principal secretary Dr Kamal Uddin Siddique and former president late Ziaur Rahman's nephew Mominur Rahman.

Of them, Kazi Saleemul Haq could not be present in the court as he went abroad for treatment while Sharfuddin

appeared before it. Dr Kamal Uddin Siddiqui and Mominur Rahman remain absconding since the filing of

the case. The ACC on August 5 last year pressed charges against Khaleda Zia, Tarique Rahman and four others.

RAID ON ABBAS'S HOUSE

Sahara promises action

Home Minister Sahara Khatun has said action will be taken if the Rapid Action Battalion (Rab) engaged in any "unjust and unlawful" act inside the house of BNP leader Mirza Abbas during hartal hours on Sunday.

"I didn't see but Rab and police went to Mirza Abbas' residence to detain him in a case filed against him the previous day," she told reporters replying to a question at the Dhaka Medical College Hospital after visiting two burn patients who were injured during pre-hartal violence on Saturday night.

Rab allegedly ransacked valuables and tortured Abbas' relatives, after entering his residence during the hartal hours on June 27.

Referring to several vehicles in the capital being set on fire allegedly by pro-BNP activists on Saturday night, several hours before enforcing the main opposition BNP's declared countrywide dawn to dusk hartal, the home minister said an inquiry is being carried out in this regard.

"We can find out who was involved in setting those vehicles on fire. Stern action will be taken against the perpetrators," she said.

The home minister also said the government will provide assistance to the injured people.

Faruk Hossain 30, and his friend Sumon, 28, were admitted to the burn unit of DMCH after they received burn injuries when their private car was set on fire by pro-hartal activists near the Maghbazar level crossing at about 8:45pm on Saturday.

When asked whether the BNP's student affairs secretary and lawmaker Shahid Uddin Chowdhury Annie will be released for treatment, Sahara said if his physicians recommend treatment abroad, he might be permitted.

Annie is now undergoing treatment under police guard at United Hospital as he received injuries during a clash between pro-hartal and anti-hartal activists on Sunday.

Earlier the home minister visited the policemen, who were injured during the hartal hours, at Rajarbagh police line at noon.

The Supreme Court (SC) yesterday stayed for six weeks a verdict of the Administrative Appellate Tribunal, halting the reinstatement of 85 upazila election officers, who were appointed during the previous BNP-Jamaat alliance government but terminated during the caretaker government.

The Administrative Appellate Tribunal in its verdict had declared illegal the termination of the election officers.

Chamber Judge of the Appellate Division Justice SK Sinha yesterday issued the stay order following four separate leave-to-appeal petitions filed by the government against the Administrative Appellate Tribunal's verdict.

The judge also sent the petitions to the regular bench of the Appellate Division for a hearing.

Attorney General Mahbubey Alam told The Daily Star that the Election Commission (EC) now cannot reinstate the 85 persons to the posts of upazila election officer until further order of the Appellate Division.

He also said that the caretaker government had legally terminated them since they were appointed on political consideration during the BNP-Jamaat alliance government.
