MARITIME DISPUTES WITH MYANMAR

Dhaka sends documents to int'l court to end disputes

Bangladesh has sent necessary documents to the International Tribunal for the Law of the Sea (ITLOS) for settlement of maritime disputes in the Bay of Bengal with Myanmar.

"We have sent the memorial to the Hamburg-based ITLOS as the deadline for submission is July 1," a foreign ministry high-up said yesterday, preferring anonymity.

Myanmar is due to submit its counter-memorial by December 1, 2010.

According to the United Nations Convention on the Law of the Sea (UNCLOS), any coastal country can have first 12 nautical miles from its baseline as territorial sea, 24 nautical miles as contiguous

zone, and next adjoining 200

nautical miles as exclusive

economic zone. International law says sea boundaries of the states opposite to each other will be delimited as per "equidistance" formula while those of adjacent states through "equitable sharing of the sea"

principle.

It is difficult in cases of Bangladesh, India, and Myanmar, as their coasts follow a curve creating over-

lap of territories. Bangladesh favours a principle based on equity, which creates an area of overlap, while India and Myanmar favours line-based equidistance system to get

bigger maritime areas. Settlement of maritime disputes with Myanmar and India will take a long time because of their nature and complexity, said a source at the UNCLOSWing.

Govt has failed to fulfil promises

Says Shantu Larma

The Awami League government has failed to fulfil any of its promises made to the indigenous community even 18 months after it assumed office, Chairman of Parbatya Chattagram Jana Sanghati Samity (PCJSS) Jyotirindra Bodhipriyo Larma alias Shantu Larma said yesterday. "The Chittagong Hill Tracts (CHT)

peace accord has not yet been implemented. The government has, in fact, made some moves that pose a threat to the lives of Adivais," he said at a discussion, organised by the Jatiya Adivasi Forum, marking the 155th anniversary of the Santal Revolution.

Criticising the role of the CHT Land Commission, he said, "It is trying to conduct a land survey in CHT instead of settling land disputes first, which will

actually benefit the Banglees, not the Adivasis."

Larma, also the chairman of the CHT Regional Council, criticised the two Adivasi ministers in the present cabinet for failing to work for the well-being of their community.

He said State Minister for CHT Affairs Dipankar Talukdar and State Minister for Cultural Affairs Promod Mankin did not make any efforts to include the word 'Adivasi' in the recently passed Ethnic Minority Cultural Organisation Bill-2010.

"The situation that led to the Santal revolution in 1855 still exists. The party in power has changed many times, yet the fate of the indigenous community remains the same," Larma said.

Other speakers at the discussion called on the government to give constitutional recognition to the indigenous people, ensure their right to practise traditional land management and take steps to protect their language.

Terming the indigenous people 'missing population', economist Abul Barkat said, no governments carried out a proper census of indigenous people or made a move to give them constitutional recognition.

"Without ensuring the rights of the Adivais, it won't be possible to achieve the 'Vision-2021' or turn Bangladesh into a welfare state as promised by the AL government," he said.

They were earlier produced before the court on completion of their one-day remand.


Metropolitan Magistrate Rokshana Begum Happy of Dhaka placed Mobin on oneday remand on June 28.



Police picked up BNP leader Mobin and six others from Mohakhali in the city




