## 100 Jamaat-Shibir protesters arrested across districts

Law enforcers yesterday arrested around a hundred leaders and activists of Jamaat-e-Islami and Islami Chhatra Shibir in different areas outside the capital as Jamaat-Shibir men blocked traffic and engaged in unruly activities during their programmes protesting the arrest of three top Jamaat leaders on Tuesday.

Jamaat Ameer (chief) Motiur Rahman Nizami, Secretary General Ali Ahsan Mohammad Mojaheed and Nayeb-e-Ameer Delwar Hossain Saydee were arrested on Tuesday, hours after a Dhaka court issued arrest warrant against them in connection with a case filed for hurting religious sentiment of Muslims.

Our Staff Correspondent reports from Khulna: Police arrested Khulna city Jamaat Ameer Mian Golam Parwar and 21 other Jamaat-Shibir men as they turned violent during their procession on Sir Iqbal Road and lower Jessore Road under Khulna Sadar Police Station.

The Jamaat-Shibir men, who brought out the procession in protest against arrest of three top central leaders of Mojaheed and Saydee, witnesses said. Jamaat, pelted the police with brickbats and damaged a number of roadside

Seriously injured during the incident, OC Munirul Giash, SI Abdur Rahim and constable Shariful Islam were admitted to Khulna General Hospital.

Our Chapainawabganj correspondent reports: Police arrested 12 leaders and activists of Jamaat, including secretary general of its Chapainwabganj pourasava unit Abul Hasan, from different areas of the district on Tuesday night

and Wednesday morning.

"Jamaat men blocked road on Chapainawabagnj-Sonamasjid Highway in Mohananda Bridge area, disrupting road communication late Tuesday night. Two cases were lodged in this connection under the Speedy Trial Act against the 12 Jamaat men," Ahsanul Haque, officer-incharge of Sadar Police Station, said.

Police arrested Chandpur town unit Jamaat Ameer Shahjahan Miah and two other activists on Tuesday midnight when the Jamaat men, led by Shahjahan, brought out a procession in Truck Road area in the town protesting the arrest of their three top leaders, reports our correspondent.

The law enforcers also arrested Golam Mostafa, ameer of Matlab Dakshin upazila unit, following the same allegation on Tuesday night.

Our Brahmanbaria correspondent adds: Five Jamaat-Shibir activists were arrested in Kashba upazila of Brahmanbaria.

The activists brought out a procession from Araibari Madrasa at about 11:00am protesting arrest of Nizami,

As police tried to stop their move, they pelted the law enforcers with brickbats, leaving four police personnel injured. Police lobbed teargas shells and picked up five activists from the spot.

In Jessore, police arrested 12 Shibir men on charge of plotting destructive activities in the town, reports our correspondent.

Officer in charge of Kotwali police station Moazzem Hossain said they were arrested from Shibir controlled messes in Khorki, City College Para, Barandipara and Sheihkrati areas of the town.

#### Villagers suffer as an influential man cuts canal across road for personal purpose

People of several villages in Tirnoi union under Tentulia upazila of Panchagarh district are suffering as an influential person has cut a canal across an earthen path on Haradighi-Roshonpur road to drain away rainwater from his tea garden.

Rashidul Islam Rashid of Roshonpur village cut the canal across Haradighi-Roshonpur road and set a bamboo-made passage over the canal last month, Rabiul Islam, 25, and Razzak, 36, of Roshonpur village told this correspondent during the latter's visit to the area on Saturday. People of Choradangi,

Haradighi, Balabari, Roshonpur and Guabari villages under Tirnoi union are suffering much as they have to use the road to go to other places, said several locals. Following heavy downpour

several days ago, the bamboo structure collapsed and sufferings of people increase manifold.

"We are suffering much as

the road has become impass able due to digging up of an unauthorised canal. Now the people of Balabari and Haradighi villages have to pass additional 10/12 kilometres to go to Tirnoi Bazar. We are also facing difficulties to carry agriculture products," said Fazlur Rahman of Balabari

Chairman of Tirnoi Union Parishad Rafiqul Islam said, "I am yet to be informed of the matter. It is obviously a great offence to dig such a canal across the road." "I am not aware of the

### Bithar's wife elected councillor

Professor Runu Reza was yesterday officially declared elected as councillor of ward no 24 of Khulna City Corporation (KCC) in the byelection held on Tuesday.

According to Returning officer Bibhor Kumar Biswas, Runu Reza, wife of slain ward councillor Shahid Iqbal Bithar, polled 5,177 votes while her nearest rival Shamsher Ali Mintu 3,477 votes. The seat fell vacant after

Shahid Iqbal Bithar was

gunned down by extremists in front of his residence at Mussalmanpara under Khulna Sadar Police Station on the night of July 11 last year. Of the 23,752 voters, 13,206

exercised their right to franchise in the by-election. Seventy-one ballots were cancelled.

Runa Reza said the murder of her husband Bithar, also a central Jubo League member, was a sequel to intra-party feud in Khulna Awami League. She also blamed a group of Khulna AL leaders for preventing police from submitting the chargesheet in the murder case to the court.

SYLHET GRENADE ATTACK CASE

## Date for deposition of PWs deferred

A trial court in Sylhet yesterday could not record deposition of prosecution witnesses (PWs) in the explosive case filed in 2004 in connection with the grenade attack on the then Biritish High Commissioner Anwar Chowdhury on the premises of the mosque attached to the shrine of Hajrat Shahjalal (RA).

Additional District and Sessions Judge Manzurul Haque Khan fixed new date on 26 August this year, as prime

accused Huji chief Mufti Abdul Hannan could not be produced before the judge due to his presence at another court. Four other accused were

produced but none of the prosecution witnesses also turned up, court sources informed. So far, deposition of 23 PWs had been recorded in the case.

Three people--Special

Branch Assistant Sub-Inspector Kamal Uddin, Habibur Rahman Habib and college student Zobayer Ahmed Rubel--were killed while the Bangladeshborn British High Commissioner was hurt along with about 70 others in the

grenade attack after Juma prayers on May 21, 2004 on the

Hazrat Shah Jalal's (R) shrine premises in the city. Two cases--one for killing and the other for explosives-were filed in this connection.

In the muder case, the Sylhet divisional Speedy Trail Tribunal Judge awarded death penalty to Mufti Hannan and two others and life term to two others on 23 December, 2008.

On June 7 of 2007, CID's Senior ASP Munshi Atiqur Rahman filed charge sheets against four people---Mufti Abdul Hannan, his brother Mofizur Rahman and Huji operatives Ripon and Bipul.

Later, CID Inspector Zobayer Ahmed filed supplementary charge sheets in the cases on March 11, 2008 against another Huji operative Abu Zandal.
