102 more Shibir activists arrested in Chittagong

CMP additional commissioner closed

Police yesterday picked up 102 more activists of Islami Chhatra Shibir in overnight raids in the city in connection with the Sunday's violence by Jamaat.

Meanwhile, additional commissioner of Chittagong Metropolitan Police (CMP) was closed Sunday night to the police headquarters for his failure to take measures to contain the violence.

CMP police arrested them hours after the arrest of 41 Jamaat-Shibir men in connection with the vandalism.

The law enforcers also raided Shibir dominated students' messes at the city's Chakbazar and Chandanpur.

Two separate cases were filed with Halishahar and Double Mooring police stations against the Jamaat and Shibir activists for vandalising over 100 vehicles and business establishments demanding the release of their arrested leaders.

Sayedee last week on charges of hurting religious sentiment of the Muslims.

Jamaat-Shibir carried out the destructive agitation in a planned way to create panic, police sources said.

Among the 143 arrestees, 103 were accused in the case filed with Double Mooring Police Station and 16 others in the case filed with Halishahar Police Station.

Double Mooring police produced the arrestees before the court of Metropolitan Magistrate Osman Gani yesterday afternoon seeking five-day remand for each while Halishahar police produced the 16 arrestees before the court seeking 10-day remand for each of them.

The court fixed July 8 for the hearing on remands.

Sources said the Jamaat-Shibir men took advantage of the absence of top CMP officials in carrying out the destruction.

The vandalism took place at a time Police had arrested Jamaat Ameer when CMP Commissioner Motiur Rahman Nizami, its Secretary Moniruzzaman, Deputy Commissioner (Port) Kushum Dewan and Officer-inand Nayeb-e-Ameer Delwar Hossain Charge (OC) of Halishahar Police Station

Humayun Kabir were on leave.

Assistant Commissioner of Double Mooring Police Station SM Tanvir Arafat said police rushed to the spot within fifteen minutes of receiving information about the attack.

Meanwhile, the police headquarters Sunday night closed CMP Additional Police Commissioner Abdul Jalil Mandal.

Jalil, also an additional deputy inspector general, has been asked to report to the headquarters immediately as he went on leave on Sunday without the permission of the commissioner, said

Additional Inspector General of police NBKTripura.

"He left a leave prayer on the table of the commissioner in his absence," the additional IGP said.

CMP Commissioner Moniruzzaman, however, went on leave with the approval of the headquarters.

Assistant Commissioner of Detective Branch of police Jahangir Alam said CMP had received orders from the police headquarters regarding the closure of the additional police commissioner.

Hajee Danesh Science and Technology University (HSTU) was ultimately closed indefinitely yesterday--five days into the incident of violent protests by the students for closing the university on June 29.

University sources said that the decision was taken at an academic council meeting chaired by Vice Chancellor Professor Dr. Afzal

On June 29 the university authority suspended all academic activities till July 8 which triggered students to go on a rampage that night. They went berserk and damaged a number of vehicles and buildings including residence of the VC and confined him for seven hours protesting against the HSTU authority's decision. The police had to use batons and fire tear gas cells to bring the situation under con-

After the incident, on June 30 Professor SM Dr. Harun Ur Rashid filed a case accusing 21 students, of whom 14 could be identified, pressing charges for damaging university property.

Meanwhile, Shamajtantrick Chhatra Front of Dinajpur demanded immediate withdrawal of the case and re-opening of the university.

Sources said the agitators had been protesting since June 22 for penalising 15 students for violating the discipline of the university.

Of them, one was fined Tk6000, nine were temporarily expelled and fined Tk5000 each and five students had their scholarships cancelled.

The students in a letter, urged the HSTU authorities to cancel their decisions but it had no effect.

The following day, the students held a press conference at Dinajpur Press Club and announced tougher programmes to realise their demands and decided to call for a hartal.

On Tuesday morning, the students started boycotting the classes which led the HSTU authority to decide to close the university till July 8 in a bid to mitigate the tension on the campus.

This angered the students who gathered at the administrative building with processions and confined around 12 people including the VC, registrar and lecturers inside the building.

Hajee Danesh tech varsity Govt plans 20-bed burn units in 13 medical colleges

Against the backdrop of increasing fire incidents and serious causalities, the government has planned introduction of burn units in the country's 13 medical colleges and at upazila level.

According to the plan, each of the 13 medical colleges would get a 20bed burn unit. The unit would be equipped with modern equipment and trained physicians to deal with burn patients, official sources said yesterday.

The health authorities are expecting the burn units will help them manage emergency situations like the Nimtoli incident.

"The process is now underway to introduce burn units in all 13 medical colleges to ensure proper treatment of fire victims," Head of Burn and Plastic Surgery Unit of Dhaka Medical College and Hospital (DMCH) Prof M Shahidul Bari said at the conference of Bangladesh Assistant Nurses Association (BANA).

The High Court (HC) yesterday granted anticipatory bail for four months to Dhaka City Corporation (DCC) Mayor Sadeque Hossain Khoka and 12 other officials in a corruption case.

Two die in Gazipur boat capsize Schoolgirl killed in road

Three people, including a schoolgirl, died in two incidents in Kaliganj upazila of Gazipur district on Sunday and yesterday.

A correspondent from Gazipur adds: two people died when a boat capsized in Belai Beel at Bamangaon in Kaliganj upazila on Sunday.

The dead were identified as Faruk Mia, 17, and Makmudul, 8, of Kapasia upazila of the district.

Police said Faruk along with Makmudul was going to his sister's house at Bamangaon by a boat. Suddenly the boat carrying them capsized in the water body in the evening.

Local people rescued them

and took them to the upazila health complex where doctors declared them dead.

In another incident, a schoolgirl was killed in a road accident at Barodi in Kaliganj upazila of the district yester-

The victim was identified as Bristi, 13, a student of class seven of Kaliganj Rayerdia High School and daughter of Bacchu Miah of Talia village of the upazila.

Sources said students of the school in a bus were going to Comilla for a picnic. Around 11:00am, they stopped the bus beside the highway at Barodi of Rupganj for a break.

Paban, others face arrest warrant

A Dhaka court yesterday issued an arrest warrant against Khandaker Abdul Hamid Paban, son of BNP Secretary General Khandaker Delwar Hossain, and former Jatiyatabadi Chhatradal (JCD) president of Chatkhil thana unit in connection with a cracker explosion

The case was filed with Gulshan Police Station against Paban and five others on charge of exploding crackers in front of BNP Chairperson Khaleda Zia's Gulshan office on February 23 this year.

Judge (in charge) Mohammad Ismail Hossain of Dhaka Metropolitan Sessions Judge's Court took the charges into cognisance and issued the arrest warrant.

Paban, an accused in several other criminal cases, and Omar Faruk, who is the former president of JCD's Chatkhil thana unit have been absconding since filing of the case on February

Four other accused -- Golam Sabbir alias Shovon, Syed Hasan Rony and Pradip Saha, secretary of Sonaimuri upazila of JCD and Dakat Babu -- were arrested on different dates, and are now awaiting trial in Dhaka central jail.

The court also directed Bangshal and Chatkhil Police Stations to submit reports on execution of the arrest warrant to it by August

During the investigation, Shovon, Rony and

Pradip Saha had given confessional statements saying that they had exploded cocktails in front of the BNP Chairperson's office as per Paban's direction. In their confessional statements given before the magistrate under section 164 of the

penal code, they said Paban had hired two other young men to carry out a mock bomb attack on himself, in an attempt to earn sympathy of the BNP high-ups. The whole charade was aimed at consolidat-

ing his (Paban's) own position in the party against competing opponents, they told the Detective Branch of police Inspector Mohammad Ziaur Rahman, also the investigation officer (IO) of the case, submitted the
