Pakistan blames militants from Afghanistan for blast

Pakistan's interior minister says Nato and Afghanistan are not doing enough to stop Taliban militants crossing the border from Afghanistan into Pakistan.

Rehman Malik also disputed the widelyheld belief that Pakistani militants are freely heading in the other direction to fight coalition

He told the BBC that he blamed militants coming from Afghanistan for Friday's attack in Mohmand district.

The attack, the deadliest in Pakistan this country. year, killed more than 100 people.

It happened in an area the Pakistani government had recently claimed had been cleared of militants and said was safe for civilians to return to.

Mr Malik says he has intelligence information to prove that the attackers had crossed the border from Afghanistan.

He said he had 'demanded' that the Afghan government and Nato "stop border infiltration". But there is considerable evidence to sug-

gest militants have been heading in the opposite direction relatively freely -- something Mr Malik claims his government has put a stop to. And, of course, the attacks in Pakistan have

been taking place not just in tribal border areas like Mohmand, but right across the

That has caused a great deal of anger among Pakistanis, many of whom believe their government simply does not have the right strategies in place, or the competence, to reduce the threat.

ICC adds genocide to charges against Sudan's president

The International Criminal Court added genocide yesterday to the list of charges against Sudan's President Omar al-Beshir, already wanted for war crimes and crimes against humanity in Darfur.

"There are reasonable grounds to believe that (Omar al-Beshir) acted with specific intent to destroy in part the Fur, Masalit and Zaghawa ethnic groups," said a new warrant issued Monday, listing three genocide charges.

The court in March last year issued a warrant for Beshir's arrest on charges of war crimes and crimes against humanity, its first ever for a

sitting head of state.

It did not include three genocide charges on that warrant as requested by prosecutor Luis Moreno-Ocampo, who appealed its decision.

In February, the ICC's appeals chamber ordered judges to rethink their decision to omit genocide from the warrant, saying they had made an "error in law" by setting the burden of proof too high.

In Monday's decision, the court said there were reasonable grounds to believe that villages and towns targeted by government forces "were selected on the basis of their ethnic composition".

Politicians seek end to killing

Strike in Indian Kashmir

Shops, schools and offices were shut for a second day in Indian Kashmir yesterday as politicians met to discuss how to end weeks of violent and deadly street protests against

security forces. Indian troops have been struggling to control a wave of demonstrations in the Muslimmajority Kashmir valley after being accused of killing 15 civilians -- many of them teenagers -- since the first death of

17-year old on June 11. Authorities lifted a rigid curfew on Sunday across Kashmir after an uneasy calm returned to the major towns, but all activity ground to a halt

after separatists called a strike. In the summer capital of Indian Kashmir, chief minister Omar Abdullah convened a meeting of pro-India local politicians to find a way out of the cycle of protests and disruption.

"The all-parties meeting is underway to discuss the current situation and find ways to end the unrest," an official spokesman in Abdullah's office said.

New Delhi has blamed separatists and militant groups for instigating the protests, which are seen by most people locally as a spontaneous reaction to perceived abuses by security forces, economic stagnation and political deadlock.

How Chowdhury Alam 'abducted'

Asim told The Daily Star.

"They identified themselves as lawmen and slapped me indiscriminately. They took Chowdhury Alam in the private car leaving me on the road", said

He added, "The car was owned by Chowdhury Alam's sister Mamtaj Begum and I am her personal driver."

The next morning he was informed by Alam's driver Jasim that the car was found abandoned in West Tejturibazar, opposite to Wasa building in Karwan Bazar.

Asim said they were on way to Dhanmondi from Khilgaon. As they reached Khamarbari, he chose Indira Road seeing severe congestion on Manik Miah

Avenue, he added.

Sources say Alam was using his sister's car to avoid arrest and he asked the driver to take Indira Road when he sensed that he was being followed.

Alam's son Abu Sayeed Chowdhury claimed his father was being followed by law enforcers as they had made several attempts to pick him up before June 25.

"We filed a case with Sher-e-Bangla Police Station on June 26 in connection with abduction of my father and a general diary with Tejgaon Police Station regarding recovery of the car," he said.

In the case Alam's family mentioned that unidentified people abducted him from Indira Road.

"We suspect law enforcers have picked up my father. But we filed the case accusing unknown people as police refused to record our state-

ment," said Sayeed. Officer-in-Charge of Sher-e-Banglanagar police Reaz Hossain denied the allegation and said they recorded the case according to the family state-

Sayeed also filed a writ with the High Court on July 4 claiming that law enforcers had picked up his father and seeking an order to haul him before the court immediately.
