The arrestees are Mohiuddin Monir alias Munna, 22, Nirjhar Das Samu, 25, Rana Nandi, 25, and Ruhul Nath, 25.



## Tree felling move sparks protest

UNB, Barisal

Move for constructing a road by felling around 15000 trees at Char Kukri-Mukri in Char Fashion upazila of Bhola has created resentment among the people of the district.

Locals observed that the decision to cut down such a large number of trees may endanger lives and properties of more than 20 lakh people of this coastal district during natural disaster.

They have decided to send a letter to the prime minister for saving the trees. Felling of trees will also disrupt the ecological balance of the coastal area,

said local elite.

Fazlul Kader Majnu Molla, Bhola district AL secretary and Sadar upazila chairman said, as all their efforts to save the trees have failed they will now try to draw the attention of the prime minister trict. in this regard.

minutes of journey time may benefit some of the influential people but not the mass people, said Mobasserullah Chowdhury, president of Bhola Sushil Samaj and an environment activist. He urged the authorities to find an alternative to felling the trees.

Local sources said preparations are already at final stage for cutting down about 15,000 trees which were planted under Green Belt Afforestation Programme in coastal area of the dis-

Locals said there is an alternative way Felling of these trees to save few to construct a road on the western side of the area without felling the trees.

Contacted, Range Officer of Char Fashion forest range said that for the construction of the road around 2000 timber plants and 13000 immature other plants are likely to be felled. Value of the trees would be several crores of taka, he added.

#### Dredging of river Passur to start next month

Dredging of the river Passur will begin in the second week of next month.

Government has already allocated Tk 100 crore from the fund of Annual Development Programme (ADP) to modernise Mongla seaport and dredging of the channel, sources said.

The allocation of fund was officially earmarked at a meeting of Ecnec, held on April 23, this year, they said.

Government has given top priority to dredging of River Passur to make it navigable for foreign ships. Because, increase of foreign ships at the port increases revenue earnings from the port, said Md Mahabullah, Director of Mongla Port Authority.

Tenders have already been

invited for carrying out modernisation work of the port. Onder the project, 13 kilometres of Passur River will be dredged so that foreign vessels of 7 to 8 metre draught, laden with goods, can anchor without any problem, he said.

Work of the project is expected to be completed by June 2013, according to Executive Engineer (Civil) of Mongla Port Authority Md. Ali Ahmed.

Dredging from Joimonirghol to Sabur Beacon of the Passur is essential as per a survey report as ships often face problems due to siltation.

Executive Engineer Ali Ahmed, who has been assigned to look after the work as Project Director said 41 lakh 96,000 cubic metres of earth would be dug out and lifted from six points of the river.

#### Schoolgirl, women rescued

A schoolgirl, abducted from Palashbari upazila on Monday, were rescued 12 hours into her abduction from Madergani area in Pirganj upazila.

Police also arrested one of the abductors named Anwar Hossain and brought him to Palashbari Police Station.

Anwar and his two accomplices picked up the class nine student of Kunjamahipur High School from Modhipur village under Palashbari upazila on her way to a coaching center at the village at around 8:00am. Immediately after the

incident, victim's father filed a case with Palashbari Police Station accusing Anwar Hossain, Asadul and Miru Mia of Modhipur village of kidnapping his daughter. Police launched a drive and

rescued the girl from Maderganj in Pirganj upazila at around 8:00pm on Monday. They also arrested Anwar while the rest two fled the scene.

Our Dinajpur correspondent reported that police arrested a gang of three who tried to deceive a college girl in the name of giving a job in Birganj upazila of Dinajpuron Monday.

The arrestees are Md Shukur Ali, 24, son of Afaz Ali, Md Shahin, 22, son of Jamal Uddin, and Shah Jamal, 26, son of Abdul Kader of Laxminarayan village under Debiganj upazila of Panchagarh district.

Police quoted family sources as saying that Dipen Master, 35, of Shatagram village had earlier assured Amina Khatun, daughter of Tahiz Uddin of the same village of giving her a job. On Sunday, Amina met Dipen Master who introduced her to Dalu, 25, of the village.

Dalu took Amina to one Shukur at Dashmailmore under Kaharol upazila the same day. Shukar and two other arrestees took Amina to Aftabganj in Nawabganj upazila in a bus.

Sensing trouble, Amina cried for help at bus Stand. Hearing scream, locals rushed to the spot and rescued her. They also caught the three and handed them over to Nawabganj police.
