Five sued for implicating shrimp trader in false case in Sirajganj

Five people including a district level BNP leader have been sued for implicating a shrimp trader in a false case.

The deputy assistant director (DAD) of Rab-6, Amir Hossain filed the case with Sadar police station accusing the five yesterday.

The accused are district BNP leader and Alipur union chairman Abdur Rouf, his son Abdus Selim, Kabir Hossain Bhutto, son of Abdul Mazed and Enamul Haque, a staff of brick kiln owned by accused Rouf of village Alipur in Sadar upazila and Amirul Islam, son of Miaraj Gazi of village Shakhiur in Debhata upazila.

The complainant alleged that on May 21 night the

accused had planted firearms at the house of shrimp trader Shafiqul Islam who happens to be a local Awami League (AL) leader at village Nathuardanga in Sadar upazila. The accused wanted to implicate Shafiqul in a false arms case, the complainant added.

Earlier, Rab personnel picked up Amirul Islam, Kabir Hossain Bhutto, Nuruzzaman Paltu and Hadiuzzaman Badsha on July 13 suspecting their involvement in the inci-

During interrogation at Rab headquarters in Uttara, Dhaka, Amirul and Bhutto admitted to their involvement with the misdeed saying, they did it at BNP leader Rouf's dictation.

After planting the firearms,

Amirul, Selim and Bhutto informed Rab men who raided Safiqul's house on May 21, the Rab official said.

However, three other accused went into hiding, Sadar police station officer-incharge (OC) Shah Jahan said. "We are trying to arrest them," he said further adding, the two arrestees were brought to Satkhira police station early yesterday.

Mentionable, agitated villagers confined the Rab team in a room for about eight hours following the raid at the house of the innocent shrimp trader on May 21.

As the Rab officials regretted and assured the villagers punishment to the culprits, the villagers freed them on May 22 morning.

Two drug smugglers arrested

Police arrested a drug smuggler along with 45 yaba tablets at Dharmanagar-Tripura frontier in Akhaura upazila on Tuesday.

The arrestee is Fancy Nantu, 33, of Monianda union of the upazila.

of the upazila. Acting on a tipoff, BDR men raided the area and arrested Malek with the sedative drugs.

A case was filed against him under Narcotics Control Act.

Two boys, kidnapped from Manikganj for ransom on Tuesday, were rescued in Tarash upazila on Wednesday.

A gang of three abducted Ariful Islam, 13, son of Abdul Kader, and Abu Huraira, 13, son of Khorshed Alam, of Sanail village under Singrair upazila Tuesday morning.

They took the boys to Mahishluti in Tarash upazila and phoned the victims' families from a phone-fax shop demanding Tk four lakh as ransom.

The phone-fax shop owner informed the police of the matter. Police immediately raided the area and rescued the boys. They also arrested one of the kidnappers named Selim while the rest managed to flee.

The students of Government Saroda Sundori Mohila College staged a demonstration on the campus protesting alleged irregularities of the college authorities and demanding removal of the principal.

Around 300 angry students confined the principal, hostel superintendent, assistant hostel superintendent at the common room of their hostel for two hours on Wednesday night demanding fulfillment of their 10-point demand.

They also gave a 24-hour ultimatum to the college authorities for removal of the principal. On information, Faridpur deputy commissioner (DC) Helaluddin Ahmed and district

administration officials rushed to the spot along with a large contingent of police and freed the teachers from confinement.

The students alleged that a third year student of the Social Welfare department suddenly fell sick on Sunday while watching the FIFA World Cup final match. Instantly, they informed the matter to hostel super Yasin Molla for shifting her to a hospital for treatment. On denial, the students informed the matter to the principal for proper care of the sick girl. But the principal also did not pay heed to their appeal.

Finding no other alternative, they rushed their friend to one hospital to another for treatment. Finally, they succeeded to admit her to Faridpur General Hospital. However, no teacher visited the ailing stu-

dent at the hospital. "Even the principal showed apathy to the sick girl and behaved roughly," the students alleged. Afterwards, the students got united and

placed their 10-point demand to the principal on Wednesday. The demands include proper treatment to the ailing student, improved services at the dining room and canteen, checking visitors'

entry, separate toilets for night guards, 24-hour TV watch, easy exit and entry of students to the hostel etc. As the principal turned down their demands, the students chanted slogans against the college authorities. At this, principal Mahfuzur Rahman along with hostel superintendent Yasin Molla and

assistant hostel superintendent Jalil Munshi invited the students to discuss the matter at the hostel common room. But the agitated students confined them for two hours from 8:30

Following intervention of the DC, the teachers were freed. Later, the DC assured the students to fulfill their demands.
