### Implement DAP, save Dhaka city

**Environmentalists** urge govt

Green activists yesterday demanded immediate arrest and punishment of the alleged individuals responsible for forming propaganda against Dhaka's Detailed Area Plan (DAP) recently published as a gazette.

At a rally in front of the National Press Club, they also insisted on fast implementation of DAP, which was formulated to build a planned city and called for uprooting all land grabbers around the capital.

Green Voice, Juba Nagorik Odhikar Jote and Sheba jointly organised the rally.

"DAP was created to build a planned city but the land grabbers are spreading false rumours creating confusion among people to obstruct its implementation fearing it would end the source of their illegal income," said Mihir

### Commuters suffer for delay in bridge work

Users of the capital's Gulshan-Tejgaon link road have to suffer the hazardous bumpy diversion for one more year, as the construction of a bridge on the route has been delayed further.

It will take until next June to complete the work that the Dhaka City Corporation (DCC) initiated without relocating utility services.

Contractor Abul and Brothers NTL JV started building the bridge last July but the work got stalled till February due to revision of the design.

"We didn't think of relocating the utility services in the beginning because of fund constraint," said Sharifuddin, DCC executive engineer.

"But later it turned out that construction of the bridge would not be possible without relocating those utilities." He attributed the delay also

# UAE lifts ban on manual passports

Bangladeshi workers' hassle ends

The United Arab Emirates (UAE) has started accepting Bangladeshi manual passports again two weeks after imposing a restriction.

"The UAE authorities have started to allow manual passports along with machinereadable passports (MRP) from Sunday [July 11]," said Md Moniruzzaman, Bangladesh's Labour Counsellor in Abu Dhabi.

The country had stopped issuing visas on manual passports and started allowing only MRPs since the last week of June stating two types of passports confusing, said an official of Bangladesh high commission there.

Bangladeshi workers there had to face troubles during the time as the UAE authorities asked them to get MRPs when they went to renew their residence permits.

The recruiting agencies here had expressed concern, as thousands of workers seeking jobs in the UAE would also suffer unless the situation was addressed immediately.

Over such development, Foreign Minister Dipu Moni convened a meeting of 12 manpower-importing countries' envoys in Dhaka on July 4 and asked them to accept both kinds of passport.

### Jamaat trio might be shown held in JMB raid case

Detained Jamaat leaders Motiur Rahman Nizami, Ali Ahsan Muhammad Mojahid and Delwar Hossain Sayedee might soon be shown arrested in a case filed in connection with the recovery of nine grenades from a JMB den in the capital's Kadamtoli area on June 24.

A top official of the Detective Branch (DB) of police said they would seek a court order within a day or two to show the trio arrested in the case based on JMB chief Saidur Rahman's information. According to the official, Saidur said Jamaat and JMB activists

were collecting grenades and other explosives for subversive operations across the country to foil the trial process of war criminals. "Saidur also said that Jamaat had provided financial support

and other assistance for the destructive operations to keep the

government and law enforcers busy with something else rather than the war crime trial," added the official. Meanwhile, DB police yesterday brought detained acting JMB chief Bhagne Shahid from Bogra and the banned outfit's

North Bengal chief Shafiqul Islam alias Jamai Rafiq from Gaibandha to the capital to interrogate them face-to-face with Saidur. Sources said DB has already started interrogation to verify

Jamaat's involvement in planning destructive operations.

## Kabir confesses killing Menoka

MURDER FOLLOW-UP

The youth who stabbed the Eden College student Menoka to death in the capital on Thursday confessed the murder before a Dhaka court yesterday saying he did it because the girl cheated on him, police said.

Meanwhile, police checked out the call lists of cell phones of the victim Mohsina Rabbani Menoka and accused Tariquzzaman Kabir, and SMSs [short message service] exchanged between them.



Checking the messages and call lists, Sub-inspector (SI) Abu Bakar of Mirpur Police Station said, "It appeared to us that there was an emotional attachment between Menoka and Kabir."

However, Menoka's family members turned down the police

assumption and Kabir's statement that there was an affair between the victim and Kabir. Lutfor Rabbani Badal, father of the victim told reporters that

Kabir has made up the story of an emotional relationship with

his daughter fearing punishment for the murder.

Kabir stabbed Menoka to death entering her living room at Moddhya Paikpara in Mirpur on Thursday afternoon. Police arrested Kabir from there as he had refused to open the door, and **SEE PAGE 15 COL 3**
