## HC warns against custodial deaths

Says no mercy for such incident, asks DMP to report its actions by Aug 3

The High Court yesterday issued a stern warning to the government that it must take legal action against policemen involved in custodial deaths after investigating the cases with nonpolice personnel. This court will deal with everyone involved

in custodial deaths with an iron fist without mercy and compassion, said an HC bench, adding that police must forget the idea that they are immune to prosecution.

Those days are over and the police must realise this reality, it commented in the presence of a number of police personnel who appeared before the bench yesterday in connection with three incidents of death in police custody.

The HC bench of Justice AHM Shamsuddin Chowdhury Manik and Justice Md Zakir Hossain came up with the observations during the hearing of a writ petition earlier filed by Human Rights and Peace for Bangladesh and Bangladesh Human Rights Foundation.

The two groups filed the public interest litigation on July 5 seeking directives of the HC on the authorities concerned to stop incidents of death in custody.

Officer-in-Charge of Gulshan Police Station Kamal Uddin, OC of Darussalam Police Station Mujibur Rahman along with sub-inspectors Anisur Rahman, Masudur Rahman, Hekmot ullah, Moshiur Rahman and assistant subinspector Sayed appeared before the court following its earlier order to explain the three custodial deaths in the capital.

The bench yesterday said police personnel found involved in such incidents must be suspended immediately.

"We will not spare any policeman whether he is the inspector general of police or an ordinary police constable on the road," Justice Manik said, adding that incidents of death in custody must be stopped.

The judge also said the process of impeccable investigation into the deaths must go ahead.

Cabinet okays draft law

The cabinet yesterday approved the draft of the **Environment Court Act 2010** that provides for five years' imprisonment or a fine of Tk 5 lakh or both for environment polluters.

The proposed act also provides for setting up environment courts in all districts to prevent environmental pollution, Prime Minister's Press Secretary Abul Kalam

Azad told journalists. The draft was approved at the weekly cabinet meeting held at the Secretariat with Prime Minister Sheikh Hasina in the chair.

Azad said the new law is being enacted to ensure stern action against environment polluters.

# AL asks BNP to send name of party rep

Ruling Awami League has requested Opposition Leader Khaleda Zia to nominate a BNP lawmaker for a high-powered all-party parliamentary committee to be formed by Thursday to amend the country's constitution.

"We've requested to send the name of the opposition nominee by July 20, so the committee can be formed in the current session of the parliament," Treasury Bench Chief Whip Abdus Shahid told The Daily Star yesterday. Shahid sent a letter to Khaleda on Sunday

night, seeking the name by today as the parliament's current session is scheduled to be prorogued on Thursday.

Opposition Chief Whip Zainul Abdin

Farroque told reporters yesterday that they received the letter, and BNP will decide on the matter on consultation with its chief Khaleda

BNP Chairperson Khaleda Zia started

exchanging views with party senior leaders on the issue late last night. As of filing of this report at 1:00am today, the meeting was still going on at the BNP chairperson's Gulshan office. The opposition will also hold a meeting with

different professional bodies and like-minded political parties today to discuss the issue, party insiders said.

BNP however already alleged that the government's move to amend the constitution has an "ulterior motive".

#### Tough law for telcos passed Fine raised to Tk 300cr

The parliament yesterday passed a bill making the provisions of telecom law tough to punish telecom operators and other ICT-based companies for specific wrongdoings with an increase of fine up to Tk 300 crore from Tk 10 lakh.

During passage of the bill the House also accepted recommendation made by the parliamentary standing committee on post and telecommunications for formation of a three-member appeal board led by a retired High Court judge.

### No bar to sending cases filed for crimes in '71

Reviewing cases filed against Jamaat-e-Islami leaders with different police stations in connection with crimes in 1971, the home ministry yesterday found no legal bar to sending the cases to the International Crimes Tribunal for trial.

# 62 dead in Indian train crash

At least 62 people were killed and over 92 were wounded when an express train rammed into the rear of another train waiting at Sainthia station of West Bengal yesterday.

A statement issued by Eastern Railway, headquartered in Kolkata, put the death toll at 62 and the number of injured at more than 92. Among the dead were 39 men, eight

women and two children, railway officials

said. The accident took place yesterday, at around local time 2:00am (20:30GMT Sunday), when Siliguri-bound Uttar Banga Express running at a high speed apparently overshot the signal and came on the same track crashing into the stationary

Bhagalpur-Ranchi Vananchal Express at the station in the Birbhum district, about 200km from Kolkata, railway officials said.

The impact of the collision was so severe that the roof and the sides of two compartments of Vananchal Express were reduced to a heap of mangled metals, and the main section of one train carriage had been flung over an overhanging railway footbridge. Rescue workers had to cut their way into

the mangled wreckage to rescue the passengers. Emergency officials said all the passen-

gers trapped in the wreckage were rescued and all the injured were taken to hospitals.

Hospital sources said from among the 92 injured, 35 were in critical condition.

Driver MC Dey and assistant driver NK Mandal of the Uttarbanga Express and guard A Mukherjee of Vananchal Express

were among the dead, the statement said. Railway Minister Mamata Banerjee appeared to raise doubts whether it was a sheer accident. "We have so many doubts

in our mind. Whatever has happened is not casual," she told reporters before leaving for the spot. "We are still finding out the details and

we will take all necessary steps and action and find out who is behind this calamity," Banerjee said.

There is speculation that faulty signalling may have been the cause of the crash. A

police investigation is now under way. This was the second major railway accident in West Bengal this year.

In May, nearly 150 people died when a Mumbai-bound Jnaneshwari Express train derailed and was hit by a goods train. Police **SEE PAGE 15 COL 3** 

# Probe finds lapses in BG Press security

#### Staff recruited without police verification

The probe committee formed by the Bangladesh Government (BG) Press authorities found security flaws and neglect in frisking employees as reasons behind the recent question leak.

The probe committee also found that the employees in the restricted section did not have police verification before appointment.

Even though the policy "Restricted Section Operation, 2000" states that employees can only be appointed to the section after being verified by the police, it was not followed, said

highly placed sources. These employees had their police verification done when they were appointed to the BG Press, they said.

The committee would recommend reforming and modernising the press by installing new equipment and ensuring tight security measures, say highly placed sources.

Formed on July 9 after the leak of questions for now-cancelled assistant teacher recruitment examinations for public high schools, the committee is likely to submit its report to the directorate of printing and publishing today, said Abul Kashem, head of the committee.
