BSF kills Bangladeshi

Indian Border Security Force (BSF) on Tuesday shot dead a Bangladeshi cattle trader on Haldia border in Gosaba police station in India opposite to Kalinchi border in Shyamnagar upazila, said a source across the border yesterday. The victim was identified as Amjad Hossain, 35, son of Mandar Gazi of the village. The BSF men of Haldia camp opened fire on the cattle traders while they were crossing the river Bidyasagar with cattleheads by a trawler. Amjad Hossain died on the spot at about 9:30pm. Other cattle traders -- Israfil, Mikail and Nimai Chandra of the same village however escaped unhurt as they jumped into the river and reached Haldia village by swimming.

Trafficker held, 3 rescued

Members of Bangladesh Rifles (BDR) in a drive rescued three people while being trafficked to India and arrested one person at Sadipur border here on Friday. The rescued victims were identified as Rita Das, 32, wife of Subod Das, Sraboni Das, 14, of Khulna Khalishpur area and Boloy Bala, son of Sushil Kumar Bala of Gopalganj district. The arrested trafficker was identified as Bikash Pal, son of Mintu Pal, resident of Bahadurpur Road in Benapole. Acting on a tip-off, a team of BDR led by Subeder Humayun Kabir raided the area and arrested Bikash Pal while he was trying to cross the border along with three others, alluring them to give better job in India. Later, the border guards handed them over to Benapole port police. A case was also filed in this connection.

BRAC official shot, looted

Muggers shot and wounded a BRAC official and took away Tk 14,000 from him at Chamtia on Gouripur road in Lalpur upazila yesterday noon. Witnesses and police said Abdul Majid, collecting the money from Mahishakhola area, was returning on his by-cycle to Gopalpur BRAC office at Lalpur. On way at Chamtia, the muggers intercepted him at about 2:30pm. As he cried for help, the gang fired gunshots leaving him badly wounded and then decamped with the money. Locals rescued him and rushed to the Rajshahi Medical College Hospital in a serious condition.

14 statues recovered

A team of Bangladesh Rifles (BDR) seized 14 statues and Indian clothes worth around Tk 5 lakh from Sadipur border in Benapole, Jessore on Wednesday. Tipped off, a BDR team led by check post commander Humayun Kabir raided Sadipur village and recovered 14 silver statues and Indian saris, three pieces and T-shirts in abandoned condition. The recovered items were handed over to the Benapole Customs House. None was arrested in this connection, said the check post commander.

SCF HUMAN CHAINS, RALLIES IN DISTRICTS

'Arrest war criminals, men held with hold speedy trial'

Sector Commanders' Forum (SCF) yesterday formed human chains and held rallies in several districts across the country to press home its demand for speedy trial of the war criminals.

The forum urged the government to arrest the identified war criminals as early as possible and try them for committing crimes against humanity during the country's liberation war.

In Sylhet, the forum arranged a human chain programme in front of the Central Shaheed Minar in the afternoon. Members of the different political, professional and socio-cultural organisations joined the programme, reports our staff correspondent.

Addressing a rally at the venue, Colonel (retired) SIM Nurunnabi, member of the Sector Commanders' Forum, said the process of trial of the war criminals was stopped after assassination of the

father of the nation. We demanded that the present government start the trial as soon as possible since it was one of its election pledges, he added.

Chaired by former lawmaker Enamul Haque Chowdhury, the rally was also addressed, among others, by former lawmakers Muhammad Ashraf Ali and Shah Azizur Rahman.

The speakers said the crimes the war criminals committed are unprecedented in the history and that they should be tried on the soil of this land. "It isn't a matter of hostility or avenge. They should be tried for their inhuman crimes," they added.

They urged the new generation to know the true history of the country's liberation war and uphold the national culture and heri-

According to a correspondent from Barisal, local coordination committee of Sector Commanders' Forum formed a human chain and then held a rally in front of Ashwini Kumar Hall in the human chain, brought out a morning.

The rally was addressed by Maj Gen (retd) M Masudur Rahman, organising secretary of SCF, Akkas Hossain, Mokhlesur Rahman, Moshiur Rahman, Zaglul Haidar Shahin and local leaders of SCF and Muktijoddha Sangsad with Sheikh Kutubuddin in the chair.

This invitation for prequalification follows the general procurement notice for this project that appeared in UN Development Business on-line and in dgMarket on December 09, 2009

The People's Republic of Bangladesh has applied for a credit from the World Bank (WB), Japan International Cooperation Agency (JICA), Asian Development Bank (ADB), Islamic Development Bank (IDB), and other partners to finance the proposed Padma Multipurpose Bridge Project, Bangladesh intends to apply part of the proceeds of from the World Bank Credit and credits/loans from other partners for payments under the contract for the River Training Works. The Bangladesh Bridge Authority intends to prequalify contractors and/or firms for construction of the River Training Works. It is expected that invitations for bid will be made in October 2010.


The Padma Multipurpose Bridge Project includes a new two level road cum rail bridge across the Padma River, plus extensive river training works on both sides of the river, approximately 2 km length along the North bank and approximately 12 km length along the South Bank. The river training works involve substantial dredging (approx 50 million m³), major underwater revetment works (approx 2.6 million m²), and rock placement (up to 6 million tonnes). These river training works are included in this proposed "River Training Works" contract.

Prequalification will be conducted through prequalification procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, May 2004 revised October 2006, and is open to all bidders from eligible source countries, as defined in the guidelines.

Interested eligible applicants may obtain further information from, and inspect the prequalification document at, the Bangladesh Bridge Authority (address below) from 0900 to 1700 hours on Sunday to Thursday. A complete set of the prequalification document in English may be purchased by interested applicants on the submission of a written application to the address below and upon payment of a nonrefundable fee of Bangladesh Taka 10,000 or US\$ 150. The method of payment will be by cash or Bank draft in favor of Executive Engineer, Padma Multipurpose Bridge Project. The document will be sent by courier or collected from the office below.
