#### BHASANI UNIVERSITY Students want renaming of degree

Students of three departments of Maolana Bhasani University of Science and Technology (MBUST) continued agitation demanding BSc Engineering degree in place of BSc Honours degree.

Around 250 students of Biotechnology and Genetic Engineering (BGE)
Department of the university formed a human chain on the

campus yesterday morning. Later, they held a press conference at Tangail Press Club where Mohammad Naimuddin, a fourth year second semester student of the department, read out their demand.

Biswajit Chandra De, another student of the BGE department, told the journalists that they are lagging behind in the race for jobs due to lack of BSc Engineering degree despite having higher education in the same subject.

"We have been boycotting our all classes and examinations since July 20 last. We also have submitted a memorandum to the university authorities to press our demand", he

Although a meeting was held between the teachers and students of the department on July 24 but it ended without any decision, he added.

Pro-vice chancellor Prof Moniruzzaman, proctor Omar Farugue and the department teachers held a meeting in face of agitation by the students of the Food Technology and Nutritional Science (FTNS) Department on July 17, campus sources said.

As the university authorities did not give any specific timeframe to meet the demand, the students of the FTNS department continued their movement including boycott of classes.

In this situation, the uni versity authorities on July 18 banned all kinds of programmes like procession, rally and human chain on the

campus. Later on July 19, the pro vice-chancellor, the registrar and the proctor held a meeting with the teachers and students of the department again and assured the agitators of meeting the demand.

The students o Environmental Science and Resource Management (ESRM) Department also held a view exchange meeting with the teachers of the department and submitted a memorandum containing the same demand to the university authorities on July 24.

## Land dispute: 3 killed, 30 injured in 4 districts

At least three people were killed and 30 others injured in clashes over disputed lands in four districts yesterday.

In Panchagarh, one person was killed and seven others were injured in a clash at Jaigirjoth village under Tentulia upazila over control of a piece of disputed land, reports our Thakurgaon correspondent.

Officer in Charge (OC) of Tentulia police station Abu Bakkar Siddik told this correspondent that at about 7:30am yesterday Tomizuddin and other 8/10 people including his brothers were planting aman saplings in a field at the same village. All of a sudden Zakir

Hossain of the same village along with 25/30 hired musclemen attacked them for taking control of the land leaving Auhidul Haque, 30, son of late Bishu Mohammad dead on the spot and seven others injured.

Injured Tamizuddin, 35, Shirajul Islam, 45, Saidur Rahaman, 40, Hamida Begum, 40, Shahina Khatun, 25, Tahera Khatun, 34 and Shujan, 40 were admitted to Tentuilia

Later, Motaz Ali and his son attacked Dilbar and wounded him badly. After a while the Police and locals said, there villagers divided into two groups over the incident and attacked each other with sharp weapons leaving at least seven people injured.

Of them, Motiar died at Rangpur Medical College Hospital.

In Benapole, Jessore, at least seven people were injured in a clash between two rival groups over land dispute at Dighirpar village yesterday morning, reports a correspon-

The injured are Ashanur Rahman, 25, son of Nazrul Islam, Al Amin, 24, son of Babar Ali, Maleka Begum, 60, wife of Abdus Sattar, their sons Hafizur Rahman, 26, and Mofizur Rahman, 26, Bulbul, 30, son of Habibur Rahman, and Babar Ali, 45, son of Kudrat.

Witnesses said an altercation took place in the morning when Ashanur Rahman along with his men went to his maternal uncle Babar Ali's house to take possession of a disputed land.

Later, their supporters equipped with lethal weapons and sticks attacked each other, leaving seven people injured from both sides.

### Vet university students' ultimatum

Chhatra League (BCL) and General Students Forum at Chittagong Veterinary and Animal Science University (CVASU) jointly gave a 20-day ultimatum to the authorities to remove vice-chancellor Dr Nitish Chandra Debnath.

The BCL and Forum leaders were holding a press conference at Chittagong Press Club yesterday.

Terming the VC as a controversial, incompetent and loyal to 4-party alliance, they demanded his removal by August 15. Otherwise, they threatened to enforce an indefinite and tough agititation programme paralysing the campus from the next day.

At the press conference the leaders also announced holding of demonstration including procession and rally on the campus today. They will submit a memorandum to education minister on Thursday (July 29).

They said the education adviser during his visit to the university on April 10 assured the students of removing the VC. But, no step was taken in this regard even after three months which prompted them to go for fresh agitation programme.

Kamal Kanti Majumder, convener of Bangladesh Chhatra League (BCL) and Chittagong General Students Forum, CVASU, read out the written statement at the press conference.

#### Brac official injured by muggers, dies

A BRAC official who was shot and injured by a gang of muggers at Gopalpur in Lalpur upazila on Saturday died at Rajshahi Medical College and Hospital on Sunday night.

On July 24, when BRAC staff Abdul Majid was returning to his office at Gopalpur in a bicycle after collecting money, muggers intercepted him at Chamtia on Lalpur-Gouripur road and took away Tk 14,000.

As he tried to resist the muggers they fired gunshots, leaving him critically injured.




