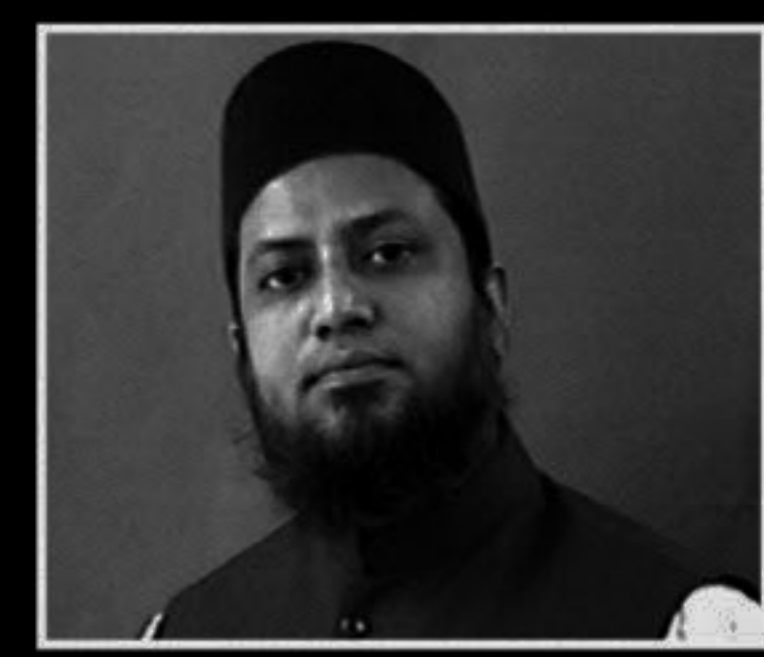



Discharge and Delivery Surveys for Commodities

Save the Children-USA (SC-USA), a non-governmental entity registered with US Government, is seeking a survey company for future discharge and delivery surveys for commodities to be received in Bangladesh from the United States Government under the PL 480 Title II for a Multi Year Assistance Program (MYAP) entitled, "Nobo Jibon". The Statement of Work (SOW) which provides guidelines concerning content and explains SC USA's expectations for the product provided by the surveyor is available at the Save the Children Office. The SOW is an integral part of the contract that SC-USA will sign with successful bidder. The purposes of the contract are to: a) provide monitoring services for SC-USA's food aid cargoes (bulk, bulk with bags, break-bulk and containerized) that will be discharged and delivered at different locations in Bangladesh; b) conduct cargo discharge surveys for SC-USA for determining cargo loss and damage claims against ocean carriers. The main requirement is to report discharge and delivery results by ocean Bill of Lading number. It is also expected that the surveyor will coordinate and liaise with the vessel agents and the receivers or receivers' agents in performance of the contracts. In general, SC-USA is seeking experienced surveyors who:

- Attend the discharge and, if necessary, be present at delivery locations after communicating with the vessel, vessel's agent, receiver, and receiver's agent.
- Attend and monitor the discharge of the cargo from the vessel and, if the cargo is shipped on a through Bill of Lading, attend and monitor the delivery of the cargo at the inland delivery location.
- Provide a detailed, thorough, well-documented survey report addressing each of the specifications required for the type of shipment involved.
- Provide a level of customer service satisfactory to SC-USA.

SC-USA is inviting sealed bids in Bangladesh Taka from the bidders to conduct this survey work subject to fulfilling and adherence to the following conditions.

**Conditions:**

- The tender shall cover shipments that are scheduled to commence discharge or delivery from the date of the contract signed through December 31, 2011, subject to extension / amendment.
- The surveyor must be available on short notice for the above-mentioned shipment. Given the nature of food aid shipments, the surveyor may need to attend at different discharge and/or delivery locations at the same time.
- The scope of the contract for bulk discharge surveys shall include attendance and monitoring at any lightening operations. Any lightening operation shall include a draft survey (load and light draft survey) of the mother ship and any lighter vessels.
- For through Bill of Lading shipments of bulk, bulk with bags, and break-bulk cargoes, the surveyor shall attend, monitor, and report on the loading of the cargo onto land or river conveyances at the discharge port for movement inland/in-country.
- The surveyor shall provide an original and two copies of the survey report to SC-USA. The survey report should have a printed name and signature by the actual surveyor whenever possible. All documentation (including the survey report) shall either be in English or accompanied by an English translation.
- SC-USA reserves the right to accept/reject any or all bids under the tender without assigning any reason whatsoever.
