Says CWCS study

A recent study identifies poverty as the major cause behind trafficking of women and children in the country.

Centre for Women and Children Studies (CWCS) conducted the study in 38 districts identifying Jessore and Satkhira as the most frequently used lands routes for trafficking witht 64 percent of the victims being females aged between 13 and 17 years.

Jessore, Satkhira, Mymensingh and Dhaka are the major source areas, while there are as many as 20 transit districts bordering India used for trafficking women and children, the study mentions.

Sharing the study at Brac Centre yesterday Prof Ishrat Shamim, president of CWCS said, poverty caused by natural and man-made disasters is one of the key factors behind the rise of trafficking. Both external and internal trafficking are presently at large.

Apart from poverty other reasons

and children include, child marriage and domestic violence, she said.

Promises of better jobs, marriage, deception through love affair, legal or illegal migration channels, selling of young women by step-parents, relatives or husbands and kidnapping are the main modes of procuring victims for trafficking.

The victims are then traded for prostitution, domestic work, forced marriage, pornography, sex tourism and organ trade. Forced labour is also becoming a prominent factor these days, she added.

The victims run the risk of various health-related problems including unwanted pregnancy, drug addiction, vulnerability to STDs and HIV/AIDS, the study mentions.

The ones experiencing different forms of physical brutality are also susceptible to psychological trauma, mental disorder or depression leading to suicide.

Addressing the launching cerethat increase vulnerability of women mony, Dr. Shirin Sharmin Bangladesh Police also spoke.

Chowdhury, state minister for Women and Children's Affairs said, the government has planned to review existing laws related to trafficking to suit them to the current situation. Regional and international cooperation is vital, as no country can combat trafficking single-handedly, she mentioned.

Advocate Salma Ali, executive director of Bangladesh National Women Lawyers Association (BNWLA) said, Bangladesh signed and ratified many conventions that provide guidelines on rescue and repatriation. However, those guidelines were not incorporated into the laws of the country, she observed.

Among others, Shireen Hasan, executive director of CWCS, Olatz Landa, co-ordinator Asia Unit, ANESVAD Foundation, Dr. Ubaidur Rob, country director, Population Council, and N B K Tripura, NDC, Additional Inspector General,

Husband kills wife over trifling matter

A quarrel between 19-year-old housewife Konika Akhter and her husband Ali Hossain over a trifle matter led to her killing at their Khilgaon home on Monday, disclosed detained Saudi expatriate Ali Hossain.

Ali Hossain, who was arrested by Rapid Action Battalion (Rab) personnel at South Keraniganj on Wednesday night, told Rab that they woke up late in the night as their one-year-old child was crying.

They locked into quarrel over pacifying the child and at one stage Konika slapped him on the face, he said, adding that it enraged him and he pressed her throat with both of his hands for minutes, which name. caused her death.

The victim Konika Akhter, verifying the information.

wife of Ali Hossain, 35, lived on the ground floor of a fivestorey building at Goran in the city's Khilgaon area. She was found dead in her bedroom around 11:30am on Monday.

Senior Assistant Superintendent of Police Mohammad Jahangir Alam told The Daily Star that following the incident Ali left his child with his mother-in-law and fled to his relative's house at South Keraniganj.

Ali told reporters that during his stay in Saudi Arabia, he sent money to his wife but she could not give him the correct account of her expenditure.

FIFTH AMENDMENT

Call to implement SC verdict

Communist Party of Bangladesh (CPB) and Bangladesher Samajtantrik Dal (BSD) yesterday hailed the Supreme Court's verdict that declared the Fifth Amendment of the constitution illegal said a press release.

CPB organised a discussion at National Press Club with the party President Manjurul Ahsan Khan in the chair.

CPB and BSD called upon the government to implement the verdict as early as possible and run the country imbued with the spirit of

liberation war. The SC released the full text (184 pages) of its judgment on Tuesday, around six

months after it upheld the

High Court verdict declaring the Fifth Amendment illegal.

"The parliament now should take steps to ensure the rights of indigenous people, increase of women seats and vote,' they said.

They also stressed speeding up the trial of war criminals as it is connected to the revival of the spirit of liberation war.

In a statement, BSD General Secretary Khalequzzaman hoped that the revision of the constitution by the all-party parliamentary committee would be impartial.

Law, Justice and Parliamentary Affairs Minister Barrister Shafique Ahmed and CPB General Secretary Mujahidul Islam Selim spoke at the meeting.
