### Dodgy doctors warned

PM vows stern action for skipping duties in rural hospitals

UNB, Dhaka

Prime Minister Sheikh Hasina yesterday sounded tough warning that the government will take stern action against the doctors who will not attend duties at the rural hospitals regularly.

"I request you to attend your respective hospitals regularly in the rural areas... if you don't do your duties properly, stern action will be taken," she said while inaugurating the World Breastfeeding Week-2010 at the city's Bangabandhu International Conference Centre in the morning.

This year the Breastfeeding Week is being observed with the theme: Breastfeeding Just 10 Steps, the Baby-Friendly Way!

"We all get salaries from the taxes paid by the mass people. None has the right to ignore the common people's rights," the premier said.

She asked the physicians not attending offices in the remote areas regularly to ask their own conscience whether they are doing the right thing. "It is the official and moral duty of all to serve the interests of

## Commission trade traps patients

Patients in the country are increasingly becoming captive of an unholy nexus of doctors and diagnostic centres driven by unethical greed.

It has become a common knowledge in the society that doctors tend to prescribe unnecessary medical tests for their patients in exchange for commissions from diagnostic centres, driving up the cost of treatment.

There are 7,623 authorised private diagnostic centres in the country, 780 of which are in the capital, according to the Directorate General of Health Services (DGHS). Some doctors admitted to The Daily Star that the practice

does exist, and doctors get 10 to 30 percent commission from each test they suggest. "Usually, renowned diagnostic centres offer low commission.

But less popular centres pay more, as they need promotion and doctors' attention," said a cancer specialist of Bangabandhu Sheikh Mujibur Rahman Medical University.

"If an x-ray costs 300 taka, the doctor gets 120 taka just for

referring the patient to a particular diagnostic centre," said **SEE PAGE 15 COL 4** 



### Tribunal hears war crimes of Sayedee

Decides to pass order in his Aug 10 presence

The International Crimes Tribunal yesterday directed the prisons authority to produce detained Jamaat-e-Islami Nayeb-e-Ameer Delwar Hossain Sayedee before it on August 10.

The order came after the hearing on a complaint case (information obtained by an investigating agency) from the prosecution that alleged that Sayedee committed war crimes, genocide, crimes against humanity and peace during the Liberation War of

Bangladesh in 1971.

Sayedee is the fifth person against whom the prosecution placed allegations before the tribunal of committing offences under International Crimes Tribunal Act, 1973.

Describing the allegations against Sayedee: tried. alias Delu, Syed Rezaur Rahman, on behalf of : the seven-member prosecution team led by . Chief Prosecutor Ghulam Arieff Tipoo, prayed : crimes during the 1971 before the tribunal to issue arrest warrant against Sayedee.

## 334 NGOs shut in four months

#### Corruption, misuse of foreign funds, patronisation of militancy alleged

The government cancelled registration of 334 non-government organisations (NGOs) in the last four months for their involvement in corruption, misuse of foreign funds and patronisation of militancy.

a stringent drive to clean up the sector and seized moveable and non-moveable property of these organisations, which were operating in the name of social welfare, charity and volunteerism.

The move is significant as NGOAB had cancelled only 56 foreign-funded NGOs in the last two decades since 1990.

The bureau cancelled the registration in April, May, June, July and August-2, after a

series of probes into violation of rules and laws to run foreign-funded projects in the country.

An official at the NGOAB told The Daily Star, "We could not give you details of the cause of cancelling the NGOs' registration as the offences vary from organisation to organisa-

Speaking anonymously, an NGOAB director said some organisations were supposed to run their activities in orphanages and religious places. But the intelligence agencies and NGOAB investigators did not find any such activities and feared that those NGOs were involved in militant activities.

The director added some NGOs were also involved in various kinds of corruption including recruitment of consultants and higher

### Baby killed Mother arrested, police tell

of extra-marital affair

Khilgaon police yesterday arrested a woman from the capital's Sipahibagh area allegedly for killing her only daughter in association with her paramour and hiding the body.

They recovered the decomposed body of three and a halfyear-old Jennifer Islam Tanha from a sun shed on the 3rd floor of a five-storey building where the victim's mother Halima Yasmin Toma, 24, started living with one Rajib.

Rajib, an employee of a Chinese restaurant at Segunbagicha, is now on the run. In police custody, Toma told

The Daily Star that on July 29, Rajib gave her syrup as she complained of headache. After taking it she fell unconscious. The next morning when she gained consciousness she found Tanha

missing and Rajib gone. Toma said she had left her husband Faruk Gazi, a grocer at Mirpur-11, and moved in a flat with Rajib on July 27. She brought Tanha along with seven tolas of gold ornaments and Tk 1.5 lakh with her while leaving her husband.
