113 killed in Kashmir floods

At least 113 people were killed and 370 were injured when flash floods triggered by torrential rains struck Leh town of Jammu and Kashmir state early yesterday.

"We have recovered 103 bodies so far and about 370 are injured. The number of missing could not be ascertained as yet," State Police Chief Kuldeep Khoda said yesterday.

However, in a late-night upgrade AFP reported that the death toll has risen up to 113. Khoda said the toll was likely to go up with

dozens of people reported still missing. Flash floods and rains hit the town of Leh and the adjoining villages at around 2:00am local time. Various buildings and mud-houses in old

Leh town were wiped out by the overnight floods. Telephone towers and government buildings also got washed away.

The district hospital and the main bus station were flattened by mudslides and floods, and vehicles were seen floating in the town. Leh airport got disrupted for sometime

yesterday and was made operational again by afternoon to facilitate landing of aircraft carrying relief material and rescue teams.

carried out by the state police, paramilitary forces and the army in Leh town. Home Minister P Chidambaram said over 6,000 security personnel have been deployed in

Leh to carry out rescue and relief work. The overnight floods, prompted by intense

cloudbursts, left a trail of death and destruction in Leh that lies at an altitude of some 3,500 metres (11,500 feet) above sea level.

While many villages like Sabu, Phyang, Nimoo and Choglamsar were affected, the city

bore the maximum brunt of the calamity. The dead included three Army Supplies

Corps jawans and three Jammu and Kashmir Armed Police (JKAP) constables.

Prime Minister Manmohan Singh announced an ex-gratia relief of Rs 1 lakh each to the families of the deceased.

AFP adds, Tourism Minister Nawang Rigzin Jora described the Leh flood incident as "unprecedented" devastation. "Flash flood and mudslides caught people

unawares during the night and washed away their homes," he added. Reuters adds, Buddhist-dominated Ladakh,

which also shares borders with China, has been hit by unusually bad weather in the past few days, stranding many tourists who flock to the place for adventure sports such as white water rafting.

Leh town, dotted with Buddhist monasteries, is the main town of India's Himalayan region of Ladakh.

"Sheets of water poured in after the cloud-Massive rescue operations were jointly burst last night, washing away mud and stone structures that came in its way," a police spokesman said by telephone from Leh.

"So far, we have no reports of any tourists among the dead, but some are stranded on the Leh-Manali road. The army has sent rescue teams there," officials said.

US attends Hiroshima ceremony for first time

The United States yesterday for the first time attended a ceremony commemorating its atomic bombing of Hiroshima, 65 years after the Japanese city's obliteration rang in the nuclear age.

Representatives from more than 70 nations joined tens of thousands at the emotional event, held under an azure sky as clear as that on the morning of August 6, 1945 when Hiroshima was transformed into a terrifying inferno.

The United States' World War II allies Britain and France, both declared nuclear powers, also sent their first diplomats to the ceremony in the western Japanese city in a sign of support for the goal of nuclear disarmament.

The mournful toll of a temple bell marked the start of a one-minute silence at 8:15 am, when the US B-29 bomber Enola Gay had dropped a device that instantly killed tens of thousands in Hiroshima.

"The human race must not repeat the horror and misery caused by atomic bombs," Japanese Prime Minister Naoto Kan said in a speech after 1,000 white doves were released into the sky in a symbolic gesture for peace.

Al-Qaeda in Pakistan 'most formidable'

The United States said Thursday that despite major setbacks, al-Qaeda's core in Pakistan is the "most formidable" terrorist group threatening the United States, along with affiliates in Yemen and Africa.

In an annual report, the State Department said it also learned that Americans were not immune to the lure of Islamist militancy, with some of them hooking up last year with radicals in Pakistan and Somalia. "Al-Qaeda's core in Pakistan remained

during 2009 the most formidable terrorist organisation targeting the United States," the State Department's counter-terrorism coordinator Daniel Benjamin told reporters. "It has proven to be an adaptable and resil-

ient terrorist group whose desire to attack the United States and US interests abroad remains strong," Benjamin said, reading from the Country Reports on Terrorism 2009. "We assess that al-Qaeda was actively

engaged in operational planning against the United States and continued recruiting, training and deploying operatives, including individuals from Western Europe and North America." Al-Qaeda, from its safe haven in Pakistan, is

helping train and fund the Taliban-led insurgency in Afghanistan, which "remained resilient" strike against the United States," the report said. in the south and east and expanded its presence into the north and west," the report said.

In Afghanistan, despite some heavy losses among militants and their leaders, the Taliban's "ability to recruit foot soldiers from its core base of rural Pashtuns remained undiminished," the reports aid. In Pakistan, there was still "rising militancy

and extremism," it warned. al-Qaeda militants, Afghan insurgents and tribesmen and nomads.

southern Punjab, and other parts of Pakistan. But Benjamin repeated the US contention that Pakistan is now working hard to tackle the threat from militants, after charges that its ISI intelligence service has backed them as a foil to perceived threats from neighbouring India.

The report said al-Qaeda has reeled under a Pakistani military onslaught, lost many of its leaders, and now finds it "tougher to raise money, train recruits and plan attacks" outside Pakistan and Afghanistan.

It also said al-Qaeda has suffered from a Muslim public backlash as its militants and allies have staged indiscriminate attacks, hitting Muslims in Algeria, Iraq, Saudi Arabia, Pakistan, Indonesia, and elsewhere.

"Yet despite these setbacks, the al-Qaeda threat was more dispersed than in recent years, which partially offset the losses suffered by al-Qaeda's core," the report said.

US drone strikes have also reportedly killed al-Qaeda leaders.

Its attempted Christmas Day bombing of a US airliner en route to Detroit showed "that at least one al-Qaeda affiliate has developed not just the desire but also the capability to launch a

Scientists find sea sponges share human genes

Mankind may be descended from apes but Australian scientists have found proof of links much closer to the sea floor, with a study revealing that sea sponges share almost 70 percent of human genes.

Genetic sequencing of sea sponges from the World Heritage-listed Great Barrier Reef showed the ancient marine animal shared many of its genes with humans, including a large number typically associated with disease and cancer.

Lead researcher Bernard Degnan, of the University of Queensland, said the findings "would shed light on a whole range of different things," and could lay the foundation for breakthroughs in cancer and stem cell research.

"Sponges have what's (considered) the 'Holy Grail' of stem cells," Degnan told AFP.

Exploring the genetic function of sponge stem cells could provide "deep and important connections" to the genes that influenced human stem cell biology, he said.

"(It) might actually inform the way we think about our own stem cells and how we might be able to use them in future medical applications,' he said.

Mandela charity trustee 'kept' Campbell's diamonds

An official at a Nelson Mandela charity said yesterday he kept suspected blood diamonds for over a decade, giving them to police only when supermodel Naomi Campbell testified at a war crimes trial. Campbell's appearance Thursday at the trial of former

Liberian dictator Charles Taylor set off speculation about the fate of the "blood diamond gift" Taylor allegedly gave her in 1997 after a celebrity dinner hosted by then South African president Nelson Mandela. The supermodel told a court in The Hague how she received a

pouch of rough diamonds as a late-night gift she assumed came from Taylor, who is charged with murder, rape and enslavement for his alleged role in the 1991-2001 civil war in Sierra Leone that claimed some 120,000 lives. Campbell told judges she gave the stones to Jeremy Ratcliffe

then the chief executive of the Nelson Mandela Children's Fund to "do something good with".

In a statement, Ratcliffe confirmed Friday that he kept the three uncut diamonds and never gave them to the charity.

"Three small uncut diamonds were given to me by Naomi Campbell on the Blue Train on September 26, 1997," Ratcliffe said, referring to the luxury train he travelled on with Campbell and other guests of Mandela. Campbell had wanted the fund to use them, but Ratcliffe said he

did not want to involve the charity in any possible illegal activities.

"In the end I decided I should just keep them," he said, but added that he recently handed them over to South African authorities.

Police confirmed they received the stones on Thursday. "They were handed over to the police and now they have been sent to the diamond board for authentication," said Musa Zondi, spokesman for the special investigations unit of the South African police.

Convicted K Rouge jailer hires new lawyer

local attorney, Kang Ritheary, to represent him because "we cannot find international lawyers that met his criteria," said Lars Olsen, a spokesman for the court.

Kar Savuth told local media last month that his client wanted a Chinese lawyer with knowledge of communism to represent him at the tribunal, where there had been discord between his inter-

national and local lawyers. Duch was jailed for 30 years

last month for war crimes and crimes against humanity over his role in overseeing the mass murder of 15,000 men, women and children at the Tuol Sleng prison.

The fishing boat originally belonged to the Thai government. The Bangladesh Navy had earlier seized it for fishing in Bangladesh's territory. According to the petition
