### SLUM DEMOLITION Health secy, IGP face contempt rule

The High Court yesterday issued a contempt of court rule against health secretary, inspector general of police and two other government high officials for knocking down the Sat Tala slum in the capital's Mohakhali area ignoring its earlier order.

The two other contemnor officials are senior assistant secretary of health ministry and additional chief engineer of Public Works Department.

The court in the rule directed them to explain within two weeks why action would not be taken against them for contempt of court as they demolished the Sat Tala slum.

# Power projects must not delay

PM directs officials to relax rules for faster bidding and implementation; ensure uninterrupted supply during iftar, sehri time

As different government agencies are failing to complete the tender process to set up new power plants on time, Prime Minister Sheikh Hasina yesterday instructed the power ministry to amend the procurement rules for faster bidding.

"She has asked officials to amend the tender rules concerned so that a tender cannot be delayed due to procedural reasons," Prime Minister's Press Secretary Abul Kalam Azad told journalists.

He said this following a meeting between the prime minister and high officials of the energy and power ministry yesterday.

Hasina asked officials to make sure that procedures are not bars to generating power, and that the government does not lag behind its

She also instructed officials to take whatever measures possible to ensure smooth supply of power during Ramadan. She particularly asked the authorities to ensure power supplies during iftar and sehri hours and urged people to be more frugal in using electricity.

Power Secretary Mohammad Abul Kalam Azad, however, told reporters after the meeting that it would not be possible to meet the power demand during Ramadan because of the gas crisis. He said 920 million cubic feet of gas a day SEE PAGE 15 COL 1

## Transit to benefit four countries

Dipu Moni explains: India to get access to its north-east thru' Bangladesh territory, Bangladesh to get transit thru' India to reach Nepal, Bhutan

India will be allowed to use Bangladeshi territory to reach seven landlocked north-eastern Indian states through establishment of road and railway connectivity, Foreign Minister Dipu Moni disclosed yesterday.

Bangladesh will also be allowed to use Indian territory to reach Nepal and Bhutan, and will have direct access to the north-eastern Indian states, she said.

### 3-lane system re-launched, jam worsens

Traffic movement on major city roads virtually came to a halt at different points for hours yesterday greatly disrupting life.

And downpours in the morning and afternoon added to commuters' sufferings due to gridlocks. Meanwhile, Dhaka Metropolitan Police yesterday started re-

launching the three-lane system on major roads in a bid to ease traffic jam. But instead of improving the situation, it might have created the unusual tailbacks. Traffic congestion persisted from around 9:00am to about

5:00pm at different busy intersections including those in Mohakhali, Farmgate, Karwan Bazar, Shahbagh, Malibagh, Gulistan, Moghbazar, Bijoy Sarani, Mirpur, Khilkhet, Uttara and Airport to Abdullhapur areas. A commuter from Uttara, Md Habib, said, "It took me over
