Syndicate steals Tk 1cr oil a year

Oil worth about Tk one crore is allegedly being pilfered every year from the state-owned Beanibazar gas field.

Sources said, a syndicate of some dishonest officials and employees of the gas field, Padma-Jamuna depot in Sylhet and owners and drivers of tank-lorries are involved in stealing the oil.

from the gas field by overloading oil in tank-lorries during the supply of fuel to Padma-Jamuna depot in Sylhet. At least 100 people are involved

in the network, they said. oil-tankers are used every month to carry the refinery fresh oil from the Beanibazar

Although each tank-lorry is supposed to load 9,000 litres of

WIFE MURDER

One to die, another sentenced to life

Two people were convicted in Faridpur and Natore on Tuesday and Sunday for killing their wives while body of a housewife was recovered in Nilphamari on Tuesday.

A court in Faridpur sentenced a man to death on Tuesday for killing wife about two years ago.

Convict Sheikh Farid, 30, is son of Abdur Rashid of Moheshordi village under Bhanga upazila of the district, reports our correspondent.

Court source said, Shirina Akter, 20, daughter of Wadud Khan of Bagpura village under Bhanga upazila was married off with Sheikh Farid of the same upazila.

After marriage Sheikh Farid used to beat Shirina demanding a fat amount of dowry. As Shirina refused to bring

the dowry money, she was set ablaze in the kitchen of inlaw's house on 31 May, 2008. She succumbed to her

injuries on the way to Faridpur Medical College and Hospital (FMCH) the same day. Shirina's father Wadud

Khan filed a case with Bhanga police station in this connection on 2 June, 2008 accusing three people -- Sheikh Farid, his father Abdur Rashid and mother Zarina Begum. In Natore, another man

was sentenced for life on Sunday for killing his wife in 2004, reports UNB.

sources said Abul admitted her to Dimla hospital on Monday evening claiming that she swallowed poison in a bid to commit suicide. Later, she died at about 10

ALLEGED SEXUAL HARASSMENT TO A GIRL

RU students lay siege to administrative building

Students of different departments at Rajshahi University (RU) yesterday laid a siege to the administrative building demanding expulsion of a student for allegedly sexually harassing another student.

According to the agitating students, Assaduzzaman Siju, a fourth year student of RU economics department sexually harassed a third year student of the same department a few months ago. The victim has become mentally ill as Siju allegedly tortured her on and often, they alleged.

They alleged that the accused is still threatening the victim's family and creating pressure on them to marry the girl. The agitating students besieged the administrative building for one and half hours and kept the building's main gate under lock and key till 11:30pm demanding immediate expulsion of the culprit.

Later, the protesters locked in an altercation with proctor Prof Chowdhury Zakaria as he barred the students from meeting vice chancellor.

Illegal firearms factory busted, 2 arrested

Police early yesterday busted an illegal firearms manufacturing factory and arrested two persons while assembling arms at Morrelganj.

They also recovered a number of arms-making materials from the spot. Following a tip-off, police

raided the houses of listed drug peddlers Nayan Talukder and Shamim Talukder and unearthed the arms manufacturing factory, sub-inspector of Morrelganj police station Md Manirul Islam, said.

They caught red-handed two persons and seized five incomplete pipe guns and 27 kinds of arms-making equipments from the illegal factory. The arrestees were identi-

fied as Khan Zakir Hossain, 35 of Rupsha upazila and Md Abdul Hakim Sheikh, 60 of Batiaghata upazila in Khulna district. Sensing presence of the

law enforcers, Nayan and Shamim managed to flee the scene. A case was logged with
