BlackBerry 'optimistic'

It can avert Indian ban

AFP, New Delhi

BlackBerry maker Research in Motion (RIM) said yesterday it was "optimistic" it could avert a threatened shutdown by India of the core features of the popular smartphone on security grounds.

A top-level delegation of the Canadian firm met India's Home Secretary G K Pillai to discuss the government's warning it would ban BlackBerry's corporate email and messaging unless it gave security agencies access to the services.

"I am optimistic," Robert Crowe, vice-president of Research in Motion, told reporters following the halfhour talks

Crowe's statement came as India's showdown with BlackBerry threatened to widen and encompass Google and the Internet telephony firm Skype as the country seeks access to any services that might be used by militant groups.

"These are all issues that are being deliberated from a security point of view," an Indian government official, who declined to be named, told AFP.

The government, fearful that extremists could use Blackberry's heavily encrypted messaging system to coordinate attacks, has given RIM until August 31 to provide a "technical solution" to its demand for security access.

India is battling insurgencies from Kashmir in the northwest to the far-flung northeast and mounting Maoist unrest. Islamist gunmen used mobile and satellite phones to coordinate the brazen three-day assault on Mumbai in 2008 that killed 166 people.

India's telecom operators, already forced by the government to conform to tough new security regulations on importing equipment to ensure it is not embedded with "spyware", declined to comment on the ultimatum to BlackBerry.

"We have to wait to see how the story unfolds, it is a very fluid situation," said an executive at one wireless company.

The United Arab Emirates, however, has said it will ban BlackBerry messenger, email and web browsing services from October 11 for security reasons. In response to the Indian

threat, RIM said in a written statement it tried to be as cooperative as possible with governments "in the spirit of supporting legal and national security requirements".

But it also wanted to preserve "the lawful needs of citizens and corporations".

Analysts have noted other security-conscious countries such as China and Russia appear to be satisfied over their intelligence agencies' level of access to BlackBerry communica-

Quoting minutes from a July 12 meeting between Indian officials and telecom and Internet providers, the Financial Times on Friday said the government wanted a broad solution to enable possible interception and monitoring of all Internetbased traffic, including Skype and Google.

Google is already locked in tension with Beijing over state censorship and cyber attacks that the US company says originated in China, the world's largest online market with 420 million users.

India is another coveted prize for communications providers. It is the world's fastest-expanding cellular market and already has 1.1 million BlackBerry customers.

Nine Dakope villages under water

At least nine villages of Dakope upazila went under six feet of water as a newlyconstructed ring embankment at Joynagar collapsed Thursday afternoon.

Over 10,000 villagers of Aila affected areas became homeless and marooned without food or safe drinking water.

The situation is likely to worsen as another ring embankment at Kalabogi union under the same upazila is also facing threat under the tidal surge of the rivers Shibsha and Dhaki which are swelling more than usual due to the weather, said Shafiqul Islam, an engineer of Water Development Board (WDB).

"This may inundate several villages rendering over 20,000 people homeless," he said, adding, "We are vigilantly observing the situation and preparing to tackle the prob-The affected villages of

Dakope are Channirchawk, Fakirdanga, Kalinagar, Kamarkhola Uttarpara Kamarkhada Madhyapara Shibnagar, Mozamnagar, Kaminibasia and Andharmanik.

The marketplaces and shops have gone under flood water paralysing the economy of the affected villages.

The flood victims have taken shelter at the temporary cyclone centres and academic institutions while others have migrated to neighbouring villages which have not been The marooned people are

facing a severe crisis of safe water and food, said Sheikh Abul Hossain, chairman of Dakope.

Jong-il's son seeks military 'stripes' Says Gates

US Defense Secretary Robert Gates said on Thursday recent provocations by North Korea against the south were probably tied to ailing leader Kim Jong-il's youngest son seeking to earn his military "stripes."

Gates, who was in South Korea last month, said one of his biggest worries about the North was that with the succession of the ailing leader's son now apparently underway there would be more provoca tions against its neighbour.

Relations across the divided peninsula have turned increasingly hostile after South Korea accused the North of sinking one of the South's warships, the Cheonan, in March, killings 46 sailors.

"I have a sneaking suspicion that Kim Jong-il's son, who wants to take over, has to earn his stripes with the North Korean military," Gates said at the U.S. Marines' Memorial Club in San Francisco. "My worry is that that is

behind the provocation like the sinking of the Cheonan, and so I think we are very concerned that this might not be the only provocation from the North Koreans," he added in response to a question over the threat posed by Pyongyang.

Chowdhury. Khan Mahmud Amanat, a professor in the civil engineering department at Buet, who will be in the new investigation team, noted, "If the recommendations of Jamilur Reza Chowdhury were executed on time, the bridge would not be in such a bad condition now."

About the delay in selecting a contractor for the repair work, Communications Minister Syed Abul Hossain told The Daily Star on Tuesday that his ministry is at the final stage of selecting a firm for the

"We are now evaluating finance offers from three firms -- two Japanese and a Chinese ---- and hope to issue work order by the end of this month," he said adding that the bridge will be okay once the repairs are done.

"We were not in power when the cracks were detected. After assuming power we invited tender twice, but failed to find a suitable firm for the difficult job. This compelled us to go for the third tender which is going to be a successful one," he said.

A Bridge Division official said the repair work may take three months to start, and a year to be finished.

The government cut vehicular speed and load limits by a half in 2006, in line with the recommendations of Prof Chowdhury led expert team.
