Russia says fires abating close to nuclear site

Russia said yesterday wildfires raging close to a secret nuclear site had been controlled, amid accusations it sought to cover up the risks from fires in forests contaminated by the Chernobyl nuclear disaster.

With the country's worst ever heat wave showing signs of relenting, the authorities faced new weather problems as a violent storm ripped through northwest Russia overnight and headed for Moscow.

The peat and forest fires in the countryside of central Russia have killed over 50 and also raised concerns about the security of potentially dangerous strategic sites located in the vicinity of the fires.

A major worry has been fires in a nature reserve close to Russia's main nuclear research centre in Sarov -- a town closed to foreigners as in Soviet times -- but the authorities said they had taken a major step to resolving the crisis.

Iran to begin work on new nuke site in 2011

Iran is to start building its third uranium enrichment plant in early 2011, a top official said, defying world powers, which have slapped new sanctions on Tehran for pursuing the sensitive nuclear work.

Iran's atomic chief Ali Akbar Salehi, cited on state television late on Sunday, said the search for sites for 10 new enrichment facilities "is in its final stages.

"The construction of one of these will begin by the end of the (current Iranian) year (to March 2011) or the start of next year, inshallah (God willing)."

Iran is already enriching uranium at its main plant in the central city of Natanz and is building a second enrichment facility inside a mountain at Fordo, southwest of Tehran.

The country's hardline President Mahmoud Ahmadinejad announced the planned construction of 10 new enrichment plants late in 2009 after Tehran was censured by the UN atomic watchdog over building the Fordo facility.

Iraqis file case to break political deadlock

A dozen civic groups launched an audacious court action yester-day in a bid to break Iraq's deadlock over the formation of a new

government, five months after a general election.

The legal appeal to Iraq's Federal Supreme Court is the latest sign of growing popular discontent with political elites in a violence-wracked country where basic services and infrastructure remain weak and dilapidated.

The charities and pressure groups brought the case against caretaker parliament speaker Fuad Massum, accusing him of violating the constitution by leaving the Iraqi Council of Representatives' first session open, with no progress on the election of a new speaker.

That, they allege, has blocked the election of a new national president and prime minister.

"We call on the Federal Court to require the defendant ... to end the open session as it violates the constitution ... or call on the Federal Court to dissolve the Council of Representatives and carry out new elections," the groups said in a news release. Iraq's four main political blocs, none of which holds a parlia-

mentary majority, have made little progress in forming a governing coalition in the months since the March 7 poll.

Ex-premier Iyad Allawi's Iraqiya bloc narrowly won the elec-tion with 91 seats in the 325-member parliament, followed by Prime Minister Nuri al-Maliki's State of Law Alliance with 89. While the constitution stipulates that a speaker, president and prime minister must be elected in that order, analysts note the

posts will likely be decided on jointly by Iraq's main political groups as part of a grand bargain. Massum, who holds his post by virtue of being parliament's oldest lawmaker, conceded that leaving parliament's first session open "was

a violation of the constitution, and ... I will stand before the court to defend my stance, and I will accept any ruling the court will make."

Israel rejects 'preconditions' for ME peace talks

Israeli officials on Monday rejected any "preconditions" ahead of an expected international invitation to direct peace talks with the Palestinians that would call for a complete settlement freeze.

Their remarks came as Washington appeared to be closing in on the relaunch of direct negotiations after months of shuttle diplomacy that have thus far failed to convince the Palestinians to enter face-to-face talks.

"Israel is ready to start direct negotiations immediately, but without any preconditions," an Israeli official told AFP on condition of anonymity.

"The Palestinians, who have lost valuable time by refusing to revive these direct contacts, will present all the topics they want to discuss at the negotiating table," he added.

The diplomatic Quartet -- comprised of the United States, the United Nations, the European Union and Russia -- was expected to issue a statement inviting both sides to relaunch direct talks, which were suspended in late 2008.

Israeli media reported that a forum of seven top cabinet members have decided to reject the Quartet statement, which may call on Israel to extend a limited West Bank settlement freeze, set to expire in September, for another 10 months.

"The Quartet declaration should allow the Palestinians to descend the tree they have climbed by refusing negotiations, but it must not be binding on Israel," several Israeli media outlets quoted an unnamed minister as saying.

The minister was quoted as saying that Netanyahu's government would reject the appeal from the Quartet but accept a parallel invitation issued by Washington that would be "more balanced."

Chief Palestinian negotiator Saeb Erakat charged that Netanyahu's government was not serious about peace.

"The announcement by the Israeli government rejecting the statement of the international Quartet before it is even issued shows that Israel is persisting in its rejection of a serious peace process," Erakat told AFP.

"(This) clearly proves that this government has other interests besides peace and stability in the region," he added.

Erakat also rejected Israel's decision on Sunday to deploy 23 caravans in eight West Bank settlements to serve as classrooms, saying it was "placing additional obstacles" in the way of US efforts to revive the peace process.

Thailand lifted a controversial state of emergency in three more provinces yesterday, but not Bangkok, almost three months after the end of deadly street protests that left the nation deeply divided.

The move came as 17 leaders of the "Red Shirt" antigovernment movement appeared in court, where they pleaded not guilty to terrorism charges over their role in the twomonth-long mass rally, which leftabout90 people dead.

The government said that although there were lingering fears of unrest, it was scrapping emergency rule in Chiang Mai, Chiang Rai and Ubon Ratchathani in northern Thailand because the strict laws were hurting business and tourism.

"I admit that to revoke the emergency decree is risky as there might be some activities that will affect the image of the country," said Prime Minister Abhisit Vejjajiva.

"For Bangkok and surrounding provinces, it's the hardest decision to make as Bangkok is the centre of everything," added Abhisit, who has come under pressure from foreign allies and rights groups to revoke the laws.

The government has said the decree is still needed in the capital following two small bomb blasts there last month, including one that killed a man.

Bacteria can 'smell' environment, research shows

Research has shown that bacteria - among the simplest life forms on Earth have a sense of smell.

Scientists from Newcastle University in the UK have demonstrated that a bacterium commonly found in soil can sniff and react to ammonia in the air.

It was previously thought that this "olfaction" was limited to more complex forms of life known as eukaryotes.

The finding, published in Biotechnology Journal, means that bacteria have four of the five senses that humans enjoy. The discovery also has

implications in the understanding and control of biofilms - the chemical coatings that bacteria can form on, for example, medical implants. Bacteria have already

demonstrated the ability to react to light, in analogy to sight, and to change the genes that they express when confronted with certain materials, in analogy to touch.

However, there is a distinction between an organism reacting to a chemical that it encounters directly (in analogy to the sense of taste) and a reaction to a chemical that is floating around in the air, says Reindert Nijland, lead author of the study. "The difference is both in

the mechanism that does the sensing, as well as in the compounds that are sensed," Dr Nijland, now at University Medical Centre Utrecht in the Netherlands, told BBC News.

Thai govt ends US-S Korea drills anger North, worry China

The US and South Korean militaries will stage their second joint exercise in less than a month from yesterday, fuelling tensions with the prickly North and angering regional power China.

The annual exercise comes a week after Seoul completed its own drills near a disputed maritime border off the west coast that prompted the North to retaliate by firing a barrage of artillery shells in the same area.

Responding with the same rhetoric as it has in the past, the reclusive North said the latest exercise was a "dangerous act to light the fuse of a new war."

Pyongyang has often turned to saberrattling to make a point but analysts say it is unlikely to risk a full-blown war which would pit it against the combined might of the US and South Korean militaries.

But US officials have said further provocations by the North are possible in coming months, especially as Pyongyang tries to build political momentum for the succession to leader Kim Jong-il, expected to hand power to his youngest son.

Unlike the show-of-force drills in July which involved a US aircraft carrier, this month's exercises are lower key.

Washington and South Korea say the exercises are defensive and designed to send a message to Pyongyang that its behaviour is aggressive and must stop. Last week's tit-for-tat military actions

occurred near the Northern Limit Line, the site of several deadly clashes since the 1950-53 Korean war, and the location of the torpedoing of a South Korean warship earlier this year.

Seoul blames the sinking of the Cheonan corvette, which cost 46 lives, on Pyongyang. The North denies responsibility.

Kyrgyz army involved in mob violence: HRW

A prominent human rights group said yesterday that Kyrgyzstan's armed forces abetted and may even have actively taken part in violence by ethnic Kyrgyz mobs against the minority Uzbek community that left at least 370 people dead in June.

Human Rights Watch said many witnesses reported seeing individuals in camouflage attacking Uzbeks and using armoured military vehicles to remove improvised roadblocks barring entry into Uzbek neighbourhoods.

"This pattern raises serious concerns that some government forces either actively participated in, or facilitated attacks on, Uzbek neighbourhoods by knowingly or unwittingly giving cover to violent mobs," the report said.

The report by the New York-based group is the most ambitious attempt to date at an independent survey of the causes and consequences of the clashes, which also sent hundreds of thousands of people fleeing from their

homes to neighbouring Uzbekistan.

Kyrgyzstan's interim government spokesman Farid Niyazov wouldn't immediately comment on the report, but said the government welcomes the probe and would continue to cooperate with rights groups to help establish the truth about the unrest.

Top government representatives have acknowledged the real death toll may be much higher than the official tally.

Kyrgyzstan, a strategically located ex-Soviet Central Asian nation that hosts US and Russian military bases, has remained tense before October's parliamentary elections called after former President Kurmanbek Bakiyev was driven from power in a bloody uprising in April.

Establishing the origin of the five-day wave of violence that erupted on June 10 has been hindered by sharply diverging testimonies, although international observers largely agree it rose out of petty interethnic brawls in the southern city of Osh.
