Legislators' involvement in carrying out local development activities has been mired with controversy and has triggered debate on whether MPs can be empowered to interfere in the activities of the local government bodies.

The Supreme Court in a verdict delivered on April 27, 2006, categorically stated that legislators are entitled to ask for any information and object to any of their electorates before the House, but they cannot interfere with the local administration.

It had said the scheme of the constitution is that members of parliament and the ministers would perform their functions centrally, keeping a broad view of the necessity of the country as a whole, while functioning of the local government bodies envisaged under Articles-59 and -60, shall be confined to the needs of local areas.

"...The members of parliament have got no direct role or function, in respect of either development or maintenance of law and order, in the district or in other local administrative units," said the court in the verdict on a writ petition titled "Anwar Hossain Manju versus the Government of Bangladesh".

The court in that verdict declared illegal the notification on the appointment of district ministers. The government did not file any appeal against the verdict with the appellate division, which means the verdict is now law of the land. The current government also refrained from introducing the system of district ministers.

But the government allowed MPs to interfere with the functions of upazila parishads, a crucial tier of the local government body that was reintroduced after around 19 years.

"The government of Pakistan has requested around 900 million dollars of financial support from the World Bank, which we have committed to provide," a statement from the Washington-based bank said.

#### White House: politics no role in mosque remarks

AP, Aboard Air Force One

A White House spokesman says politics wasn't a factor in President Barack Obama's remarks about building a mosque near the site of the Sept. 11, 2001, attacks in New York City.

Deputy White House press secretary Bill Burton said it was "not politics" but Obama's feeling that he had the obligation as president to "make sure people are treated equally" under the Constitution.

Obama has said that religious freedom allows the mosque to be built, but without commenting on the wisdom of building one two blocks from ground zero. Republicans have pounded him for his com ments, making it a prime mid term election issue.

Burton said Obama "felt i was his obligation as president to address this." Obama was on the way to Wisconsin for fundraising.

FROM PAGE 16 An HC division bench of justices Syed Mahmud Hossain and Govindo Chandra Thakur asked the respondents to reply why the government agencies should not be directed to protect the forest from adverse and contrary activities such as felling of trees.

In 2005, the Local Government Engineering Department (LGED) initiated a plan to clear part of the forest on the island to construct a road to link the island with the mainland.

But the plan was stalled the same year following opposition from the forest depart-

ment and issuance of a letter of objection from the environment and forest ministry. The forest department said if the proposed road was constructed clearing part of the

forest, illegal logging would become rampant there. However, a local lawmaker revived the plan and got it approved at a meeting of the Upazila Unnayan Samonnoy

Committee in October last The objections against the

plan were purportedly withdrawn on the plea that the road is needed to rescue the islanders in case of a natural disaster.

The petitioner pleaded that there had been no assessment of environmental impact of the proposed road. Besides, the ministry's deviation from its earlier stance was highly subjective and done under political consideration.

Before the amendment took effect, Bangabandhu was the prime minister and the country had parliamentary form of government.

The fourth amendment act is still valid and none of the previous amendments were deleted from section 34. On condition of anonym-

was not included in the fourth schedule of the constitution, which deals with the transitional and temporary provisions. Perhaps, it was a drafting mistake, he added.

The government last Thursday decided that the CNG filling stations across the country, except for those in Sylhet, would remain closed between 3:00pm and 9:00pm during the month of Ramadan effective from yesterday.

Sultan Miah, a CNG-run bus driver, said he did not know about the government decision. "Now I'll have to switch off my engine and remain idle after Iftar." A number of other bus and CNG-run three wheelers drivers made the same com-

Farhana Zaman, an NGO

official, said, "Certainly we're

suffering because of the deci-

sion. But I accept to face it, if power supply improves." Zakir Hossain Nayan, general secretary of the Bangladesh CNG Filling Station and Conversion Workshop Owners' Association, told The Daily Star

that the decision will cut down their sales by Tk 1.5 crore a day. "Considering people's sufferings [from power shortage] we've agreed to implement the government decision only during Ramadan. But we'll launch tough movement if the government plans to extend the

closure farther," he said. The association leaders yesterday also placed their demands at a meeting between them and the managing director of the Titas Gas Transmission and Distribution Company Abdul Aziz.

Country's total gas requirement a day is around 2,000 million cubic feet but there is a shortfall of around 400 million cubic feet. This is causing a severe gas crisis across the country affecting not only the power plants and industries but households too.

Over 100 CNG-run vehicles were waiting in two separate queues at the Canada-Bangla CNG Filling Station at Karwan Bazar around 8:10pm. Employee of the filling station Nuruzzaman said the cars, taxis and CNG-run auto-rickshaws started joining the queues soon after they closed for the six hours at 3:00pm.

"I have been waiting here for nearly five hours," said autorickshaw driver Kamal Uddin from the city's Mugda area.

"The sudden decision to shut down filling stations has thrown us into terrible sufferings. I have to pay Tk 750 to the owner of my three wheeler before 10:00pm but I am short of Tk 200," said Kalam Hossain of capital's Faridabad area.

Other drivers of vehicles waiting there expressed resentment over the government decision. They said the decision put them in a lot of trouble and demanded the closure time be fixed at three hours rather than the current six.

### Afghan couple 'stoned to death' for love affair

AFP, Kunduz, Afghanistan

A man and woman have been stoned to death in northern Afghanistan after being accused by the Taliban of having a love affair, a witness and an official said yesterday.

The 23-year-old woman

and 28-year-old man were

killed because "they had an affair," said Mohammad Ayob, the governor of Imam Sahib district in Kunduz province. "Two people were stoned to

death by Taliban in Mullah Quli village late yesterday," he said. The village is under the control of the Taliban. Mullah Quli resident Abdul Satar said about 100 people,

most of them Taliban insurgents, gathered in the village on Sunday evening as a statement was read out saying the pair had confessed to their affair. He said the man was mar-

ried to someone else, and the woman was engaged. "The Taliban convicted both to stoning to death, some from the crowd started throw-

ing stones at the couple until they died," Satar said. The couple had their hands bound behind their backs and were forced to stand in an empty field as their sentence

was carried out, he said. A local Taliban commander, who contacted media but refused to give his name, confirmed the killings.

against stoning and other appalling human rights abuses masquerading as 'justice', no matter how much pressure they are under to deal with the Taliban, said Sam Zarifi, Amnesty International's Asia-Pacific director.

Under Islamic Sharia law, sex between unmarried people is punishable by public beatings, while punishment for those caught in extra-marital affairs is death by stoning.

Earlier this month, the Taliban publicly flogged and then killed a pregnant widow for alleged "adultery" in western Badghis province. The killings are a grim reminder of the Taliban's harsh

### WTO rules against EU on hitech duties

The World Trade Organization has backed the United States, Japan and Taiwan in their complaint against EU duties on high-technology products, according to a ruling published Monday.

"Having found that the European Communities has acted inconsistently ... we recommend that the Dispute Settlement Body request the European Communities to bring the relevant measures into conformity with its obligations," the WTO panel of arbitrators said. The ruling was issued confi-

dentially to the parties involved in July. The plaintiffs had accused the EU of violating the WTO's
