The immigration authorities yesterday withdrew one of its sub-inspectors from Shahjalal International Airport for misbehaving with a personal staff of Prime Minister Sheikh Hasina.

toxic ship

Court directs ship-breakers to submit safety certificates before import

The Supreme Court yesterday directed Bangladesh Ship Breakers' Association (BSBA) to execute the High Court order to get all scrap ships decontaminated at source and outside Bangladesh territory.

A full bench of the SC passed the order during hearing of an appeal filed by BSBA seeking a stay on the HC order. The BSBA sought to import toxic ships within the interim period until the government formulates guidelines for the ship-breaking yards.

The HC division in its order on May 11 directed BSBA to have pre-cleaning certificate of decontamination before importing vessels into Bangladesh for breaking.

"The order means the ship breakers would not be able to import toxic ships," said Syeda Rizwana Hasan, chief executive of the Bangladesh Environmental Lawyers' Association (BELA).

A full bench of the Appellate Division headed by Chief Justice Mohammad Fazlul Karim observed that value of life [of shipbreaking labourers] could not be justified by money in any manner.

The SC observation came as the BSBA counsels were arguing ships cannot be imported for breaking due to the HC order and the shipbreaking industry is facing loss and labours are losing jobs.

Shah Alam gets bails in 4 more cases

Three separate Dhaka courts yesterday granted bails in four cases to Ahmed Akbar Sobhan alias Shah Alam, Bashundhara Group chairman, in connection with land grabbing cases.

The courts granted the bails when Shah Alam along with his lawyers including Sheikh Fazle Noor Taposh appeared before the courts to seek bail in the cases.

All the cases were filed with Badda Police Station in 2007.

The lawyers said their client had appeared before the courts as per direction from the High Court (HC).

Metropolitan Public Prosecutor Abdullah Abu, who was present during hearing on the bail petitions, did not raise any objection.

Fire at chemical warehouse again

3 critically burnt; locals of Old Dhaka revisit Nimtoli nightmare

A fire at a chemicals storehouse left three people seriously injured in a residential area of Lalbagh in Old Dhaka yesterday.

The wounded were admitted to the burn unit of Dhaka Medical College Hospital in a critical condition.

The blaze started at about 2:30pm on the ground floor of the two-storey chemicals storehouse on Jagannath Saha Road, only four days after the government extended the deadline for shifting chemicals warehouses from the city's old part to a safer location.

The government took the initiative a few days after 124 people died on June 3 in a devastating fire fuelled by combustible substances at a chemicals warehouse in densely populated Nimtoli in Old Dhaka. It directed traders to move chemicals storehouses from the area to a

safer location by August 17.

Locals said it could have been another disaster like Nimtoli had the fire touched the flammable substances stored on the first floor of the factory that packages rubber solution.

They got panicked seeing a strong blaze spiralling upward from the two-storey building. The factory staff doused the flame using fire extinguisher, sand and water, said locals.

A huge amount of chemicals had been found inside the factory, said Abul Kalam Azad, officer-in-charge of Lalbagh Police Station. The

cause of the fire was yet to be ascertained. The factory staff did not inform police or fire fighters about the incident, he said adding that they rushed to the spot on information from a few locals.

Factory owner Gazi Shafiullah Jewel, 32, who received burns in the incident, claimed


