RUMOUR OF CHILD-LIFTING IN CTG

Mob kills old woman

30 injured as they clash with cops, attack police station

An elderly beggar woman was killed and three other people were injured in separate incidents of mob beating in the city on Saturday night and yesterday following a remour of child-lifting.

Chittagong SP ZA Morshed told The Daily Star that five suspected childlifters have also been killed in such incidents in the district since August 01.

Sources said the rumour is that childlifters are taking away children for collecting cut off heads for the newly built third Karnaphuli Bridge.

As panic gripped the people following the rumour, police yesterday requested all mosque authorities start miking from mosques, and the law enforcers held meetings with local ward councillors to aware people.

Officer in-charge (OC) Rezaul Karim of the police said some people suddenly started beating the unidentified woman, when she was begging at Bandartila 50, around 9.00pm on Faruk. Saturday following a rumour that she had five cut off heads in her bag.

In another incident, a group of muggers took away Tk 5,000 and mobile phone set from a trader Khalil Uddin Razu at Bohoddarhat Intersection around 9:15pm on Saturday. Later, the criminals started shouting termed Khalil "child-lifter." Hundreds of people joined them and beat Khalil.

When police rushed there, the mob barred them resulting in a clash that left 30 people, including cops injured. They also blocked the intersection and attacked Chandgaon Police Station and damaged a police vehicle, police said.

A group of people went to the police station early yesterday saying that Khalil had five cut off head and those have been kept at the police station, said OC Omar

Five people were arrested and a case was filed in this connection accusing the arrestees and two thousand unidentified persons, he said.

Yet in another incident, people also beat up Mohammad Ali, 19, at Rajakhali under Bakolia Police Station on Saturday night suspecting him as a child-lifter. Later, police rescued him.

Around 12.00noon yesterday, a rickshaw-puller was also beaten up by locals at the city's Chhotopole as his passenger Selina Akter, a resident of CDA Residential area, asked him to catch Miraj as the boy fled her house in the morning.

Netherlands keen to help in water management

The Netherlands wants to help Bangladesh in water management as well as attaining the Millennium industry. Development Goals (MDGs).

The Netherlands Ambassador to Dhaka Alphons Hennekens said this when he called on Prime Minister Sheikh Hasina at the Prime Minister's Office (PMO) yesterday.

Water management has emerged as one of the major challenges for Bangladesh in recent years, as the country is exposed to serious threats from climate change.

Some studies said the sea level will rise by at least three metres due to global warming within 2050, sending the existing coastal embankments underwater if they are not raised by 4-6 metres.

Hennekens told the prime minister of his government's willingness to assist Bangladesh in the fields of poverty alleviation and primary education.

Besides, he said his government is eager to help develop the shipbuilding

industry in Bangladesh.

Hasina emphasised safeguarding the environment and the people from the hazardous aspects of the shipbuilding

She said the Netherlands can be benefited by importing small and mediumsized ships from Bangladesh. She thanked the Netherlands for being a dependable development partner in supporting socio-economic development of Bangladesh.

She lauded Dutch support for Bangladesh as well as the LDCs in general as it is the fifth largest destination for Bangladeshi exports within the European

Hasina also urged Ambassador Hennekens to get his country to import more of Bangladesh's ceramics, pharmaceuticals, leather goods and computer software.

As the envoy hailed the PM for her 'Vision 2021' initiative to turn Bangladesh into a modern, digitalised country, the issue of a previous agreement between

Bangladesh and Dutch company 'Tulip Computers' came up for discussion.

During the previous Awami League tenure, Tulip Computers started a project in Bangladesh, coordinated by the Dutch Ministry of Development Aid. The aim was to train 7,700 teachers in IT. Tulip Computers was to provide 11,000 computers and additional hardware, as well as the courses for the teachers.

The Dutch government would pay half the project cost, estimated to be about •10m. But "ridiculously", the next BNP-Jamaat government had stopped the project, solely for the reason that the name of the Dutch company resembled the name of Tulip Siddique, daughter of Sheikh Rehana, the prime minister said.

"However, we have taken steps again to implement the project as we are pledge-bound to create a digital and modern Bangladesh," Hasina said.

Principal Secretary to the Prime Minister MA Karim and Prime Minister's Office Secretary Mollah Waheeduzzaman were present.

Rajuk boss to face contempt of court charge Aug 26

The High Court (HC) yesterday directed Chairman of Rajuk Nurul Huda and its two officials to appear before it on August 26 in connection with a contempt of court petition filed against them.

An HC bench of Justice AHM Shamsuddin Chowdhury Manik and Justice Sheikh Md Zakir Hossain also issued a rule asking them to explain on the day why they should not be punished for committing contempt of court by not complying with its order.

The bench came up with the order following the contempt of court petition filed by one Mizanur Rahman, a construction contractor of Dhaka City Corporation (DCC).

Two other contemnors are Rajuk's director Khizir Ahmed and deputy director Khalilur Rahman.

Since they did not take any decision as per the HC order, Mizanur on August 18 filed the contempt of court petition with this court.

Barrister M Amir-Ul Islam appeared for the petitioner, while Deputy Attorney General Nazrul Islam Talukder represented the government.

Govt to expand list of foreign friends of 1971

Bss, Dhaka

A national committee constituted to name distinguished foreigners to be honoured for their 1971 supports presented a draft search list before its third meeting yesterday chaired by Foreign Minister Dipu Moni.

"The list is expected to be finalised by September this year," said Dipu Moni at the meeting in her office. She added that the government decided to confer them with the honour in Dhaka coinciding with 40th Independence Day on March 26 next year.

Officials said a sub-committee tasked to prepare the list proposed names of 108 foreigners while a member of the main national committee named another 134 people from India and Pakistan alone. The foreign minister, heading the committee,

said inputs were being taken from different sources to prepare the final list. She said, "Though we have already prepared a draft of the awardees but it is difficult to say at this moment what the size of the list could be.'

But the meeting sources said the final list was expected to contain nearly 500 names as newer searches revealed that high profile people across the world extended their supports for the 1971 LiberationWar.

The source added that the studies found people like Victoria Ocompa, the great Argentinean, known for her love for Rabindranath Tagore, campaigned in her country for our liberation in 1971 at the age of 90.

A member of the committee also said initial searches found nearly 35 Pakistanis who dared to stand for the cause of Bangalis braving their exposure to torture, imprisonment and manhunt.

Officials earlier said late Indian prime minister Indira Gandhi would be conferred with a special honour for her "immense" support for Bangladesh's 1971 Independence. Former US senator Ted Kennedy, French author and politician Andre Malraux were the two other prominent figures in the initial list suggested for the award.

Liberation War Affairs Secretary Uzzal Bikash Dutta said the foreigner would be divided in different categories like foreign statesmen, politicians, diplomats, soldiers, artistes, writers, journalists, rights activists and groups and media like BBC and All India Radio for the honour.

Bangladesh is to invite the recipients or their relatives to receive the awards in Dhaka.

"The objective of the award is to express our acknowledgement . . . to prove we are a grateful nation," Dutta said.
