## Cabinet okays expats' voting rights

The cabinet yesterday approved an amended bill on Voter Lists Act 2010, securing voting rights for all expatriate Bangladeshis living in various countries of the globe.

According to the Voter List (amendment) Act 2010, for as long as an expatriate stays abroad, he or she will have his or her due right to practice voting rights from his or her local constituency in Bangladesh. This was explained by Press Secretary to the prime minister Abul Kalam Azad after the cabinet meeting held at Bangladesh Secretariat with Prime Minister Sheikh Hasina in the chair.

The press secretary said ensuring expatriates' voting rights has been promised several times by the prime minister herself.

### DCC elections after Eid

#### Says poll commissioner

UNB, Dhaka

The Dhaka City Corporation (DCC) elections will be held at a convenient time in between Eid-ul-Fitr and Eid-ul-Azha, said Election Commissioner M Sohul Hussain yesterday.

Talking to reporters at his office, the election commissioner also said elections to the union parishads and municipalities would be held between December and January. Earlier, he said the elections would be held around November-December.

In this regard, he said the time period was extended by a month as annual final examinations and hajj would be held during this session (Nov-Dec).

The election commissioner mentioned that there are some 79 union parishads where elections have not been held for 10 years. Local body polls can likely be held when ordinances are promulgated, he

Sohul Hussain also revealed that vetting procedure of the amended union parishad and municipal acts have already been completed and the Ministry of Local Government has also recommended the commission to take necessary preparations for the local body elections.

Speaking as the chief discussant Prof Imtiaz Ahmed of Dhaka University's International Relations department said to make the country free from extremism the political parties of Bangladesh

### MURDER CASE

### HC frees Ruhul Quddus of charges

The High Court on Sunday upheld a trial court order that allowed the government to withdraw a murder case in Rajshahi against nine persons including Ruhul Quddus Babu, who was recently appointed as an HC judge. Ruhul Quddus Babu was nominated as an HC judge by the

president on April 11, but he is yet to take oath for his office. The HC yesterday passed the verdict after rejecting a revision

The revision petition was filed against an order of a Rajshahi court that allowed a government prayer on April 8 this year for withdrawal of the case filed on charge of killing Aslam Hossain, an Islami Chhatra Shibir leader of Rajshahi University (RU), in

petition challenging the withdrawal order of the murder case.

Aslam was killed at his room in Nawab Abdul Latif Hall of RU on November 17, 1988.

The same day, Nayeb Ali, a classmate of the victim, filed a murder case with Matihar Police Station in Rajshahi against 18 people including Ruhul Quddus in this connection.

Nayeb Ali, the plaintiff of the case, and Aslam's father Zinnat Ali filed the revision petition with the HC on May 2 this year.

Barrister MI Farooqui appeared for Ruhul Quddus, Advocate Munsurul Huq Chowdhury argued for others who were accused of the case, while Advocate Tajul Islam stood for the petitioners.

## Probe violence of 2007

VC urges govt

Dhaka University authorities yesterday observed "Black Day" commemorating the oppression on teachers, students and staffs of the university by law enforcers from August 20 to 23 in 2007 on the campus. Marking the day, classes at the university

remained suspended from 11:00am to 1:00pm while teachers, students and staffs wore black ribbons.

Attending a discussion at Teacher-Student Centre auditorium, Vice-Chancellor Prof AAMS Arefin Siddique urged the government to reinvestigate into the violence that occurred on campus during the three days in 2007.

He said people who were involved behind the incident should be disclosed before the nation and punished.

On August 20, 2007 a violent student protest erupted on DU campus following the beating of a few students by some army members at the central playground of the university. The protests continued for next three days spreading violence on some other campuses in the country.

ment of shipping and law enforcement agencies at the BIWTA conference room. Steps have been taken to ensure uninterrupted power supply at the Sadarghat launch terminal during the period, he said adding

that the law enforcers will keep sharp vigil on all the launch terminals. Special monitoring teams, comprised of

BIWTA officials, representatives of vessel owners' association, department of shipping, representatives of different workers' organisa-

tions and law enforcement agencies, will be in force to check any violation of rules and regulations.

Malek also stressed the need for easing tailbacks on Gulistan-Sadarghat route. Oneway traffic system would be introduced from Sadarghat to Jagannath University during the occasion.

Any launch carrying passengers on rooftop will face stern action, warned the BIWTA chief. Deputy commissioners of districts sharing the inland waterways will adopt measures to operate mobile courts during the Eid holidays, added the BIWTA chairman.

"We will try to charge lower fares as much as possible," said Bangladesh Inland Waterways (passenger carriers') Association Chairman Mahbub Uddin Ahmed Bir Bikram. "We will take the final decision regarding fares

on next Thursday or Friday," he added. Monwar Hossain, BIWTA secretary, Jahid Hossain, chief inspector of the department of shipping, Abu Hena Khandaker Wahidul Karim, additional SP of police headquarters, Ashrafuddin, coast guard representative, among others, were present at the meeting.
