# Asian women rights groups support war crimes trial

BSS, Dhaka

Representatives of several Asian rights and women groups yesterday expressed solidarity with Bangladesh initiatives to try 1971 perpetrators of crimes against humanity particularly against women.

They expressed the solidarity on the concluding day of a three-day international workshop in the city.

"Rape and other forms of sexual violence against women in 1971 did constitute war crimes, crimes against humanity and/ or a constitutive act with respect to genocide'," said a special resolution of the workshop.

The resolution was read out at a press conference at the National Press Club.

It added: "We demand that the perpetrators of rape and forms of sexual violence against Bangladeshi women during 1971 be prosecuted

as war crimes, crimes against humanity and genocide at the appropriate forum."

Sri Lanka, Pakistan, Thailand and Indonesia joined the three-day meet at the BRAC Inn to review implications of "rising fundamentalism" on working women.

Prime Minister Sheikh Hasina yesterday called upon the minority communities to work with sincerity, honesty and devotion for ensuring welfare of the people of all faiths living in the country.

She made the call when members of the reconstituted Buddha and Hindu religion Welfare Trusts met her at her office.

Hasina said the aim of her government is to establish a secular society where people of all caste and creed will freely perform their religious activities.

PM's Press Secretary Abul Kalam Azad briefed reporters after the meeting. He said both the delegations apprised the PM of their needs. The prime minister assured them of providing necessary support.

Referring to the trust funds given by the government, Hasina advised the trust management to raise the funds on their own initiatives so that they can utilise the money for their benefits.

About the Vested Property Act, she said the issue is now under the consideration of the parliamentary standing committee. The government needs a unanimous recommendation from the Hindu community to take an

early decision. The prime minister said her party believes that the country is owned by the people of all faiths that has taken steps to ensure equal rights to all communities in all affairs.

Recalling the brutal attacks, suppression and repression of the past BNP-Jamaat government on the minority communities, Hasina said the present government is relentlessly working to prevent recurrence of such incidents.

Other speakers at the meeting also stressed the need for forming a forum of parents of children with autism.

This would promote greater interactions among the parents to form a unity, said Nasima Begum, joint secretary of the social welfare ministry.

"The mothers must realise that there is no need to be depressed, and their children have civil rights like everyone else," mentioned Nasima adding that mothers of the children need training and education on the issue of autism and intellec-

Parents should take their children to "Even if someone studies a lot, she doctors when symptoms of autisms appear, said Dr Mahmud Ahmed Chowdhury from Shishu Bikash Kendra of Chittagong.

> The medical service providers need training on autism so that they can identify the problem of the children and give initial guidance to their guardians, he added.

The experts also stressed the need for giving counselling to mothers of autistic children, as they have to face immense mental tortures in their families and the society.

### HC scraps sentence of Shahjahan Siraj

The High Court yesterday overturned a lower court judgement convicting former minister Shahjahan Siraj and sentencing him to 13-year imprisonment in a corruption case.

An HC bench of Justice Syed Muhammad Dastagir Husain and Justice AKM Zahirul Hoque delivered the verdict after granting an appeal filed by Shahjahan in 2009.

Shahjahan's lawyer Ahsanul Karim said the HC has overturned the trial court's verdict, since the allegations against his client was not proved.

## Bill on alternative justice system soon: Shafique part of the number of judges in the country.

The government is going to introduce alternative dispute resolution system as a mandatory trial mode in civil and criminal courts to remove the deadlock of cases for easing sufferings of justice seekers, Law Minister Shafique Ahmed said yesterday.

"We're at the final stage and hope to place it before the parliament as a bill for passage," he said at a seminar at the city's LGED Bhaban.

Ain O Salish Kendra (ASK) and Bangladesh National Women Lawyers' Association (BNWLA) jointly organised the seminar titled 'Restorative Justice System'.

Speaking as the chief guest, the law minister said lakhs of cases have been pending with the courts and it is impossible to run all the cases on the
