Smugglers pouring in garments, 13 outlaws freed on cosmetics ahead of festivals

'Luggage parties' active on buses and trains

Huge amounts of goods are being smuggled in daily through direct passenger buses and trains running on Dhaka-Kolkata-Dhaka route as a section of passport passengers known as 'luggage party' are pouring in different types of garments and cosmetics from India ahead of the Eid and Puja festivals.

Smugglers' syndicates of the two countries are using the buses and trains as a 'safer medium' for bringing Indian goods to supply it to the local market.

Valuables including gold and US dollars are also allegedly smuggled using these transports.

On August 4, Bangladesh Rifles (BDR) seized Indian sari worth Tk 36 lakh from a bus of transport company 'Souhardo Paribahan' running on Dhaka-Kolkata route.

On August 8, law enforcers seized 59 bags containing Indian saris and three pieces of lehenga, worth about Tk one crore, from another bus of the same company.

Every day four 'direct' buses run on Dhaka-Kolkata route through Benapole border.

At Dhaka Cantonment station on August 12, Rapid Action Battalion (Rab) raided Moitree Express train coming from India through Darshana border and recovered high quality Indian saris, 'three pieces' and other garments worth about Tk 3 crore. They also arrested 15 people in this connection.

As goods worth crores of taka enter Bangladesh through illegal ways, the

There are allegations that a section of bus drivers and supervisors in collaboration Paribahan. with customs officials at smuggle these goods.

"As 'luggage party' smugglers buy a good number of bus tickets in advance, common passengers often find it difficult to get tickets as per need. Although Customs and fied as Jafar, 25, son of one Tanvir said.

In Chittagong, police Benapole and Petrapole seized Indian garments worth Tk 10 lakh and arrested one person yesterday from the city's Mansurabad area under Double-Mooring police station.

Acting on a tip off, police led by Assistant Commissioner of Police Tanvir Arafat of the Double-Mooring Zone detained a truck in Mansurabad area at around 7.30am.

"We seized 647 pieces of Indian salwar kamiz and 552 pieces of Indian saris worth Tk 10 lakh from the truck,"

The garments were being taken to Chawkbazar, Tanvir

Meanwhile, members of Bangladesh Rifles (BDR) on Sunday noon recovered smuggled Indian cloths worth Tk 20 lakh from Kali Bazar area in Dharmoghor of Habiganj district.

Acting on a tip-off, a team of BDR raided the area and recovered 360 pieces Indian saris and 30 three-piece sets which were hidden under a pile of straw.

bail in Khulna in last 7 months

Thirteen underground operatives, detained on specific murder charges, were released on bail from Khulna district jail from December 27 in 2009 to August 9 this year.

Seven out of the 13 outlaws could be identified while names of the remaining six were not disclosed by Khulna district authorities.

According to Jail Superintendent Shah Alam Khan, Azad Hossain, an armed cadre of Janajuddho faction of outlawed PBCP was released on December 27 last year. He hails from Moishaguni village under Rupsha upazila.

On March 3 this year, Mashikul Islam of the same party was released from jail. The outlaw hails from Ikhri village under Terokheda upazila.

Most wanted outlaw Giasuddin of New Biplobi Communist Party (NBCP) of Dakkhindihi village under Phultala upazila was released on April 13.

On last June 28, Rafique Joarder of the banned outfit came out of Jail. He is from Dumuria upazila. On the same day, outlaw Shahin Sheikh of PBCP Janajuddho faction and a chargesheeted accused in Journalist Harun-or-Rashid murder case was released

from Jail.

Mashiur Rahman Palash, an armed cadre of PBCP Janajuddho faction was released on August 9. He hails from Terokheda upazila. Sakhawat Hossain Saki, an armed cadre of outlawed NBCP, was released on the same day. He hails from Dumuria upazila.

All the outlaws were released on bail after serving five to eight years prison term. They are accused in sensational murder cases filed with different police stations of Khulna division, Jail sources said.

The law enforces are keeping a close watch not only on the movement of the released outlaws but also on all the listed others to arrest them against the backdrop of their alarming rise and involvement in secret murders and extortions at different places of Khulna Division and Khulna city, said KMP Commissioner Helaluddin Badri.

According to sources in different intelligence agencies, there are over 8,000 armed cadres of nine different underground organisations in Khulna city and 10 districts in Khulna division. Most of these outlawed parties are also maintaining women squad, which is a matter of grave concern for the law enforcing agencies, the sources said.

Nasirullah's death shatters dreams of his family

Air became heavy as the death news of Rajshahi University student Nasirullah Al Nasim reached his Chalknarendra village home in Shibganj upazila of Chapainawabganj.

Nasim's mother Jannatun Nesa fell unconscious while his three sisters Monira Begum, Sumaiya Khatun and Afroza Khatun were too grief-stricken to speak. Nasim, a fourth year student of

history department of RU and an activist of Bangladesh Chhatra League (BCL), was critically injured as supporters of a faction of BCL beat him up following a row over distribution of iftar token on the occasion of National Mourning Day at Shah Makhdoom Hall in RU on August 15.

leaving him unconscious.

Residents of the hall rushed Nasim to Rajshahi Medical College Hospital. Later, the attackers pushed him As his condition deteriorated, doctors down from the first floor of the hall, sent him to Dhaka Medical College

Hospital (DMCH). After fighting for life for eight days, he died at DMCH on Monday afternoon.

"Nasim's father Moslem, who serves as a teacher of a school at Chandpur village in Shibganj upazila, often told us that he would like to see his son as a university teacher. But the tragic death shattered all his dreams," said his neighbour Zaman.

Sirajul Islam, who taught Nasim at school, said, "He was a brilliant student. He got scholarship in classes five and eight. He was the only brother of three sisters who also dreamt that their brother would be an ideal man as a university teacher."

Our Rajshahi Correspondent adds: Nasim's body was taken to RU campus where his namaj-e-janaja was held yesterday. He was buried at the graveyard of his village in the evening.

Two held for mugging, truck looted in N'ganj

Police in separate drives arrested two people on Monday night on charge of looting Tk 14 lakh from a businessman at Nitaiganj in the town.

The arrestees were identified as Mukul, 35, and Kamal, 32.

Mukul, ringleader of a mugging gang, was held at Chittagong Road in Siddhirganj here while Kamal picked up from Panthapath in Dhaka.

Police also recovered Tk 10,000 from the possessions of Mukul.

Businessman Golam Farid Mithun was robbed of Tk 14 lakh and some documents by an armed gang in Nitaiganj on the night of August 8.

Meanwhile, a T-shirt laden truck was looted by criminals at Panchabati BSCIC industrial area in Fatulla thana early yesterday.

Waiz Uddin, owner of the goods, said he along with three other partners bought 11,050 pieces of wastage T-shirts worth Tk three lakh from Goria Fashion at No. 1 lane of BSCIC.

A gang of armed muggers blocked a truck carrying the goods, beat up five people on board and took away the truck at gunpoint at about 4am, he said.

A Sylhet court yesterday sentenced an activist of Bangladesh Chhatra League (BCL) to 12 years rigorous imprisonment in a mugging case.

Judge Hossain Helal of anti-crime tribunal fined the convict, Shamim Iqbal, Tk 20,000, in default he is to suffer another year in jail.
