New York's main contract, light sweet crude for October delivery, gained 24 cents to 71.87 dollars. The contract closed Tuesday at 71.63 dollars, its lowest since June 7.

Brent North Sea crude for October was 38 cents higher at 72.76 dollars a barrel. It closed Tuesday 1.24 dollars lower at 72.38 dollars.
