## Harijans go on rampage at Dinajpur CS office

Harijan people yesterday went on the rampage at Dinajpur Civil Surgeon's (CS) office protesting recruitment of sweepers for the office from non-Harijan community.

They damaged furniture, doors and windowpanes and poured litters on the floors of different rooms of the office. The protesters also assaulted Deputy Civil Surgeon Dr Md Abu Bakkar Siddique.

Sources said the CS office invited application for 19 posts of sweeper in June this year. After official procedures, the authorities concerned prepared a list of candidates selected for the posts from non-Harijan community, sources added.

As the CS office put up the list on its notice board at around 12:30pm yesterday, the Harijan people became agitated and started ransacking of the office

Being informed, police rushed to the spot and took the situation under control. During the incident, Civil Surgeon Md Abdul Karim was not present at his office. The protesters alleged that the authorities

concerned had taken Tk 70,000 to 1,10,000 from each of the candidates of Harijan community, promising jobs at the CS office. But they selected non-Harijan people for the posts of sweeper, taking Tk 2 lakh to 2.5 lakh from each of them. Later, the protesters brought out a procession

in Dinajpur town demanding removal of Civil Surgeon Md Abdul Karim. They accused him of taking bribes from Harijan candidates and demanded return of the money.

After parading different streets in the town, the Harijan people went to the deputy commissioner's office and besieged it for an hour.

Contacted, lawmaker Iqbalur Rahim of Dinajpur-3 constituency said he will urge the authorities concerned to initiate an investigation into alleged corruption at the civil surgeon's

Denying the allegations, Civil Surgeon Md Abdul Karim said sweepers' were recruited though proper procedures. He however claimed that five sweepers were recruited from Harijan Community.

## No headway in CVASU deadlock

All exams suspended indefinitely

apparently in reaction to 'provocative comments' made by officials.

Chittagong Veterinary and Animal Sciences University (CVASU) authorities yesterday suspended all its examinations for indefinite period in the wake of indefinite siege enforced by Bangladesh Chhatra League (BCL) on Sunday.

The BCL started the siege in protest of CVASU decision to expel and punish their nine party men.

Academic activities at the university were disrupted for the second day yesterday due to the siege.

The CVASU authorities issued the notice of suspending examinations yesterday

morning. CVASU Controller of Examination and President of CVASU Teachers Association Dr Goutam Buddha Das said they had no alternative to suspending the examination in the wake of anarchy created

by BCL men on the campus.

He alleged that BCL activists are threatening the teachers and staffs bringing the academic activities virtually to a standstill but police are yet to take any steps against them.

Officer-in-charge (OC) of Khulshi police station Iftekhar Hossain said they were trying to keep the situation under

control. Expelled BCL convener Komol Kanti Mazumder said they would continue their agitation programme until

their demands are met.

The university authorities on Saturday expelled five BCL activists for lifetime and punished four other students on charge of assaulting some teachers and staffs of the university.

BCL activists enforced an

indefinite siege on the campus on Sunday by locking the administrative and academic buildings protesting the punishment and demanding resignation of Vice Chancellor (VC) Nitish Chadra Devnath.

### BARNALI RAPE, MURDER IN BAGERHAT

# Two to die, 4 get life

Khulna Divisional Speedy Trial Tribunal yesterday sentenced two people to death and four others to life imprisonment for killing a college girl after rape in Rampal upazila of Bagerhat district in 2007.

Those awarded death penalty are Kamal Hossain and Moktar Hossain Mukta. The lifers are Hasan Sheikh, Mahbub Hossain, Nazmul Hossain and Nahid Sheikh. They all hail from Chitra village under Rampal upazila.

The tribunal also fined the lifers Tk 10,000 each, in default they are to suffer another year in jail. Judge Md Sikander Ali delivered the verdict in the case at 5:30 pm. He acquitted six other accused, as charges brought against them could not be proved.

According to the prosecution, Barnali Ghosh, an honours student of Khulna Government Azam Khan Commerce College, was abducted from her house at Chitra village under Rampal upazila on the night of June 30, 2007.

The abductors took the college girl to a shop at the village, stuffed a piece of cloth into her mouth and raped her. Later, the gang took the unconscious girl to an orchard owned by Jalil Munshi of the village at the instruction of Chitra Union Parishad Chairman Jamil Hossain

Jamu and killed her by pouring acid on her body.

Barnali's father Bipul Ghosh filed a general diary with Rampal Police Station on July 3 the same year stating that his daughter went missing.

On July 11, police recovered Barnali's body from the orchard. On the following day, Bipul Ghosh filed a case with the police station, accusing Moktar Hossain and Kamal Hossain of killing his daughter. Immediately after filing of the case,

police arrested Moktar. He made confessional statement before to court under Section 164 and disclosed the names of other gang members.

Two separate cases were later recorded with Rampal Police Station in connection with gang-rape and murder of the college girl naming 13 people as accused.

The accused in the cases were Raju, Munmun, UP Chairman Jamir Hossain Jamu, Moktar Hossain Mukta, Kamal, Wazed, Nahid, Mahbub, Liton, Hasan, Akbar Hossain, Monoj and Nazmul.

The cases were transferred to Khulna Divisional Speedy Trial Tribunal in November last year from Bagerhat court. Inspector Tofazzal Hossain of the Detective Branch of Bagerhat district police submitted a charge sheet to the court on February 18, 2008.

Statements of 22 out of 36 prosecution witnesses of the case filed for acid attack and statements of 19 of the 36 prosecution witnesses of the case filed under Women Repression Act were recorded by the court during trial.

The court could not try UP Chairman Jamir Hossain Jamu, one of the 13 charge-sheeted accused, as the High Court stayed trial proceedings against him.

#### Two more **RU Shibir** cadres arrested

Motihar police arrested two more Islami Chhatra Shibir cadres from Rajshahi University (RU) yesterday in connection with the campus violence on February 9.

Arrestees Ariful Islam and Abdul Kader are fourth year students of Marketing department of the univetrsity.

Sources said, Bangladesh Chhatra League (BCL) activists of the university unit caught Arif from in front of Rabindra Arts Building as he came to seat for his fourth year final examination at around 10.00am and handed him over to Motihar police.

Later, hearing the news that more Shibir activists appearing in the examination of Marketing department at the same building, the BCL activists blocked the gates of building at around 1.00pm.

On information, law enforcers rushed to the spot and took position at the gates to arrest the Shibir cadres. At around 1:30pm, the BCL

leaders and activists entered the building and caught Shibir cadre Kader from the examination hall.

Police arrested the Shibir men from the main gate after the BCL activists dragged the Shibir cadres out of the building. BCL leaders alleged that both the Shibir cadres took part in February 9 campus violence. RU proctor Prof Chowdhury

Zakaria said the Shibir men were arrested for their alleged involvement with February 9 campus violence that killed BCL worker Faruk Hossain and injured a number of others. Abul Khair, officer-in-

charge (OC) of Motihar police station told this correspondent that the eight are accused in the cases filed in connection with the violence. "We will take necessary

steps after primary interrogation", he said. According to the police, over 230 Shibir leaders and activists have been arrested till date in

## Six commit 'suicide' in 2 days in Thakurgaon

Six people allegedly committed suicide yesterday and the day before in the district.

Sadar upazila, two in Haripur upazila and the sixth in Pirgonj upazila.

Police said, Amullaya Barman alias Taklu, 26, son of Azindar Barman of Dakkhin Thakurgaon village and Putul Rani, 18, daughter of Joynath Barman of Bathina village under Sadar upazila committed suicide by taking poison together on Sunday evening at Bathina village.

Putul and Amullya used to meet at a bamboo cluster at Farabari village under Sadar upazila on Sunday afternoon. Somehow Putul's father

Joynath Barman got the information. He went to the spot and brought the couple to his house and confined them at a

room. As Putul's father was

arranging arbitration with the local elites, the couple took insecticide in the evening.

Hearing their groaning, Of the victims, three died in Putul's family members rushed to the room and took them to Thakurgaon Sadar Hospital.

Putul died on the way to hospital while Amullya died at the hospital, police and villagers said.

Khokin Chandra Barman, 48, son of Laxmon Chandra Barman of Gopalpur village under Sadar upazila allegedly committed suicide at about 4:30am on Sunday by hanging from a tree beside his house.

Aftabuddin, 70, son of late Hukum Ali of Jadu Rani village under Haripur upazila also killed himself on Sunday at about 5:00am by hanging in a similar way.

Somela Begum, 85, wife of police sources said.

late Rahmatullah of Dilgaon village under Haripur upazila allegedly committed suicide on Sunday evening by taking

Mita Boshai Barman, 60, wife of Heltong Roy of Bishmail village under Pirgonj upazila committed suicide on Sunday morning by hanging herself from the ceiling at an abandoned room of her house following a family feud, police

poison at her house.

On information, police recovered the bodies from different spots and sent them to Thakurgaon Sadar Hospital for autopsy. Unnatural death cases were also filed with

respective police stations. Reasons behind most of the suicides could not be known

immediately, police said. Earlier at least 10 other people committed suicide in different upazilas of the district in the current month,
