'US wasted billions in rebuilding Iraq'

A \$40 million prison sits in the desert north of Baghdad, empty. A \$165 million children's hospital goes unused in the south. A \$100 million waste water treatment system in Fallujah has cost three times more than projected, yet sewage still runs through the

As the US draws down in Iraq, it is leaving behind hundreds of abandoned or incomplete projects. More than \$5 billion in US taxpayer funds has been wasted on these projects more than 10 percent of the \$53.7 billion the US has spent on reconstruction in Iraq, according to audits from a US watchdog agency.

That amount is likely an underestimate, based on an analysis of more than 300 reports by auditors with the special inspector general for Iraq reconstruction. And it does not take into account security costs, which have run almost 17 percent for some projects.

There are success stories Hundreds of police stations, border forts and government buildings have been built, Iraqi security forces have improved after years of training, and a deepwater port at the southern oil hub of Umm Qasr has been restored. But even completed pro-

jects for the most part fell far short of original goals, according to an Associated Press review of hundreds of audits and investigations and visits to several sites. And the verdict is still out on whether the program reached its goal of generating Iraqi good will toward the United States instead of the insurgents.

Col Jon Christensen, who took over as head of the US Army Corps of Engineers in Iraq this summer, said it has completed more than 4,800 projects and is rushing to finish

233 more. Some 595 projects have been terminated, mostly

for security reasons. Christensen acknowledged that mistakes have been made. But he said steps have been taken to fix them, and the success of the program will depend ultimately on the Iraqis who have complained that they were not consulted on projects to start with.

"There's only so much we could do," Christensen said. "A lot of it comes down to them taking ownership of it."

The reconstruction program in Iraq has been troubled since its birth shortly after the US-led invasion in 2003. The US was forced to scale back many projects even as they spiked in cost, sometimes to more than double or triple initial projections.

As part of the so-called surge strategy, the military in 2007 shifted its focus to protecting Iraqis and winning their trust. American soldiers found themselves hiring contractors to paint schools, refurbish pools and oversee neighbourhood water distribution centres. The \$3.6 billion Commander's Emergency Response Program provided military units with ready cash for projects, and paid for Sunni fighters who agreed to turn against al-Qaeda in Iraq for a monthly salary.

But sometimes civilian and military reconstruction efforts were poorly coordinated and overlapped.

A spike in US troop numbers in Afghanistan to over 120,000 has brought increased contact with insurgents and a rising death toll. Forty-nine US service members have died in Afghanistan this month, still fewer than the 66 killed in July.

To the east in Nangarhar militants maintain safe havens province, the head of Lal Pur district, Syad Mohammad Palawan, was killed when a bomb planted on his vehicle exploded as he was driving into a government compound to attend a meeting of provincial security and political leaders, said police spokesman Ghafor

Insurgents apparently planned for the bomb to explode inside the compound in the provincial capital Jalalabad where it could potentially have caused far greater destruction, Khan said.

Three of Palawan's bodyguards were wounded, Khan said, while the Interior Ministry put the figure at five.

In a bid to keep operational costs low, the company discharged chemical wastes to a nearby canal through which the pollutants end up in Karnaphuli, he added.

The team conducted tests on samples of the discharged liquid wastes and found toxic substances far beyond the acceptable level set by the government.

"The factory has been releasing around one lakh cubic metres of untreated liquid wastes over the last 12 years, said Munir, adding that the textile mills authorities have promised to set up an ETP by this December.

The same DOE team also fined Reaf Leather Ltd a sum of Tk 8.60 lakh for not using its ETP effectively.

They found the tannery discharging untreated liquid wastes into the canal through a drain.

Under the MoU, an eightmember board of directors will manage the joint venture with Bangladesh as its chairman and an NTPC representative as the managing director for the first eight years before switching over to three-year rotational system.

The two countries will by rotation hold the posts of chairman and managing director for a period of three years, said the MoU. Bangladesh and India will

According to a parliamentary sub-committee report, over 15 lakh cases were pending in subordinate courts till January.
