## Sand traders offer free dredging

The Bangladesh Inland Water Transport Authority is going to launch a Tk 6.6 crore project to dredge parts of the Buriganga river although some traders are offering to do it free of cost and would rather pay for the extracted sand.

The BIWTA officials have completely ignored the sand traders' offer, selected a private contractor for the job and forwarded the project file to the Board of Members for final approval. The BIWTA board may approve the project any day.

Preparedness of BIWTA for the project to be launched this month is so vague and mysterious that when asked, Chief Engineer (Dredging) Abdul Matin said they would return the money to the exchequer if they are able to sell the sand.

The Daily Star has obtained copies of the "detailed" project proposal and nowhere in it did the BIWTA officials mention about sale of this valuable commodity or "return of project money".

## Biman bows to staff demand

Decides to reinstate pension scheme, hike salaries as per govt pay scale after days of agitation at its HQs

The Biman board of directors yesterday finally conceded to its employees' demand for revising a new pay scale, reinstating their pension scheme and giving pay raises in line with the government salary structure.

"Everything has been resolved. The board has approved all demands," said Biman Managing Director and Chief Executive Officer Muhammad Zakiul

Islam, after more than a two-hour long negotiation with the national airline's staff representatives.

Yesterday's negotiation followed Tuesday's demonstrations by Biman employees on the premises of its headquarters Balaka, after unofficial circulation of the new pay scale scrapping the pensions of around 3,000 permanent staff, and giving pay raises lower than what government employees had got.

The state-owned airliner was turned

into a public limited company in July 2007, from a state-run corporation. A new pay scale was a demand of its staff since declaration of the new government salary structure in November 2009.

"We are happy that our righteous demands have been met," said Md Mosikur Rahman, convener of Sammilito Sangram Parishad of Biman, yesterday, coming out of the negotiation meeting sporting V signs along with other

## AL vows to thwart BNP's MP's driver 'admits' killing Ibrahim Victim's wife says confession made under

pressure; lawmaker tells of different story

Kamal Hossain Kala, driver of Awami League lawmaker Nurunnabi Chowdhury Shaon, yesterday confessed to shooting AL activist Ibrahim Ahmed during a tussle.

Ibrahim's wife Rina Islam alleged that the investigators forced Kala to confess to killing his husband to let Shaon off the hook.

She said the investigators echoed Shaon, who on Wednesday claimed that Ibrahim was killed by a bullet fired during a tussle with Kala. Kala made the confessional statement before a metropolitan magistrate, who sent

him to jail. In line with a court directive, inspector of Detective Branch of police Shah Moshiur Rahman yesterday filed a murder case with

Sher-e-Bangla Nagar Police Station in connection with the incident. Azim Uddin, sub-inspector of the police

station, said Moshiur did not accuse anyone in the case.

Moshiur mentioned that they became sure

that Ibrahim was murdered through the statements of driver Kala and Sohel, personal secretary of Shaon.

Kala in his statement said he pulled the trigger during a tussle with Ibrahim leaving the AL activist dead.

However, Kala earlier said Ibrahim, an acquaintance of Shaon, turned up on the scene when he was cleaning a car. He picked up the pistol from the car to check it out. A bullet hit him in the face when he pressed the trigger accidentally.

Additional Deputy Commissioner Mohammad Moniruzzaman said Kala, during an interrogation, admitted that he pulled the trigger of Shaon's pistol during a tussle with

Shaon, lawmaker from Bhola-3 constituency, on Wednesday gave another version of the incident in a teleconference with journalists in Bhola.

He claimed that Kala and Ibrahim were checking out the pistol. At one stage Kala tried **SEE PAGE 15 COL 3**
