## BCL cadre that drove nails through RU student's leg held

Police on Wednesday night arrested a Chhatra League activist of Rajshahi University unit in connection with campus violence.

Arrestee Feroz M Arifur Rahman, 25, along with some other BCL cadres severely beat up and stabbed a RU student in public branding him as a Shibir man on August 31, police said.

The BCL cadres allegedly drove nails through a leg of Mashiur Rahman, a postgraduate student of Philosophy department, near the university's transport market at about 8:30pm.

The cadres also assaulted shopkeepers of the market who tried to help Mashiur hearing his scream.

Later, friends rescued an unconscious Mashiur from the spot and rushed him to hospital.

A patrol team of Motihar police however detained Feroz, also a close associate of



#### 21 more in Kushtia feared infected

At least 21 more people are feared to be infected with anthrax at Bilgathua village in Daulatpur upazila of apology in writing for their Kushtia yesterday.

On Wednesday, 16 other people of Dharmadaha, an adjacent village, were reported to have contracted anthrax. With this the total number of infected in the

upazila rose to 37. The patients are taking treatment at the upazila health complex and home.

Doctors at the health complex said they are still waiting for experts' opinion on the blood and skin specimens sent earlier to Dhaka.

Saleh Ahmed, Daulatpur upazila health official, said this time the disease might have caused from consuming meat of sick goats.

According to villagers a few goats at Dharmadaha and adjacent villages including Bilgathua and Krishnapur caught an unknown disease 10-15 days ago. People have slaughtered those and consumed the

"We knew that cattle are the only cause of such infection. But now it appears that goats can also carry the disease," Liton, an infected patient of Dharmadaha village, told The Daily Star.

Jatindra Chandra Roy, civil surgeon of Kushtia, said medical teams are working in the area. He also urged people not to panic.

# 4 DB men, 2 others sued

Wife of Nurul Islam, who was killed allegedly in firing by the Detective Branch (DB) of police at remote Alinagar village in Madhabpur upazila of Habiganj district on Sunday night, yesterday filed a case against four DB men and two alleged drug peddlers in connection with the killing.

Following the case filed by Jarina Khatun, wife of the deceased, with the Judicial Magistrate's Court in Habiganj, Magistrate Rajib Biswas ordered the officer in charge of Madhabpur Police station to take legal action.

The accused are Sub-Inspector Syed Belayet Hossain, constables Zahid Hossain, Mahfuzur Rahman and Anisur Rahman, and alleged dug peddlers Ataur Rahman and Shahin Miah.

Madhabpur upazila Chairman Zakir Hossain Chowdhury Asim, Dharmaghar union parishad (UP) Chairman Shamsul Islam and 19 others have been made witnesses in the case.

The complainant in her case stated that the locals recently asked drug peddlers Ataur Rahman and Shahin not to

Consequently, Ataur managed the DB team and took them to Zebu's house at about 11:30pm on August 29, she said. "As the team attempted to pick up

Zebu, his father Nurul Islam, 60, asked them not to arrest his son without warrant. He also said Zebu would be handed over to them, in presence of the upazila chairman and the UP chairman, if he was guilty. But the BD men ignored the request and suddenly opened fire, caus-ing injuries to Nurul Islam. He was rushed to Madhabpur upazila health complex where doctors declared him dead.

"I tried to file a case with Madhabur police station, but the police did not accept it. They threatened my son and other relatives not to proceed for legal action. They also pressed the UP chairman to divert the murder case. Still the accused are active to suppress the murder," said the complainant.

Hours after the killing, DB Sub-Inspector Belayet filed a case accusing

Nurul Islam, Zebu Miah, their neighbour and relative retired army man Enamul Haque, and 20-25 others on charge of assault on police.

UP Chairman Shamsul Islam, who filed an unnatural death (UD) case with the PS the same day, later said the police pressed him to put signature on a plain sheet, which was used for starting the UD

"They picked me up from my home and asked me to sign. I was just blackmailed. I informed the upazila chairman and the SP of the matter," he said.

Madhabpur OC Sheikh Kabirul Islam denied the allegation.

Meanwhile, a three-men committee headed by Zillur Rahman, the additional SP of Habiganj, filed their report to the SP on Tuesday, stating that the claim of DB men was correct and police was compelled to open fire as the arrestee's men attacked them.

An uneasy calm is prevailing at Alinagar village as most of the male people have gone into hiding to evade mass arrest in the police assault case, locals said.

## Green fodder crisis hits flood-hit farmers

Acute crisis of green fodder in Teesta and Dharla river basin areas in Lalmonirhat district adds to the worry of floodaffected farmers, especially those who mainly depend on rearing domestic animals for livelihood.

Many of the cattle owners, who have been facing serious problem due to high prices of hay, oilcake and wheat bran from the beginning of rainy season this year, are now thinking of selling their domestic animals for whatever price they get in the local market.

According to district livestock office sources, flood damaged eight dairy farms in Teesta river basin areas of Hatibandha and Aditmari upazilas in Lalmonirhat district, causing a loss of worry of cattle farmers. about Tk one crore.

"Now I get only three litres of milk daily from three cows that gave nine to eleven litres

of milk two weeks ago. As the recent flood has washed away my haystack, milk production has decreased due to lack of fodder," said Habibur Rahman, 45, a dairy farm owner of South Goddimari village in Hatibandha upazila. "I had four cows but I sold

three of them for a nominal price on Tuesday as fodder is not available in the village," said Rohidul Islam, 40, of flood-hit Sindurna village of the same upazila. Even after the recent reces-

farmers are staying on roads, embankments and highlands along with their cows as floodwater had destroyed their houses and cowsheds.

Only two weeks ago, one maund (around 40 kg) of hay sold for Tk 150 to 160 but now it is selling for Tk 280 to Tk 300 in local markets, much to the

Gobordhon Char village under Aditmari upazila, said Lalmonirhat District they fear much difficulty to Livestock Officer Dr Siraj.

"I am badly in need of grass seedlings as I lost grass on five bighas (one bigha is equal to 0.33 acre) of land due to the recent flood," Shamsul Alom, 48, a dairy farm owner at the same village, said.

"I have facing untold problem with my ten cows, as all the grasslands around my homestead has been damaged in the flood. I sion of floodwater, many have not money enough to buy hay for my cows," said Parimol Chandra Sen, 65, of flood-hit Bongram village in Lalmonirhat Sadar upazila.

"Fodder crisis has become acute as floodwater destroyed green fodder in about 30 villages in Teesta and Dharla river basin areas in four upazilas of Hanif Sarker, 62, of Lalmonirhat. It will take time for new grass to grow," said

Khulna district Jail authorities have sent a list of nine war criminals, who were convicted under Collaborators Act and sentenced to the jail, to InternalWar Crime Tribunal.

The convicted war criminals are Mohammod Reza, AY Ahmad Ali, Abdur Razzak, Tota Sheikh, Makbul Sheikh, Sohrab Molla, Hamid Sheikh, Mokarram Gazi and Ansar Ali Morol.

Some of them were transferred to Jessore, Rajshahi and Satkhira jails and later released under general amnesty and also on appeal to

Jail Superintendent Shah Alam Khan said they were punished by special tribunal in Khulna under Collaborators Act and section 364 of Bangladesh Penal Code.

He said the jail authorities have made the list as per directive of the home ministry and sent it to International War Crime Tribunal.

### 14 sued on charge of killing, looting, arson in 1971

Fourteen alleged collaborators of Pakistani occupation forces have been sued for killing, looting and setting fire to a house in Mongla upazila of Bagerhat district in

Nazrul Islam of Dhalirkhanda village under the upazila filed a petition case with Senior Iudicial Magistrate's Court in Bagerhat on Tuesday.

In the petition, five out of the 14 accused have been shown as dead. The court ordered the


officer-in-charge (OC) of Mongla Police Station to record the case after proper investigation.

The accused are Altaf Shikdar, 64, Mostafa Goldar, 64, Abdul Nurul Huq Khokon, 68, Abu Bakar Siddique (dead), Abdul Jalil Sheikh (dead), Dr Sheikh Oli Ullah (dead), Moslem Fakir, 70, Rajab Ali Sarder, 69, Rahim Sheikh, 67, Imam Ali Ijaradar (dead), Ali Ashraf Ijaradar (dead) and Jinat Sheikh, 69.

The complainant alleged that the accused picked up 15 Hindus from their houses at Damerkhanda village at gunpoint at around 11:00am on October 12, 1971, took them to a paddy field and killed them.
