'Robber' killed in mob beating Two injured, nine others caught while fleeing

A 'robber' was beaten to death, two were injured and nine arrested in two separate incidents in Narsingdi and Chapainawabganj early yesterday.

Mob beat dead an alleged robber and injured two others at Sorrabad village under Belabo upazila of Narsingdi early yesterday, reports a correspondent.

The dead was identified as Kajol, 32, and the injured are Ripon, 25, and Nurul Islam, 28.

Police said a gang of eight to ten

swooped on the house of Jinnat Ali Bepari

of Sorrabad village at around 2:00am. Sensing the presence of the robbers, Jinnat Ali informed his neighbours about the attack of the robbers over mobile phone.

On receiving the calls, the neighbours encircled the house, caught three of the

gang and beat them up mercilessly.

Kajol, one of the gang members succumbed to his injuries on way to Dhaka Medical College and Hospital, while the two others were handed over to Belabo police.

The other members of the gang, however, managed to flee the scene, sources said.

In Chapainawabganj, police arrested nine alleged robbers at Biana village under Gomostapur upazila early yesterday, reports our correspondent.

The arrestees are Aktar Ali Nantu, 45, of Mirzapur, Rezaul Karim Rozbul, 28, of Raninagar, Sadequl Islam, 30, Abdul Latif Bhutto, 45, Shariful Islam, 22, Rabiul Islam Robu, 40, Tariqul Islam, 35, of Darigachha, Ismail Hossain, 39, of Kamalpur -- all under Shibganj upazila and Taher Ali, 35, of Patharpuja village under Gomostapur upazila in the district.

Sub Inspector (SI) Abdul Mannan of Gomostapur police station said, among the arrestees Rezaul Karim Rozbul and Taher Ali are on the wanted list of Gomostapur police station.

He said a group of 20 to 22 of inter-district robbers attacked the house of one Khurshid 'pir' at about 2:00am and looted about Tk 4000, 5 tolas of gold ornaments, 5 mobile phones and clothes.

Vegetable trader killed

A vegetable trader was murdered by unidentified criminals at Mahasthan in Shibganj upazila on Sunday. The deceased was identified as Masum, 25, son of Jahidul Islam of village Purbo Mahasthan in the same upazila. Police said vegetable trader Masum of Mahasthan bazaar came to his village home closing his shop Saturday evening for taking Iftar. Later, he went out of his house after receiving a phone call and since then he remained missing. Locals found the slaughtered body of Masum in a field in between Mahasthan and Bhabaniganj villages at about 11am on Sunday. On information, police recovered the body and sent it to hospital morgue for autopsy. The reason behind the murder could not be known.

Cocktails seized, one held

Man held with arms

Police arrested a young man along with arms from a night coach at Daulatdia ghat here early Saturday. The arrestee was identified as Moktar Hossain, 35, son of late Abbas Ali of village Ramgopalpur in Munshiganj Sadar upazila. Police said, acting on a tip-off, they conducted a drive at the Dhaka bound night coach from Jessore at about 2.00am and arrested Moktar Hossain along with a US-made pistol, one bullet and two magazines. Goalanda ghat police station OC AKM Alinur Hossain said Moktar Hossain might be an active member of banned outfit Jam'atul Mujahidin Bangladesh (JMB).

Fire at packaging unit

A fire that broke out at a packaging factory at Gazirhat here gutted valuables on Sunday morning. Police and fire brigade sources said the fire originating from the chemical godown of the Silva Packaging Factory at about 9am soon engulfed the adjacent rooms of the factory. Fire fighters from EPZ fire service station rushed to the spot and extinguished the fire with the help of local people. Firefighters estimated the extent of loss caused from the blaze at about Tk 50,000.

Chemicals, drugs seized

A mobile court on Sunday seized a huge quantity of poisonous chemicals, spurious drugs and pesticides from a local bus on Satkhira-Kaliganj road at Bakal checkpost in the district town. On a tip-off the mobile court led by Executive Magistrate ATM Azharul Islam raided the bus near the checkpost and seized various poisonous chemicals, drugs and pesticides worth Tk one lakh in abandoned condition. None was arrested in this connection. A case was filed.

People suffer as approach road awaits repair

Road communication between Shaghata and Gobindagnaj upazilas has remained snapped since August 28 as the damaged portion of an approach road to Dewantola Bridge over the Bangali River is yet to be repaired.

The authorities concerned could not start repairing work for lack of fund. They have urged the higher authorities to allocate fund for repair of the damaged portion of the road. A portion of the approach

road under Mohimaganj union of Gobindaganj upazila was washed away on the night of August 28, snapping road link between the two upazilas. Pedestrians and bi-cycle riders also face immense trouble everyday to cross the bridge.

put sand bags and woods on the eroded portion to protect the approach road from further onslaught of the river.

Following collapse of the approach road, a section of people cut down roadside trees and set up a makeshift bridge at the site. Pedestrians and bi-cycle riders have to pay tolls to cross the damaged portion through the bridge.

While visiting the spot yesterday, some labourers were seen filling bags with sand for dumping at the damaged site of the approach road.

As many areas of Gaibandha district were under floodwater at that time, It was very difficult to collect sand and soil for repairing the damaged portion of the approach road, said Sahidul Islam, member Local people and staff of of Mohimaganj Union Parishad.

8 transformer thieves get 14 yrs' RI each in Sylhet

Sylhet Divisional Special Tribunal Sunday afternoon sentenced eight people to 14 years' RI each for lifting electric transformers.

The convicts are Ripon Miah and Javed Miah of Munshipara and Gias Uddin, Liton Miah, Shukur Ali, Md. Khokan, Sohel Ahmed and Abdul Jalil of Bhatalia area of Sylhet city.


Convicts Jalil and Sohel are at large while others, who were on bail appeared before the court on Sunday.

According to the prosecution in brief, the people of village Bolaura of Sylhet Sadar upazila caught Ripon Miah red-handed while lifting transformer from an electric pole on 25 September of 2007.

However, the others of the organised gang managed to escape. On quizzing Ripon dis-

closed all about the gang and their activities. He was later handed over to the police on filing a case

the same night. Divisional Special Judge of Sylhet Hossain Helal passed the judgment. He also fined each of them Tk 25,000, in default, to suffer one year more in jail.
