CRIME DURING EID VACATION

4 including outlaw murdered in Pabna

At least four people including an outlawed party activist were killed at Chatmohar, Santhia, Atghoria and Santhia upazilas during the Eid vacation.

Meanwhile police arrested a 'regional leader' of outlawed PBCP Janajudhha faction night before the Eid-ul-Fitr.

The deceased were identified as Md. Rakibullah, 25, an outlawed activist of village Keshabpur Baulaghata in Chatmohar upazila, Md. Shafique Uddin, 24, a driver of three-wheeler Kariman of village Goyashpur in Atghoria upazila, Md. Shafikul Islam, 22, of village Paikarihat in Santhia upazila and Khairunnesa, 45, a housewife of village Sharabaria in Ishwardi upazila under the district.

Sub Inspector (SI) Md. Siraj Uddin of Chatmohar police station said a gunfight

between two rival factions of outlaws occurred at Sharatganje Bazar of Chatmohar upazila about 9:30pm on Friday.

Md. Rakibullah, an operative of an outlawed party was killed during the gunfight, the SI said.

Police arrested Md. Bakul Hossain, 25, a suspected criminal with a shutter gun from the spot.

Sub Inspector Abdur Rouf of Atghoria police station said police recovered the decomposed body of Shafique Uddin, a Kariman driver from Shonahata water body of the upazila at about 10 on the day of Eid-ul-Fitr.

He was missing from his residence for three days, police said. Criminals abducted and killed him and dumped the body in the water body, police believe.

Officer-in-charge of Santhia police station Md. Robiul Islam said that the criminals hacked shallow

machine operative Shafikul Islam on September 9 morning over the past enmity.

Critically hurt he was taken to Santhia upazila health complex where died in the afternoon.

Meanwhile police said a man beat his mother-in-law Kharinnesa dead at her residence at village Shorabaria in Ishwardi upazila on Thursday.

Hasnat Ali beat her mercifully allegedly for not getting expected Eid gift, police said.

In another incident, Ataikula police arrested Md. Abdul Hakim, 42, a 'regional leader' of outlawed PBCP Janajudhha faction from the village Goashbari on Friday night.

Officer-in-charge of Ataikula police station Md. Sirajul Islam said, acting on a tip-off, a team arrested him from his village.

Hakim, son of Nazir Uddin of Goashbari village is also accused in 12 murder cases, the OC said.

Jubo League leader, 2 others killed in Bogra

A Jubo League leader and two others were killed in separate incidents in Gabtoli, Kahalu and Sadar upazilas of the district in the last four days.

The deceased were identified as Tariquul Islam Tarique, Jubo League president of Gabtoli poura unit, sand trader Nanna, 27, and housewife Beauty Begum.

Witnesses said a gang of criminals attacked Tarique with sharp weapons near the local branch of Sonali Bank, leaving him critically injured on Thursday afternoon.

He succumbed to his injuries on way to the hospital. Police said the attack took place when Tareque was going to the bank. Three people waylaid the Jubo League leader and hit him with lethal weapons.

Meanwhile, a youth was shot and hacked to death by some unknown criminals at Ghonapara village under

Sadar upazila. The dead was identified as sand trader Nanna, 27, son of Chandu Mia of Chakstrapur Kosaipara in the town.

Police sources said at around 6:00pm a gang of criminals shot Nanna and hacked him to death following a feud over a trifling matter at Ghonapara village.

Police arrested two brothers Shahid and Zahid in this connection.

Family sources said, sand trader Nanna might have been killed by his rivals following a dispute over business.

In another incident, a housewife was strangled allegedly by her husband in a feud centering two decimal of land at Depuin village under Kahalu upazila of the district.

The dead was identified as Beauty Begum, wife of Moti. Moti went into hiding after the killing.

FLOOD HITS 7 GAIBANDHA UPAZILAS

Thousands marooned, road links snapped

Flash floods hit vast areas of seven upazilas inundating dwelling houses and submerging huge aman crop in the last 24 hours ending at 6pm yesterday.

According to local WDB, Jamuna was flowing 61 centimetre above danger mark, while Karotoa in Gobindaganj increased by 57 centimetre, Teesta in Sunderganj 40 centimetre and Ghagot in Gaibandha Sadar by 15 centimetre, but all flowing slightly below the danger mark.

The rivers may cross danger levels anytime flooding fresh areas in the district, said

an engineer of WDB.

More 20 villages in Sunderganj upazila were flooded yesterday due to onrush of water from the upstream. A few thousand acres of cropland have gone under knee-deep water. Most of the aman fields in low-lying areas have been totally submerged, locals said.

Road communications between Ghoraghat and Gobindaganj is threatened as floodwater might overflow the highway anytime.

Dwelling huts in shoal areas along Jamuna and Teesta basin under Sunderganj, Gaibandha Sadar, Fulchhari and Saghata upazilas went under floodwater rendering

around 20,000 people homeless or marooned.

Road links in river basin areas of four upazilas has snapped as all the village roads went under knee to waist deep water. Country boats and banana tree rafts are the mode of communication in those areas.

Cracks have developed at many points of flood control dyke in Saghata and Fulchhari areas.

Many of the flood victims have taken shelter on high roads and embankment in Fulchhari upazila. They are living in makeshift sheds or under open sky and suffering from scarcity of food and pure drinking water.

AL-BNP clash

UNB, Shariatpur

At least 17 people were injured in a bloody clash between the activists of Awami League and BNP at Chikondi in Sadar upazila at noon yesterday.

District BNP joint secretary Helal Uddin Akand and nine others were admitted to Sadar hospital with serious injuries.

Villagers said, the clash took place over establishing supremacy in the area.
